Attached you will find an application for the Summer Sprinkling Program. This program could reduce the costs paid for sewer charges during the summer months.

There is no guarantee that you will see a savings, as everyone's water consumption is different. With this program, if you use more water during the summer billing period (May 1st through September 30th) than you used during the previous seven months (the winter billing period – October 1st through April 30th), you should see a reduction in your sewer bill.

Please read the enclosed application. If interested, fill out completely and mail in along with a \$10.00 check or money order (make payable to City of Euclid). This is a ONE-TIME fee to cover the costs of administering the Program through the water department. Thereafter, the annual reduction will be available depending on water usage, as long as you own and occupy your home. All applications and fees will be sent to the Cleveland Water Department monthly.

RESIDENTIAL SUMMER SPRINKLING PROGRAM APPLICATION

Application Fee: \$10.00

The City of Euclid has authorized a program for eligible homeowners which may reduce the cost for sewer charges each year during the months of May through September. Eligible applicants must be Euclid residents who own and occupy a one-, two-, three-, or four-unit dwelling and use more water during the summer months (sprinkling or other seasonal uses) than in the winter months. With the Summer Sprinkling Program, your summer water bill will reflect sewer charges based on the amount of water you used during the winter. You may estimate your savings by comparing your summer water usage to the past winter water usage. This program applies to sewer charges only. Sewer fees are based on your total use of water. You must still pay the Cleveland Water Department for all the water used.

Once enrolled, you are in the program as long as you occupy and own the home. Renewal is unnecessary.
