



## CAMP TIMBER-LEE SCHOLARSHIP APPLICATION INSTRUCTIONS

We desire to make the Timber-lee camp experience available to as many youth as possible. As the result of the generous support of Timber-lee friends, we are able to provide funds to a limited number of families to help defray the cost of camp. Please follow the instructions below to complete the financial aid application and send to the address found below.

### If you are applying for a FOSTER CHILD, follow these instructions:

**Part 1: Use a separate application for each foster child.** List the child's name, birthdate, grade, camp number, and date of camp week requested.

**Part 2:** Check the box and list the child's personal use monthly income, if any.

**Part 3:** Skip this part.

**Part 4:** An adult household member must sign the form.

### ALL OTHER HOUSEHOLDS follow these instructions:

**Part 1:** List each child's name, birthdate, grade, and camp week requested for only those children you desire to attend camp.

**Part 2:** Skip this part.

**Part 3:** Follow these instructions to report current total household income.

**Column 1:** Please state current annual gross household income from wages.

**Column 2:** *All other income:* Please state the amount of annual household income from all other sources (welfare, child support, alimony, pensions, retirement, Social Security, Worker's Compensation, unemployment, strike benefits, Supplemental Security Income (SSI), Veteran's benefits (VA benefits), disability benefits), and ANY OTHER INCOME.

**Part 4:** An adult household member must sign the form.

- You will be notified by e-mail if you qualify for financial assistance, and, if so, the amount awarded.
- Applicants will be notified within ten days of receipt of the financial aid application.
- Applicants must be registered with the deposit for financial aid to be applied.
- NOTE: Qualifying for financial assistance does not guarantee availability in the camp applied for. Before financial assistance can be applied your camper must be registered online or by phone.

### PARAMETERS:

- Scholarships apply to classic camps and camp start only. They may not be applied toward specialty camp sessions.
- Scholarships cannot be combined with any other discounts except the early bird discount, if registered prior to the early bird deadline.
- Scholarship applications must be received 2 weeks prior to the campers arrival date to be applied toward the camp.

### PRIVACY STATEMENT: This explains how we will use the information you give us.

Timber-lee requires the information on this application in order to determine eligibility for available financial aid. We will use your information only to determine if your child is eligible for financial assistance, and for administration and enforcement of scholarships.

- If you do not file a tax return, you must submit Social Security/Disability Income, Welfare, or Food Stamp documentation listing the child as a dependent.
