GENERAL PRICE LIST

These prices are effective as of March 1, 2026 but may be subject to change without notice.

In compliance with the trade regulations of the Federal Trade Commission, we are required to provide you a general price list for your retention. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF: \$ 2,750.00

Our fee for the basic services of Funeral Director and staff includes, but is not limited to the following; staff to respond to initial request for service; arrangement conference with family or responsible party; consultation with family and clergy; arrangement of Funeral; preparation and filing of necessary notices; authorizations, and consents; coordination with those providing other portions of the Funeral. Also included in this charge are the overhead expenses relative to our facility such as insurance, maintenance, utility expenses, secretarial and administrative costs, and equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

TRANSFER OF REMAINS TO FUNERAL HOME: \$ 525.00

Within a radius of thirty (30) miles
The charge for additional miles is \$3.00 per mile one way.

EMBALMING: \$ 750.00 - \$ 950.00

Except in certain special cases (see requirements of Michigan law set out below), embalming is not required by law. Embalming may be necessary, however, if you select certain arrangements, such as a funeral with viewing or visitation. Most common carriers also require embalming. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation, or immediate burial. *Michigan law requires embalming when death was caused by certain infectious diseases or, with very limited exceptions, when the body is not taken to its final destination (such as a cemetery or crematory) within 48 hours of death.*

OTHER PREPARATION OF THE BODY: \$ 425.00

Services provided may include (when necessary), but are not limited to the following, restoration, and cosmetology, washing, disinfecting, manicuring, and placing the body into the casket.

Hearse (funeral coach) within radius of 30 miles. \$ 400.00
The charge for additional miles is \$3.00 per mile one way.

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME:

This charge includes removal of remains, basic services of Funeral Director and staff, embalming, receptacle for body, obtaining necessary authorizations, local transportation to airport. It does not include services of staff or use of facilities for any viewing (visitation, wake, or family hour), rites or ceremonies prior to forwarding of the remains, or common carrier charges.

- With minimum shipping container (Combination Unit) \$ 3,075.00
- With casket selected from our funeral home (in addition to the cost of the casket) \$ 2,725.00
- Air Tray \$ 250.00
- Combination Unit \$ 350.00
- With container provided by purchaser \$ 2,725.00

The cost of transportation beyond a radius of 30 miles in vehicles of the funeral home is \$3.00 per mile one way.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME: \$ 1,850.00

This charge includes receiving the remains from another funeral home, temporary shelter of remains, obtaining necessary authorizations, local (within 30 miles) transportation of remains to cemetery or crematory and basic services of funeral director and staff. It *does not* include the services of staff or use of facilities for any viewing (visitation, wake, family hour) or rites or ceremonies after receiving the remains, or common carrier charges. The cost of transportation beyond a radius of 30 miles in vehicles of the funeral home is \$3.00 per mile.

IMMEDIATE BURIALS:

Prices range from \$2,650.00 to \$10,100.00

Our charge for an immediate burial without any attendant rites or ceremonies includes:

- Removal (within 30 miles) and shelter of remains
- Local (within 30 miles) transportation to cemetery
- Necessary basic services of funeral director and staff and obtaining authorizations

Our charges *do not* include the use of facilities or staff for any viewing, visitation or ceremony, public or private, the actual cost of the grave at the cemetery, the cemetery's charge for opening and closing of the grave, the preparation of the grave site, or any other goods or services except those expressly set out above.

- Immediate burial with a casket selected from our funeral home (in addition to cost of casket) \$ 2,650.00
- Immediate burial with container provided by purchaser \$ 2,650.00

The cost of transportation beyond a radius of 30 miles in vehicle of the funeral home is \$3.00 per mile one way.

DIRECT CREMATION:

Prices range from \$2,375.00 to \$2,375.00

Our charge for a direct cremation without any rites or ceremonies includes:

- Removal (within 30 mile radius) and shelter of remains
- Local (within 30 miles) transportation to crematory
- Necessary basic services of funeral director and staff and obtaining authorizations

You are not required to purchase a casket for direct cremation, but you may do so if you wish. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are corrugated cardboard. (Our charges do not include the use of facilities or staff for any viewing, visitation, or ceremony, public or private, or any other goods or services except those expressly set out above).

- Direct cremation with casket selected from our funeral home (in addition to cost of casket) \$ 2,375.00
- Direct cremation with alternative container \$ 2,375.00
- Direct cremation with container provided by purchaser \$ 2,375.00

The crematory fee and cremation authorization (medical examiner certification) are cash advance items and are not included in the above listed cost of a direct cremation. These fees will be itemized on the Statement of Funeral Goods and Services Selected in the cash advance section.

The cost of transportation beyond radius of 30 miles in vehicle of the funeral home is \$3.00 per mile one way.

PLEASE NOTE: Cemeteries or crematories may have certain restrictions concerning the type of burial or cremation container they will accept, may require the use of an outer burial container, and may have other rules, regulations, and restrictions which may limit your choices or require you to purchase certain goods or services. We have no control over the policies of cemeteries/crematories. We will however advise you of the policies of cemeteries/crematories and whether your choices are compatible with your choice of cemetery/crematory.
