

**RESOLUTION 2025-05**

**KERR COUNTY EMERGENCY SERVICES DISTRICT NO. 1**

**RESOLVED**, that an ad valorem tax for the year 2025, be levied by the Kerr County Emergency Services District No. 1, (the "District"), and was levied by act of the duly appointed Commissioners of the District for use in carrying out the legal purposes and objectives of the District, at the rate of \$0.0122, per One Hundred Dollars (\$100.00), of valuation, said valuation adopted by Kerr County pursuant to the certified tax roll for the year 2025, and further the Commissioners acting on behalf of the District, do hereby authorize the duly elected Tax Assessor Collector of Kerr County, Texas, to collect ad valorem taxes for the District; and that a copy of this resolution be forwarded to the aforementioned Tax Assessor Collector for her authority and guidance.

**RESOLVED**, that the Kerr County Emergency Services District No. 1, (the "District"), acting by and through its duly appointed Commissioners, does hereby authorize the Kerr County Tax Assessor Collector to collect ad valorem taxes for the District for the 2025 tax year, and that the Kerr County Tax Assessor Collector shall be authorized to charge the District a fee of ONE PER CENT (1%), of taxes collected, and ONE PER CENT (1%) on penalties and interest, actually collected by the Kerr County Tax Assessor Collector.

**RESOLVED**, that District tax monies so collected by the Kerr County Tax Assessor Collector shall be distributed to the District at least monthly, and that any tax monies so collected by the Kerr County Tax Assessor Collector, shall be placed in an interest-bearing account in a federally insured financial institution selected by the Kerr County Tax Assessor Collector, until such monies are disbursed to the District as set forth above; and, that any interest earned on such monies shall be the property of the District and disbursed to the District along with tax monies collected by the Kerr County Tax Assessor Collector.

**RESOLVED**, that the Kerr County Tax Assessor Collector shall provide a monthly report to the District, showing collection activities for the preceding month.

**BE IT FURTHER RESOLVED**, that a true copy of the Resolution shall be forwarded to the Kerr County Tax Assessor Collector, upon adoption.
