Welcome from our CEO

As 2025 draws to a close, I am pleased to share some key highlights and achievements from what has been a busy and impactful year for Safe Home Ireland.

In February, we were pleased to join partners in Ireland and the US to launch a campaign for reciprocal US-Irish driver licence exchange, which is now a key commitment in the 2025 Programme for Government. We continued to raise the issue across all relevant fora, and there has been encouraging progress to date. The Minister for Transport, Darragh O'Brien TD, has written to the Governor of New York, the first State formally approached. The Road Safety Authority is examining its feasibility. We will continue to share updates as they arise; in the meantime, please consider subscribing to the campaign mailing list HERE.

Also in February, we welcomed our partners from the European Return Migration Network (ERMiNe) to Dublin for the project launch at EPIC The Irish Emigration Museum. This is our first European Erasmus+ project, coordinated by Werkstatt für Sozialforschung e.V. (Germany) and delivered by key organisations from Germany, Spain, Latvia, Italy, Poland, as well as Crosscare Irish Diaspora Support Project here in Ireland. The project aims to strengthen support for intra-European mobility and return through shared learning and best practice. Further project meetings were held in Brussels in June and Berlin in November. We look forward to working together to explore continuation and expansion of this Project in 2026. Further information on the Project can be found on our website HERE.

One of the standout moments of the year was the launch of our new Safe Home Ireland Website in September at EPIC The Irish Emigration Museum in Dublin. Our new site significantly improves access to information for returning emigrants and partner organisations. To mark both the launch and our 25th anniversary, we hosted a stakeholder's event, bringing together partners from the US, Australia, the UK and Ireland. We encourage you to explore our new website HERE and to share it with colleagues, partners, networks, and anyone who may be thinking of returning or moving to Ireland.

A special highlight of the year was my US Outreach trip, to New York and Boston in October and November. Funded by a separate grant from the Department of Foreign Affairs and Trade Emigrant Support Programme - this was an invaluable opportunity for me to connect with Irish diaspora, some of whom are thinking and planning to return or moving to Ireland (some voluntarily and some involuntarily). It was great to visit so many Irish Centres and meet with all of the dedicated staff and volunteer teams. A special thank you to everyone I met and for the warm welcome. The Centres are a lifeline for many in our diaspora and a 'home away from home'.

Our UK outreach also remained strong, with visits by our Outreach & Advocacy Officers to Irish Centres in London, Luton, and areas mainly in the South-East, hosting Moving/Returning to Ireland Information Clinics, and meeting many of our housing applicants too and others thinking about moving/returning to Ireland. We look forward to broadening this work in 2026 across other locations in the UK.

We continue to work closely and meet regularly with our key partners here in Ireland, Crosscare Irish Diaspora Support Project, Citizens Information and Irish Council for Prisoners Overseas, to ensure we work together to offer a co-ordinated and seamless service to the Irish diaspora and those who are considering or have returned home to Ireland. We also worked in partnership with many Irish Embassies and Consular Services in Ireland and Abroad to support, guide and directly assist those who required our support to return home. We were also delighted to visit Irish Embassies and to meet with Consular teams in-person in Brussels, Berlin, New York and Boston on our trips abroad during the year.

Throughout the year, our Returned Emigrants Network (REN) continued to meet in Laois, Sligo, and online. REN provides returnees with a space to connect, share the positive aspects of returning to Ireland, and address some of the challenges, with the aim of advocating for a smoother journey home for others. We hope to extend REN gatherings to additional locations in 2026. If you would like more information or to get involved, contact our office directly HERE.

Applying for an Irish Contributory Pension, if you live abroad

Please see HERE for an overview of the Irish State Contributory Pension

Depending on the level of contributions made in the Irish system, applicants may be entitled to a full or pro-rata pension (where contributions made in other qualifying countries can be combined). Applicants should apply for the Contributory Pension about 6 months before they reach pension age (currently 66 years).

Please be aware that it is possible to start the application process even if you do not have an Irish Insurance Number/PPSN.

The Pension Services here in Ireland will then liaise with you directly in relation to issuing a PPSN. If you qualify for any pension, your application will be back-dated to the date you applied, rather than the date a PPSN was issued to you.

<u>Applying from the USA & Australia</u>: Application and any supporting documents should be submitted by post* to:

(*unless the client has a verified MyGov account to submit an online application*)

Pension services here can engage directly with the US Embassy in Dublin to check US contributions. This will be relevant in cases where a pro-rata pension applies.

<u>Applying from the UK/EU</u>: Application should be submitted via the Pension Services in the country of residence. This route makes it easier/quicker for the Irish pension services to access information on combined contributions history. The relevant application form for this is EUP65

UK State Pension - Entitlement to annual increase if resident outside of the UK

Q. Will I still get my UK State Pension annual incremental increase if I leave the UK?

A. Your State Pension will only increase each year if you live in:

- The European Economic Area (EEA)
- Gibraltar
- Switzerland
- countries that have a social security agreement with the UK

You cannot get increases in Canada or New Zealand.

Note! Your pension will go up to the current rate if you return to live in the UK.

UK Based Support Services for Survivors of Institutional Abuse

<u>Fréa Renewing Roots</u>, <u>Coventry Irish Society Midlands Irish Survivors Service</u> and the <u>London Irish Centre Survivors Integrated Service</u> offer specialised support for survivors of Ireland's institutions and their family members based across Britain.

The services offer trauma-informed support, by specialist staff making applications to the different payment schemes, searching for records and accessing the Irish Government tracing service. Services are free of charge and completely confidential.

In addition, each service offers regular group activities to survivors such as social events and educational activities.

Frequently Asked Questions – Driving in Ireland

Q. I am returning to live in Ireland **from the UK**. Can I keep driving on my UK licence until it expires?

A. You can drive on a valid UK driving licence in Ireland for up to 12 months, <u>but only while</u> you remain a visitor.

As the UK is no longer part of the EU, anyone becoming resident in Ireland must exchange their UK licence for an Irish one. <u>This applies even if your UK licence is still valid for several years.</u>

Q. I am returning to live in Ireland **from the U.S.** Will I have to surrender my U.S driver's licence when I apply for an Irish one?

A. No, as there are currently no reciprocal /exchange agreements in place between Ireland and the U.S. at present, you will not have to surrender your U.S licence.

However, please be aware that once you are issued an Irish learner's driving permit, that permit will take precedence over your U.S licence here in Ireland and you must abide by all the relevant rules and regulations attached to that - please see HERE for more information.

Safe Home Ireland, together with a range of other agencies and individuals, is currently campaigning for the introduction of reciprocal driver's licence exchange arrangements between Ireland and the U.S.

UK Personal Independence Payment (PIP) and Living Abroad

If you move abroad, the way Personal Independence Payment (PIP) is paid can change. The Department for Work and Pensions (DWP) reviews claims to ensure that people continue to receive the right amount of money.

Mobility Component: The Mobility component of PIP is not payable outside the United Kingdom. If you move abroad, entitlement to this part of PIP will stop.

Daily Living Component: You may still qualify for the Daily Living component of PIP if you move to Switzerland or a country in the European Economic Area (EEA). However, certain conditions must be met:

- You, or a family member, must be receiving a UK benefit such as a state pension, Incapacity Benefit, or a bereavement benefit.
- Alternatively, you or a family member must have paid enough National Insurance contributions in the UK to qualify for a sickness benefit.
- You must not be working or claiming a benefit in the country where you live.
- You must also be covered by the Withdrawal Agreement.

Changes You Must Report: You must inform the DWP straightaway if there are any changes that could affect your PIP, such as:

- Starting work or claiming benefits in your new country of residence.
- Beginning to receive another UK benefit, or if an existing benefit stops.

Reconsiderations and Appeals: If you disagree with a decision about your PIP, you can request a reconsideration within one month of the decision letter. Only after a reconsideration can you appeal the decision.

Immigration and Stamp 0 in Ireland - An Overview

Stamp 0 indicates permission to stay in Ireland for a temporary period, subject to conditions.

Summary of qualifying conditions:

- You must be of independent means, fully financially self-sufficient.
- Alternatively, your sponsor in Ireland must be of independent means and can support you fully.
- You cannot receive any benefits or use publicly funded services, for example be treated at a public hospital. You must have private medical insurance.
- You must not work or engage in any business, trade or profession unless specified in a letter of permission from Immigration Service Delivery.

Examples of when Stamp 0 is used - you may be given **Stamp 0** if you have permission to:

- Retire to or live in Ireland as a person of independent means
- Visit as an academic at an Irish university or college
- Live in Ireland as the elderly, dependent relative of an Irish National, or a non-EU/EEA or Swiss citizen.

Some examples of documentation required:

- Cover letter explaining your circumstances and confirming self-sufficiency.
- Copy of your passport
- Financial evidence: 6–12 months of bank statements, pension documents, savings/investment proof.
- Private medical insurance covering treatment in Ireland.
- Proof of accommodation in Ireland.
- Police clearance for any country lived in for 6+ months in the last 5 years.
- For dependent parents: evidence of dependency, sponsor's financial records, and proof the parent cannot live independently abroad.

Where to Apply - Applications are made by post only to; Stamp 0 Unit Immigration Service Delivery (ISD), 13–14 Burgh Quay, Dublin 2, Ireland

Costs: There is no application fee. However, when registering in Ireland (following approval), there is a \leq 300 IRP registration fee for issuing your Irish Residence Permit card.

The **average processing time** for applications can vary, it is currently 4 months. However, additional delays can be expected when applicants do not send in all of the required documents with their original application. Applications are processed in chronological order.

Important! Please be advised that this is a brief overview. The Stamp 0 application process can be complex and requirements may vary depending on your circumstances. It may be worthwhile to consult official agencies or immigration advisers before submitting your application.
