TERMS AND CONDITIONS

MANUS ABRASIVE SYSTEMS INC offers the following terms, conditions and provisions. These are based upon the unique approach of our company offering custom designed goods for each and every job.

STANDARD TERMS AND CONDITIONS

- 1) **25%** down and included with the original purchase order.
- 2) **50%** due **prior** to shipping.
- 3) **25%** net 30 days from date of shipment O.A.C.

CUSTOMER TO FURNISH

- Electrical wiring supplied to all equipment and starters/switches for all electrical components.
- CSA certification of the equipment as installed, as a whole; is the responsibility of the customer/end user. Individual electrical components used within the system will be CSA certified.
- Any equipment needed for material handling, erection and installation of the blast equipment and its' components.
- Clean, dry compressed air in a 2" supply pipe must be brought to within 8 feet of the blast equipment and terminated with a 2" ball valve. It is best that the exact location be determined in coordination with our Installation Supervisor. Our install crew will make final connections from the air supply to the various connection points as required on the system.
- Authority having jurisdiction will dictate, if required, any fire suppression system and related design criteria. Supply and installation of equipment is the responsibility of the customer and/or end user of the facility. All required utilities to be brought to points of demand. This includes electricity, compressed air, etc. to included control panels on supplied equipment. All required abrasives and initial charging for the system. All ducting between dust collector, muffler, blast room and air wash.
- Customer and/or end user is responsible for the research and application of any and all permitting, as required.

STANDARD WARRANTY

MANUS ABRASIVE SYSTEMS INC. offers 12-month warranty on all obvious design and manufacturing defects. In addition, we extend the standard OEM warranties on all outside vended goods.

SHIPMENT OF EQUIPMENT

The anticipated shipment of the equipment will be negotiated after receipt of a purchase order, a down payment and all pertinent information regarding the facility site required for design and manufacturing.

EQUIPMENT DISCLAIMER

The Products and machinery configured, designed and manufactured by **MANUS ABRASIVE SYSTEMS INC.** for this application are not to be used with silica sand blast media (abrasive). All Mod-U-Blast dust collectors are engineered for non combustible materials. If required contact your rep for testing and verification of spent material. Charges may apply.

CONCRETE AND FOUNDATION

The customer is responsible for the adequacy and construction strength of the concrete and foundation within the blast room to hold the weight of working pieces (customer specified to 20,000 lbs). The area in which the system is installed must be level, smooth concrete, free of debris. If below floor room is required, customer is responsible for concrete work / pit for recovery components.

CANCELLATION CHARGES

If canceled before release for purchasing and fabrication, **MANUS ABRASIVE SYSTEMS INC** will determine all costs incurred on the project to date of cancellation notice - principally engineering, labor, supplies and contract administration. These total costs will be marked up using **MANUS ABRASIVE SYSTEMS INC** standard commercial mark-up for this product line to cover profit, overhead, and sales expenses as appropriate for costs incurred to date. An invoice will be issued for this total amount.

If canceled after release for purchasing and fabrication, **MANUS ABRASIVE SYSTEMS INC.** will determine all costs incurred on the project as of the date of cancellation. These costs will include engineering, fabrication, labor, supplies and overhead; material where fabrication has begun and components cannot be returned to vendor; all cancellation charges from suppliers resulting from cancellation of purchase orders and all restocking charges for material normally carried as stock items by **MANUS ABRASIVE SYSTEMS INC.** which were already assigned to this project. These total costs will then be marked up using **MANUS ABRASIVE SYSTEMS INC.** standard commercial mark-up for this product line to cover profit, overhead and sales expense as appropriate for costs incurred to date. An invoice will be issued for this total amount.

FEDERAL, PROVINCIAL AND/OR OTHER TAXES

All sales for the quoted equipment do not include any applicable taxes that are related to the purchase and/or construction of that equipment. If the sale is exempt from taxes due to manufacturing, pollution controls, etc., then it is the responsibility of the buyer to provide MANUS ABRASIVE SYSTEMS with proper exemption certificates stating identification number and reason for exemption.
