## What is Family Engagement?

Family Engagement means the participation of parents and family members in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- That parents play an integral role in assisting their child's learning.
- That parents are encouraged to be actively involved in their child's education.
- That parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.
- The carrying out of other activities, such as those described in Section 1116 of Every Student Succeeds Act (ESSA).

#### **About MCS Parent and Family Engagement Plan**

In support of strengthening student academic achievement, McIntosh County Schools (MCS) developed this parent and family engagement plan that establishes the district's expectations and objectives for meaningful family engagement and guides the strategies and resources that strengthen school and parent partnerships in the district's Title 1 schools. This plan will describe MCS's commitment to engage families in the education of their children and to build the capacity in its Title 1 schools to implement family engagement strategies and activities designed to achieve the district and student academic achievement goals.

When schools, families, and communities work together to support learning, children tend to do better in school, stay in school longer, and enjoy school more. Title 1, Part A provides for substantive family engagement at every level of the program, such as in the development and implementation of the district and school plan, and in carrying out the district and school improvement provisions. Section 1116 of ESSA contains the primary Title 1, Part A requirements for schools and school systems to involve parents and family members in their children's education. MCS will work with its Title 1 schools to ensure that the required district/school-level parent and family engagement policies meet the requirements of federal law, and each includes, as a component, a school-parent compact.

# Jointly Developed

All parents were invited to provide suggestions, feedback, input, and revisions to improve the MCS Parent and Family Engagement Plan for the 2025-2026 school year through input surveys during April 2025. Parents were also invited to provide feedback at each school's Title 1, Part A Input Meeting. During the meeting, parents reviewed and discussed the Comprehensive Needs Assessment (CNA). This included discussion and input into the Comprehensive Needs Assessment, District Improvement Plan, and reservation of funds. Additionally, each Title 1 school used its spring input meetings and School Council to review the district parent and family engagement plan before the end of the school year.

Upon final revision, the district parent and family engagement plan will be incorporated into the CLIP which will be submitted to the state. Parents are welcome to submit comments and feedback regarding the plan at any time on the

school district website or by submitting written comments to your child's school. All feedback received by June 15<sup>th</sup> was included in the plan for this school year.

The district parent and family engagement plan is posted on district and school websites, distributed during the Annual Title 1 school meetings, sent home with all students, and made available in the school parent resource centers.

## **Strengthening Our School**

The district Family Engagement Coordinator (FEC) will assist and support all Title 1 schools to ensure family engagement requirements are being satisfied and that family engagement strategies and activities are being implemented. Title 1 schools will receive notifications and resources from the district and the FEC to help them improve and strengthen family engagement.

In addition to frequent communication and school visits, the district and the FEC will hold monthly meetings and trainings with its Title 1 schools' principals to review family engagement plans and activities.

Additionally, principals, the FEC, and federal programs director will come together in March to review parent and family engagement requirements and to plan opportunities for family engagement activities and meetings for the remainder of the school year.

### **Reservation of Funds**

MCS will reserve one percent (1%) of the total amount of Title 1 funds it receives in 2024-2025 to carry out the parent and family engagement requirements listed in this plan and as described in federal law. Furthermore, MCS will ensure that not less than ninety percent (90%) of the one percent (1%) reserved goes directly to Title 1 schools to support their school-level family engagement programs and activities. The district will provide clear guidance and communication to assist each Title 1 school in developing an adequate family engagement budget that addresses their needs assessment and parent and family recommendations. Stakeholder input is solicited through the school and district input meets and surveys regarding how these parent and family engagement funds could be used in the upcoming year.

# **Annual Title 1 Meeting**

Each school served under Title 1, Part A will convene an annual meeting, at a convenient time prior to November 1. All parents of participating children shall be invited and encouraged to attend. The purpose of this meeting will be to inform parents of their school's participation in Title 1, Part A programs, and to explain the Title 1, Part A requirements and the rights of parents to be involved in those programs. In addition, schools may use this opportunity to:

Explain what participation in Title 1 programs means, including:

- A description and explanation of the school's curriculum,
- Information on the forms of academic assessment used to measure student progress, and
- Information on the proficiency levels students are expected to meet:
- Explain the district parent and family engagement plan and school-parent compact.

#### **Communications**

Parents shall be notified of the parent and family engagement plan in an understandable and uniform format, and to the extent possible, provided in a language the parents can understand. Each Title 1 school shall offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, childcare, or home visits, as such services relate to parent and family engagement. Each school shall also provide parents of participating children timely information about programs. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible

### **School-Parent Compact**

Each Title 1 school shall jointly develop with parents of all children served under Title 1 a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and how the school and parents will build and develop a partnership to help children achieve the state's high standards. The school-parent compact shall include the following requirements: revision and distribution dates, jointly developed, parent input, district and school goals, outline of school, parent, and student responsibilities for improved academic achievement, activities to build partnerships, communicate student progress, and shall be written in a family-friendly language.

## **Parent and Family Engagement Evaluation**

Input and suggestions from parents and family members are an essential component of the district and school improvement plans that are developed each year. MCS will take the following actions to conduct, with meaningful engagement of parents, families, and community stakeholders an annual evaluation of the content and effectiveness of this parent and family engagement plan in improving the academic quality of our Title 1, Part A schools. All parents of students eligible to receive Title 1 services are invited to participate in various meeting and survey opportunities described in this section to share their ideas and suggestions to help the district, schools, and students reach academic achievement goals.

#### School-Parent Input Meetings - February/March/April 2025

Each Title 1 school will host a face-to-face parent and family input meeting during the spring for parents and families to provide their input, feedback, and suggestions in the district parent and family engagement plan, school-parent-student compact, school improvement plan, and training sessions for building staff capacity for working with and communicating with parents and families.

#### Parent-Family Input Surveys - February/March/April 2025

MCS and each Title 1 school will provide input surveys to seek input, feedback, and suggestions and email a link to-the survey for parents to provide meaningful feedback regarding the parent and family engagement activities and programs. These surveys will also be posted on the district and school websites for parents to complete. Parent input on the use of Title 1 funds to support family engagement programs may also be provided through the annual district survey. The survey will contain questions related to the family engagement budget as well as a section for parents to provide their comments.

#### MCS Family and Community Input Meeting – February/March/April 2025

MCS will participate in school input meetings to seek input, feedback, and suggestions for the follow: *Comprehensive Needs Assessment (CNA)*, District improvement Plan, District Parent and Family Engagement Plan, District Parent & Family Engagement Budget, training sessions for Building Staff Capacity.

MCS will use the findings from the input meetings and survey results to design strategies to improve effective family engagement, to remove possible barriers to parent participation, and to revise the district parent and family engagement plan.

Notices regarding the input meetings will be shared through various methods: REMIND, social media, district and school websites, emails, etc.

All school and district Title 1 meeting documents, handouts, agendas, and PowerPoint presentations will be posted on the district and school websites for parents/families to view and provide input if they are unable to attend events. #### **Building Capacity of Parents and Staff**

McIntosh County Schools will build schools' and parents' capacity for strong family engagement. This capacity will ensure effective engagement of parents and family members in supporting partnerships among the Title 1 schools, parents, and the community with the goal of improving student academic achievement. To build this capacity, MCINTOSH COUNTY SCHOOLS will implement district-wide activities and programs. With the teacher, families set student academic goals to be addressed through at-home learning activities and strategies.

Of Parents - Supporting Student Success - MCS will work through its Title 1 schools to provide parents assistance in understanding state and district academic information connected to student learning and progress. The district will also provide parents with information about the overall Title 1 program and its requirements. Specific information related to the Georgia Standards of Excellence and local and state assessments—including alternative assessments will also be provided.

Communicating Effectively - MCS will coordinate pages on the district and school websites that will contain resources and materials, including parent guides, study guides, practice assessments to help parents work with their children at home. Copies of these materials will be made available at all Title 1 schools for those families who may have limited internet access, including copies in Spanish. To assist parents with understanding the online student information system and other digital educational resources (including education about the harms of copyright piracy), the McIntosh County School System technology specialists will partner with Title 1 schools to host workshops for parents. The dates and times for these opportunities will be determined and notifications will be shared through school messaging systems, newsletters, the district app, websites, flyers, and social media postings.

**Speaking Up for All** - MCS will re-establish a district wide Parent Advisory Council comprised of parent representatives from each Title 1 school. This council's purpose will be to provide advice on all matters related to family engagement in Title 1, Part A programs. Community leaders and business partners will be invited to serve on this council. In addition, each school has an active school council.

Welcoming All Families - The district will coordinate and integrate the district's family engagement programs under this part with parent and family engagement strategies, to the extent feasible and appropriate, with other relevant Federal and State, and local laws and programs such as, the local preschool program and other federal and state funded preschool programs in the district. The district will invite faculty and staff from those programs to attend planning meetings focused on family engagement activities. In the spring, schools will host Kindergarten Ready days, Middle and High School Transition Nights, and a College and Career Fair so parents may receive information to help prepare them and their children for the next life stage.

**Sharing Power -** The district and schools are committed to encouraging opportunities for parents and family members to serve as parent leaders by helping to organize events, volunteering at schools, participating in PTA/PTO, serving on school councils, and networking with each other and with the community.

**Collaborating with the Community -** MCS will collaborate with community members to connect students, families, and staff to expanded learning opportunities, community services, and civic participation that enhance school environments.

Of School Staff - McIntosh County Schools will conduct trainings during the school year for principals and school staff to learn and discuss strategies to increase family engagement, improve school-family communication, and build ties with parents and the community. These trainings will be redelivered to the faculty and staff of Title 1 schools. McIntosh County Schools will also host a training for appropriate school staff and faculty that will focus on creating welcoming environments and improving two-way communication with families.

To ensure that information related to district, school, parent programs, and activities is available to all parents, each Title 1 school is required to send home and post online information for parents and family members in an understandable language and uniform format. At the beginning of the year, school staff will be trained on parent notifications and resources to be sent home in parents' native language, where applicable, and provide interpreters at parent events. Information posted on the district website will be translated to the extent practical. The district will also utilize school phone call systems, district and school websites, a new district app, local news media, and other school message systems to post information for parents.

## Accessibility

In carrying out the parent and family engagement requirements established by Section 1116 of the ESSA, the district family engagement coordinator will communicate and collaborate with the Office for Student Support Services to ensure full opportunities for participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children including providing information and school reports in a language parents can understand.

## Adoption

This district-wide parent and family engagement plan has been developed jointly and agreed upon with parents and family members of children participating in Title 1, Part A programs as evidenced by the collaboration of parents, school, and district personnel at the annual State of the District Input Meeting.

The school district will distribute this plan in multiple ways to all parents of participating Title 1, Part A children prior to **November 1, 2025**.
