Failure to Appear will result in an additional charge being filed against you for violating your promise to appear with a fine not to exceed \$500.00 and additional state fees will be incurred. If you have a driver's license, you will be entered into Omni Base in Austin and a hold will be placed on your license until fines and cost are made in FULL!

**Request for Driver Safety Course**

**Request for Deferred Disposition**

I understand that I must, **AFTER 30 days, return my NOTARIZED deferral affidavit to the Court. If you are under 25, you will be required to take a driver safety course as a condition of your deferral.**
