## What Are The Rules?

According to N.J.S.A. 45:27-22, In the state of NJ, the right to control the funeral service & merchandise decisions, authorize disposition of the human remains as well as who and in what priority class an individual can engage the funeral home to conduct funeral arrangements is as follows in this order:

1. N.J.S.A. 3B: 10-21.1, Prior to probate of the last will and testament, a decedent's appointment of a person as a "**Funeral & Disposition Representative**", within the last will and testament or on a form approved by the NJ Cemetery Board under the NJ State Attorney General, Division of Consumer Affairs, to control the funeral and disposition may be carried out in accordance with section 22 P.L. 2003 c. 261 verified by the last will and testament or "Funeral Representative" declaration.
2. The **Legally Married Spouse**, domestic partner or civil union verified by a certified copy of the marriage certificate, domestic partnership registration or civil union license. There are no legally binding common law unions in the state of New Jersey.
3. **The Majority of the Adult, Biological and/or Legally Adopted Children**, verified by a certified copy of legal adoption, birth, death and/or marriage certificate.
4. **The Majority of the Adult, Biological and/or Legally Adopted Siblings**, verified by a certified copy of legal adoption, birth, death and/or marriage certificate.
5. **The Majority of the Adult, Biological Aunts and/or Uncles**, verified by a certified copy of legal adoption, birth, death and/or marriage certificate.
6. **The Majority of the Adult, Biological Cousins**, verified by a certified copy of legal adoption, birth, death and/or marriage certificate.
7. After 72 hours have passed from the date and time of the pronouncement of death and a reasonable effort has been made and acknowledged (on a separate form) to contact an authorizing agent(s) in a higher priority class, Any Interested Party may voluntarily choose to act in the capacity of an authorizing agent.

## THE BASIC SERVICES OF FUNERAL DIRECTORS & STAFF 2505

Professional, compassionate service from your community funeral home is readily available 24 hours a day, 365 days a year. Our fee for the basic services of funeral directors and staff include but are not limited to...

- Receiving and responding to the initial request for service and preparation for the transfer of the decedent's custody and care.
- Travel (to and from), conducting and leading the goodbye experience decision making conversation.
- Preparation of biographical and statistical information during the decision making conversation.
- Examination of financial settlement options during the decision making conversation.
- Preparation and filing of papers, permits and authorizations after the conversation
- Coordinating with those providing other services that are part of the goodbye experience after the conversation
- Composition, preparation, placement and hosting of printed newspaper & online "e-bituary" notices after the conversation
- Retention and care of decedent up to (5) five days prior to the commencement of post-death events
- Overhead expenses relative to our funeral homes & operations such as occupancy, administrative and equipment costs.

The fee for the basic services of the funeral directors and staff will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for immediate cremation, immediate burials and forwarding or receiving remains.



## RETENTION, CUSTODY AND CARE

Sheltering, refrigeration and continued custody of the decedent after (7) seven days from the day in which the decedent was received into the funeral home's care and in which no post-death activities occur, per day 195

## CARE AND PREPARATION

Embalming preparation is the replacement of fluids and introduction of chemicals within the human body for disinfection and temporary preservation. The purpose of embalming is to permit the body to be present for the goodbye experience.

Except in certain, special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangements that does not require you to pay for it such as immediate cremation or burial.

## FAREWELL PACKAGED SELECTIONS SOCIAL SERVICE ASSISTANCE & DISPOSITION BENEFITS

The State of New Jersey assists low income individuals in paying for final disposition arrangements through a subsidy of \$ 3,056. The Work First New Jersey Program (WFNJ) is funded by the State of New Jersey with a budget line item through the NJ Department of Human Services (DHS) and is distributed by the board of social services or county welfare agency in the county where the decedent legally resided at the time of their death. The board of social services permits interested parties to contribute towards the public assistance subsidy. Interested parties can supplement the subsidy with a co-pay up to a \$ 1,570 maximum for a total, combined budget of \$ 4,626. The decedents assets cannot be used to supplement their own final disposition expenses. These assets will be collected by the State of New Jersey as part of the state's asset recovery program. The decedent's assets could disqualify the decedent from subsidy eligibility. Program eligibility is subject to approval and will be determined by application to the board of social services in the county where the decedent legally resided at the time of their death. 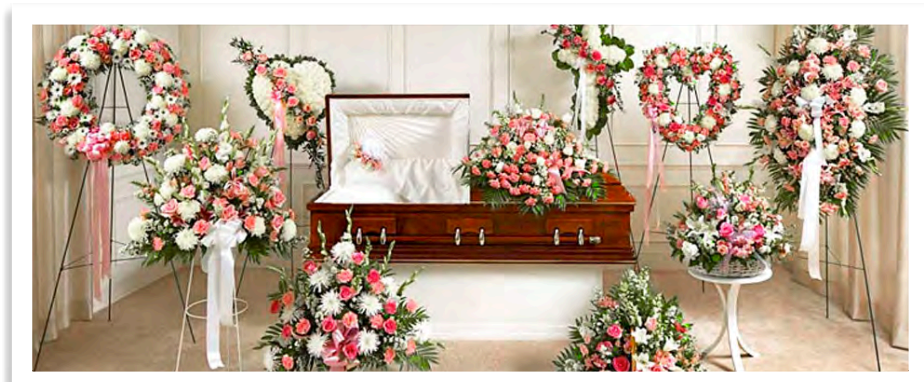
