# Senior Pastor's Report

This year 2023 was marked by many of our church events and programs beginning to see more normal participation, while still bearing the weight of the past few years' difficulties. At times, we did feel the impact of "what we missed," being "out of practice" at certain things, and being a little rusty at some of the experiences we used to navigate with ease.

I share this not to "yet again" blame it all on Covid, but to share how part of our healing and moving forward has been relearning things once routine. We noticed our children's programs began to really grow—with great numbers during VBS this summer and record-breaking numbers during HHH. Our teaching strategy needed to address basic skills many of our children missed during at-home instruction. Using scissors or pencils properly, knowing right from left—very basic skills were emphasized during our summer programs with great success.

The winter began with Lent and Easter, which were (for me) the time I finally contracted COVID. Pastor Katie Jo flawlessly covered for Lenten programing—our soup suppers included great conversations about the faith journeys of Bible legends like Jonah and Abraham.

After Easter, Dana Callahan and I put out a challenge to the congregation for greater support of HHH. Dana had been feeling unsupported, but with an HHH Sunday that included information about many ways to serve, our congregation stepped up with greater volunteerism and financial support. For me, the moment was a great example of how, when a need or challenge is expressed, our congregation steps up! Thank you again to all who support these ministries.

This support continued throughout the summer as we culminated HHH with an Art Show, hopefully the "first annual" show with many to follow.

With the leadership of Lisa Bossetto and her extended family, including Pat McChristian's daughter Toni Geisen, we launched a new ministry called Pat's Closet. We turned one of our dressing rooms by the stage into a little boutique offering formalwear to young people. This project will continue (and hopefully) expand during the spring months in anticipation of prom.

This fall, the Long Rangers began meeting as our long-range planning committee. The varied participation of long-time and newer members has been absolutely inspirational for me as pastor, and we hope to help our congregation adapt and move into the future, doing great ministry in the community.

Finally, this year included the resignation of our longtime associate pastor, Rev. Katie Jo Bielke. As her colleague, I am full of excitement to see such a talented woman minister move on to share her gifts with the wider church. Personally, I am full of all kinds of emotions—including grief at her departure and worry about the future.

But please, congregation, HEAR ME ON THIS: change is always the place where God's work shines brightest. Rev. Katie Jo's new church is poised for tremendous growth with her leadership, AS ARE WE HERE AT SJUCC poised for new growth and opportunities!

As Rev. Katie Jo made her announcement at year's end, a few people have reflected to both of us how the church shaped her growth as a young pastor. It's a point of wonderful accomplishment that she is the

confident and talented preacher and teacher she is today. While her own gifts and the Holy Spirit have a lot to do with this, so too does this congregation. The people of St. John have helped to love her into the minister she is today. People have shared how much they'd like to do this again with other pastors new to ministry.

I share this insight because it feels like evidence (already!) God is moving in our congregation. A church that views itself as a "teaching and mentoring" congregation is a place open to growth of all kinds. It's a place open to trying new things, knowing both success and failure are valuable in shaping pastors and people of faith. It's a congregation of people who know their presence and participation is important—VALUABLE to the whole. It's an identity I think St. John UCC has held for a long time, even if we did not know it or name it as such. And it's an identity that opens up a world of possibility for ministry in our community and beyond.

As we evaluate and give thanks for this year, and look into a new one, I wish you deep blessings, open hearts and I look forward to learning alongside all of you.

# **Trustee Report**

The Trustees have had a busy year here at St. John. We have investigated and then entered into a 3-year agreement for wholesale electric. Also, a committee was formed to start looking into the possibility of adding Solar Power to help reduce the electrical cost.

The Fellowship Hall Kitchen plumbing repairs were completed. Now that the floor has cured, tiles can be put back down. The Holystone Hall floor was stripped and resealed.

We approved the purchase of 5 additional panic buttons and have placed them throughout the campus. Ray and Bart have installed 5 more P-tac units. This leaves two to be replaced, it has not been determined if one of them needs to be replaced.

The stain glass windows from the old church were repaired and mounted in their refurbished frames and placed in the sanctuary. The narthex was painted to give it a much-needed updated look.

A lift was rented, and the can lights in the Faith Hall lobby were changed to LED lights. The Youth Room in Faith Hall was repaired and repainted, the floors were also stripped resealed.

All the parking lots were resealed and restriped.

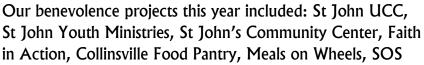

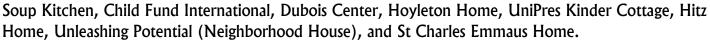
# **Evening Circle**

# Faith Hall Programming & Youth Ministries

With every ministry I work on in the dual roles that I fill here, I like to focus on the St. John UCC tag line, "The church in the heart of the community with the community at heart." St. John UCC touches those in our community from birth to the grave. I am so proud to be a part of such a mission driven group of Christians! Here are the highlights of the Faith Hall outreach ministries and Children's Education ministries in 2023:

**Faith Walking** – The Faith Walkers celebrated their 18th year on November 1. During the year, they walked an accumulative total of 6,431 miles, exceeding their goal of 5,500 miles.

There were 73 people who tried Faith Walking last year. Impressively, over the

last 18 years, the Faith Walkers have

walked a total of 150,830 miles! ## Homework Help & Hoops

We have been tutoring at-risk students since January 2007. The program is on Tuesdays and Thursdays from

3:00-6:00 p.m. for 20 weeks of the school year. 45 HHH staff tutored 49 students in 2023 with these goals in mind:

- 1. Give kids a safe, nurturing place to come and receive acceptance, love, and help from caring adults.
- 2. Model appropriate behavior and act as positive role models for our neighborhood children.
- 3. Give an academic boost to the children in our program.

We continue these goals with our HHH Summer Camp program. In 2023, we had 92 children enrolled in our free







summer lunch program (averaging 62 a day) and were staffed by 10 kitchen volunteers, 10 Reading Buddies, and 94 adult and youth activity volunteers. There were four firsts this year: an HHH art show featuring a wonderful display of art projects made by the students thanks to Pr. Jenn's vision and leadership; a special HHH's Got Talent show on our last day made possible with the collaboration of the CHS Drama Club: basketball camp led by Cortez Line

CHS Drama Club; basketball camp led by Cortez Liner and Joy Honegger; and Knitting Camp led by Pr. Jenn.

We are truly touching lives with our HHH programs!

## Spirit of Sharing (S.O.S.) Soup Kitchen

Since June 7, 2012, St. John UCC has been instrumental in organizing and hosting the S.O.S. Soup Kitchen focusing on their mission statement, "To

be the helping hands that provides the love of God to those who are hungry." We continue to be a host site for the Thursday meals at St. John UCC with meals being served at First United Presbyterian Church every Tuesday except the last Tuesday of the month, and First United Methodist Church on the last Tuesday of the month. Since COVID, S.O.S. has been served in a drive-

through manner and we expect this to change because of a lack of volunteers. As a result of increasing inflation this year, we saw a marked increase in the number of people coming to our doors needing food. In 2022, we served 10,309 meals. By the end of the 2023, we have served 16,618 meals. I would like to thank Dena Bieser for her dedication and service to this ministry since the beginning. Dena is not stepping away from S.O.S, just

stepping down as the St. John team leader. If you have the spiritual gift of hospitality, a new ministry opportunity just opened up for you!

The Faith Hall facility continues to be used not only by St. John for things like Pickleball and Learning Tree activities and St. John's Community Care's Health Fair, but many outside organizations and individuals rent the gym for their events. St. John UCC continues to be a special place for ministry in our community!







Youth Ministries oversees all the ministries that involve children from birth through high school. The highlights of 2023 for the Youth Ministries Team were:

 Blessing Box Food Drive – Youth Ministries and the Sunday School children accepted the Thrivent Challenge to collect 150 food items for the St. John Blessing Box to earn a matching \$150 to purchase more food.

Thanks to Nancy Berry for doing the paperwork for us! The congregation backed the Sunday School children and in total, 568 food items were collected!

• <u>Lego Party</u> – As an end of the school year celebration, families were invited to gather and be creative.

- Jesus is With You Wherever You Go was our summertime theme for church members who travel or do fun outdoor things in the warm weather. It is always fun to see all the pictures members share on Rally Sunday showing the many places Flat Jesus has visited.
- <u>Italian Fest Parking Lot Fundraiser</u> Always a fun way to raise funds for our ministries. The beautiful weather helped us bring in \$3,048.50.
- <u>Halloween Movie Night</u> A costume parade, a hot dog dinner, and a Halloween movie (which was moved inside because of the night chill) made for a memorable evening for St. John members and their guests.
- <u>Deck the Halls Christmas Bazaar</u> Our first attempt at a December Christmas Bazaar was a success with 14 vendors, 200 guests, live music by Carolyn Catalano and her violin students, Jenny King, and the St. John Choir, delicious food by our community's newest Girl Scout Troop. Lots of fun was had by all!
- <u>Birthday Party for Jesus</u> The emphasis for this year's party was giving. We read the Legend of St. Nicholas so the children learned the origin of Christmas gift giving. The kids were encouraged to bring an unwrapped toy to give to the Collinsville Food Pantry Toy Drive. Cupcakes, Christmas Bingo, Crafts, and our annual SS snowball fight were delightful!

<u>Crib Room and Sunday School</u> – These ministries focus on the youngest of our members. Our Crib Room is staffed by Larissa Addy and her wonderful rotating staff of volunteers. Our Sunday School teachers share their faith and teach God's love to our Pre-K through 6th grade students using the Spark Digital curriculum.



<u>Vacation Bible School/Splash Bash</u> — Hero Hotline was our 2023 theme. This year we had 83 kids registered for VBS — we averaged 77 students in attendance a day. To show you what a huge outreach ministry VBS is, 61% of the children attending VBS this year were from the community! Of the kids attending, 14 were our HHH Summer Camp kids, which is especially exciting!

Something new this year was the number of volunteers outnumbered the number of participants because we had so many youth helpers! We had 110 total volunteers with 44 adults and 66 youth helpers.

Your support and prayers of these church ministries is truly appreciated! May God continue to bless St. John UCC abundantly in 2024 and beyond!

# **Music Ministries**

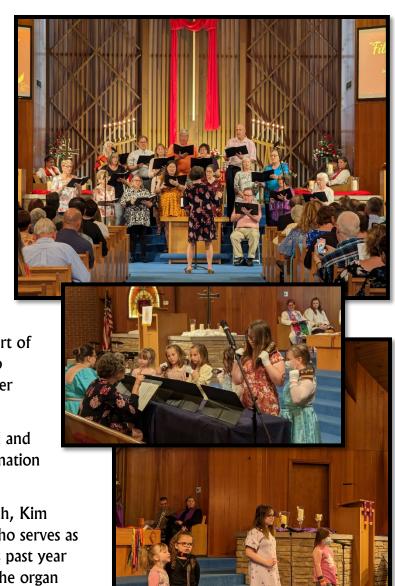
St. John UCC's Music Ministry has continued to expand in 2023. Our Bell Choir, Children's Choir

# Open and Affirming (ONA) Committee Report

In 2023 we welcomed two new members to our committee: Anne Miller and Janie McGraw. We invite other interested St. John members to join our committee.

In recognition of Neurodiversity Celebration Week in March, the O & A Committee asked the congregation to donate funds so that Sensory Boxes could be purchased. The boxes were filled with items such as noise cancelling headphones, stress relieving manipulatives and fidget toys. These boxes are located throughout the church campus; two in the Narthex, one in Faith Hall, one in Fellowship Hall and one on the top floor in the Education Building. These items can help our neurodiverse friends relax, focus, and

calm down from a scenario or an event. Items from the boxes were used a number of times for HHH Summer Camp.

In June we celebrated LGBTQ+ Pride Month by reflecting on our Open and Affirming Covenant during the June 26th service.

In September, we hosted a booth for our church at the Metro East Pride Fest in Belleville.

In October we offered two opportunities to view the documentary, 1946, The Mistranslation that Shifted Culture. This documentary is about how the translation of a very infrequently used Greek word from the original Greek text of the New Testament into English in the Revised Standard Version (RSV) of the Bible in 1946 introduced the word "homosexual" into the Bible for the first time. The documentary explains how the original translators were convinced the translation was not correct and removed the word "homosexual" in subsequent updates of the RSV, but several other translations of the Bible were based off of the RSV before the wording was revised, and those versions have not revised the text. The O & A committee continues to watch for opportunities when the documentary is again available to be viewed by those who are interested.







In November, the first event for the Rainbow Café was held. The Rainbow Café is intended to be a safe place where LGBTQ+ youth can meet. More events are being planned for 2024.

# St. John's Community Care

We can without a doubt call 2023 the Year of Change for St. John's Community Care. We currently

have 15 new employees who were hired this year, plus several that were hired and didn't work out for various reasons. 8 employees were not the right fit for the work we do, 3 long-term employees retired, and 1 took a medical leave to care for family and then returned to us. Somehow, we managed to continue the amazing care that staff have always provided to participants and caregivers. Our surveys are still being conducted but so far, out of 21 respondents, 100% of caregivers felt reduced burden, depression, and stress; felt programs met their needs; felt the quality of programs and staff was high; and would continue to use our programs. We owe these results to the commitment of the staff team who so highly value each person we serve and want to ensure the best quality of life possible for them all!



During all of this, we also managed to increase our numbers, slightly. Now that we are fully staffed and everyone feels fairly well-trained and stable, we know that these numbers will increase even more in 2024!

# Treasurer's Report

There is plenty of positive financial news to report from 2023. There are also realities that become evident when the 2023 revenues are compared to the 2023 expenses. Like every family sitting around the kitchen table discussing important decisions, the congregation will have to digest and understand 2023 in order to move forward with confidence and determination supporting the programs of the church in 2024.

The spreadsheets included in this report detail 2023 activity for the General Fund, Youth Ministries, Outreach, Fundraisers, our Capital Campaign, and our overall Balance Sheet. Highlights from the spreadsheets...

## 2023 Overall General Fund Financials

#### **General Fund Revenue**

- Envelopes totaled \$421,899. This was \$20,313 below budget and almost identical to 2022...up \$744 from 2022.
- Offerings are also given to the General Fund in the form of Special Offerings, Memorials, and Donations. These totaled \$71,284. This was \$18,367 below budget and \$40,898 less than 2022.
- This adds up to Total Offerings of \$493,183. This was \$38,679 below budget and \$40,152 less than 2022.
- Other Revenue (Reimbursements, Facility Usage, Investment Income, etc.) totaled \$99,724. This was \$12,291 better than budget and \$29,605 more than 2022. Investment Income accounted for \$17,308 of that increase.

• Total Revenue was \$592,907. This was \$26,388 below budget and \$10,548 less than 2022.

# **General Fund Expenses**

- Employee Expenses were \$414,432. This was right on budget and \$19,484 more than 2022.
- Facilities Expenses were \$163,373. This was over budget by \$17,211 and \$12,026 more than 2022.
- Church Programming Expenses were \$86,327. This was \$9,932 below budget and almost the same expenditure as 2022.
- Total Expenses (these 3 categories plus a few other detailed expenses) were \$673,088. This was over budget by \$12,396 and up \$39,481 from 2022.

• The General Fund had a Net Loss of \$80,181 in 2023. We budgeted a loss of \$41,396...we missed that mark by \$38,784. In 2022 we lost \$30,152.

## 2023 Balance Sheet

- You may notice the church has begun investing our assets. In 2023 this brought \$17,308 of income into the General Fund.
- The Capital Campaign Fund is now at zero. The Campaign paid for quite a few projects at the church over the past few years, including a few in 2023. The final \$65,545 of the fund was transferred into the General Fund at the end of 2023 to help cover our deficit.
- A transfer from the Legacy Fund into the General Fund at the end of 2023 covered the remaining \$14,636 of the General Fund deficit. The Legacy Fund started the year at \$395,202 and is now at \$380,566.
- Eileen Killinger left St. John UCC a legacy gift of \$192,764. With this gift the Eileen Killinger Fund will support Faith Hall and Faith Hall programming.
- We have Total Assets of \$676,258 at the end of 2023. This is up \$67,801 from our 2022 year-end balance of \$608,457.

# Proposed 2024 Budget

## **Budget Approach**

The 2024 budget approach is to set 2024 budgets to the 2023 actuals with a few adjustments for known changes. It does not provide for any inflationary increases unless otherwise noted.

The budget provides for search committee expenses and for visiting pastor to provide Pastor Jenn with a Sunday off every month while we look for Pastor Katie Jo's replacement. It does not contain any provision for her replacement. When the Council has determined the path forward for her replacement it will come back to the congregation for formal budget approval for replacement. The path forward and the approved budget will provide the search committee with the parameters to perform their search.

#### Overview

The 2024 budget is for revenues of \$593K and expenses of \$611K resulting in a operating deficit of \$18K.

#### Receipts

The proposed 2024 budget reflects General Fund receipts for 2024 in the amount of \$593,030 is essentially flat over our 2023 actual receipts.

## Changes from 2023

- \$4,219 (1%) increase in envelopes
- \$1,759 increase in insurance reimbursement
- \$4,000 decrease in Investment income due to lower asset base
- \$2,000 increase in donations for Pastor Katie Jo farewell party
- \$3,856 decrease in transfers from other funds

## **Expenses**

We are proposing General Fund expenditures of \$611,488, a decrease of \$61,601 over our 2023 actual expenditures.

#### Changes from 2023

- \$5,260 increase in salary & benefits for a 2% salary increase effective 2-2-2024
- \$70,602 decrease in salary & benefits due to Pastor Katie Jo leaving on 3-4-24
- \$3,664 decrease in Workers Comp Insurance
- \$5,619 increase in property insurance
- \$2,000 for Pastor Katie Jo farewell party
- \$2,000 for Associate Pastor replacement search
- \$1,500 for visiting pastor services
- \$5,368 reduction in other expenses

# St. John United Church of Christ, Collinsville, IL Minutes of the Annual Congregational Meeting – January 29, 2023 Hybrid Meeting – Held in Person and Virtually by Zoom.

The annual congregational meeting of St. John United Church of Christ was held on Sunday, January 29, 2023. Council President Dena Bieser called the meeting to order at 10:48AM.

Pastor Katie Jo Bielke, Associate Pastor, gave the opening prayer.

A quorum was confirmed with 68 members present and 6 having signed onto the Zoom meeting for a total of 74. (Joy Honegger oversaw the Zoom session.

Approval of Minutes of the 2022 Congregational Meetings: The 2022 Congregational meetings include the Jan. 30, 2022 Annual Congregational Meeting and Aug. 21, 2022 Special Meeting:

**Motion** to approve all minutes as presented (in the annual report) made by Becky McNeil and seconded by Kim Wimmerstedt.

As there was no discussion, all minutes were approved by consensus.

#### **Treasurer's Report for 2022:** Jon Hester, Treasurer

Jon presented the 2022 Financial reports (which were also in the Annual Report) by PowerPoint presentation and highlighted the following:

- 2022 total receipts were \$31,000 over budget, expenses were \$12,000 over budget, resulting in expenses exceeding receipts by \$30,000 for the year (\$19,000 under budget.)
- Envelopes/ Donations were \$15,00 under budget, Memorials over budget by \$33,000, Events receipts \$16,000 over budget
- Employee expenses were \$14,000 under budget due mainly to not filling the Mosaic Music leader position
- Facilities expenses were \$17,000 over budget mainly due to increase in cost of utilities.
- Utilities and property insurance were over budget and maintenance costs were under budget.
- Church Program and Other Expenses were \$9,000 over mainly due to a new ice machine in Fellowship Hall and resuming the normal HHH program
- Transfer of \$30,000 was made from the Capital campaign Fund to bring general fund to a zero balance:
- Currently, the total of Church Funds is \$609,000.
  - The \$395,000 in Legacy Fund includes Government Covid relief program receipts of \$93,000.

There were no questions on Jon's presentation. **Motion to** approve is the Treasurer's report made by Tammy Craig, seconded by Becky McNeil. **Report passed by consensus.** 

#### **New Business:**

- a. Approval/Elections:
  - i. Church Council The nominees for church council are two new members (each for a three-year term): Nancy Berry and Abe F. Cyrus III
  - ii. Cemetery Board Ray Ferrero and Stacy Lanier are going off the Board and the nominees for the Board are Joe Basuel, Mark Doty, and Dave Lanier. (Dave Lanier will fill the unexpired term of Scott Pursell.)

iii. Youth Ministries –The nominees for Youth Ministries are Ryan Cason, Andrea Molkenbur, Leslie Musallam.

iv. – 2023 Delegates to Illinois South Conference – No members nominated at this time.

**Motion** to approve all nominees for the Council and each board made by Stu Craig seconded by Karen Taake, nominees approved by consensus.

#### b. Proposed 2023 Budget:

Jon Hester, Head Deacon, presented the 2023 budget. Jon explained that the budget is based on 2022 actuals with adjustments and 4% salary increases.

Jon highlighted some items that were in the Power Point presentation.

On the receipts side:

- \$21K (5%) increase in envelopes.
- Reduction in Memorials of \$15K (due to large memorial in 2022)
- Other Donations reduced by \$6.8K
- Reimbursements increased due to increased 2023 rates.
- Events receipts increased \$5K due to Youth Mission trip fundraisers.
- All other receipts budgeted at 2022 actuals.

On the expense side (Total increase of budgeted expenses of \$31K)

- Increase in salary/benefits of \$2.9K for Music director for full year.
- 4% increase in salaries effective February 1 (\$12.2K)
- Health insurance premiums increase by \$3K.
- Phone increase of \$0.5K due to internet
- Property Insurance increase of \$3K
- Furniture & equipment increase of \$5K.
- Mission trip increase of \$5K in events

## Decreases in Budget of \$10K include

- Electric reduced by \$5.5K
- Maintenance reduced by \$3. K
- Reduced expenses of \$1.6K (conference meeting expense in 2022)
- Outreach donation increase offset by decrease in Food Pantry egg donation.

Jon presented the budgets for the following areas: worship, administration, facilities, music, outreach, youth ministries and special events.

Overall, the 2023 budget shows an increase in receipts over 2022 (\$16.7 K) and an increase in expenses over 2022 (\$27.8 K) resulting in Budgeted operating deficit of \$40.3 K.

**Motion** to approve 2023 Budget made by Becky McNeil, second by Lindsay Janssen Discussion / Questions: None. **Motion** passed.

## Proposed additional spending:

Trustees are currently getting bids for repairs to kitchen sink in Fellowship Hall and installation of grease trap. Current bids range in price from \$14.8K to \$34,500 (due to amount of work required). Trustees are waiting on third quote. This expense is to be paid out of capital funds.

Proposing to spend up to \$25K from the Legacy Fund to resolve an outstanding \$37K water bill that occurred after the addition of Faith Hall (extra/new water meter had not been read). This bill is to be paid by Covid relief funds.

Discussion/Questions included:

- Was there interest charged? No, interest was not charged.
- Can we legally use the Covid Relief funds for this purpose? This has been researched and we can use those funds for this.

**Motion** to approve spending up to \$34.5K out of Capital Campaign fund for kitchen repairs and up to \$25K out of Legacy Fund for the water bill. **Motion** made by Becky McNeil, seconded by Tammy Craig, **Motion Passed**.

## c. Proposed 2023 Cemetery Budget:

Jim Wimmerstedt, Cemetery Board Treasurer, presented a 2022 overview and the 2023 proposed budget.

Jim thanked the outgoing board members – Ray Ferrero and Stacey Lanier and noted that Peter Coppens is beginning his 6<sup>th</sup> year as superintendent. New flags have been purchased and will be displayed on Memorial Day.

Jim stated the budgeted income was derived using a 3 year average of sales of services and also included a 4 - 5% increase in fees effective in March, 2023. Budgeted expenses included a salary increase up to 6% (due in part to minimum wage laws) and a stipend to Peter for his personal expense for health insurance.

**Motion** to approve the 2023 Cemetery Budget as presented made by Pam Gasser, seconded by Bill Berry, **Motion carried** unanimously.

## d. Cemetery Resolution for purchase of Commercial Lawnmower

Jim Wimmerstedt presented the boards' resolution to replace an unreliable mower (which is out of warranty) and use it as a trade-in for a new mower. The board has gotten 3 bids and the net price of an amount under \$15,000 would be paid out of existing funds.

**Motion** to approve resolution for new lawn mower made by Mary Jane Soelke and seconded by Becky McNeil, **Motion** carried.

# e. Cemetery Resolution for purchase of Replacement Roadway (\$100K-\$125K from perpetual care fund)

Jim Wimmerstedt presented the background for road repair in the cemetery. St. John Cemetery has 4.8 miles of road which are in fair to poor condition. The board has a plan to begin to repair the roads in sections. They have consulted with engineers and gotten bids on repairing a 475 section (.8 mile of road). The estimated cost for concrete road and curbing of this section is \$100,000 to \$125,000 and would be paid for out of the perpetual care fund.

**Motion** to approve resolution for purchase of replacement roadway made by Debi Ralston and seconded by Bart Bieser. Vote taken, **Motion** carried.

## Staff/Council/Committee/Organization Reports:

#### a. Pastors' reports –

**Pastor Jenn**- (Report is in the annual report.)

Pastor Jenn said if she were to summarize her report, it would be "community engagement."

She stated that she yearns to be a presence in the community, and she feels our efforts are clearly working because community members know about our church. She has adopted the "why not" attitude.

## **Pastor Katie Jo** (Report is also in the annual report.)

Pastor Katie Jo stated that her goal is to make sure we are extending a welcome invitation, so all feel comfortable and all feel valued.

Examples of ways we have done this include members welcoming people and telling them where to go for a meeting, and offering candy at the fall festival that was free of allergies.

## b. President's Update

Dena Bieser said her report is included in the annual report.

Dena added that repair of the kitchen sink in Fellowship Hall is our current project.

## St. John UCC Special Meeting – Sunday, May 21, 2023

The meeting was called to order by President Ginger Schantz in the sanctuary at 10:30 am. A quorum was confirmed to be present.

The motion to purchase new projectors for the sanctuary was made by Stu Craig and seconded by Karen Take. Matt Swinford presented the following information to supplement the motion.

- The current projectors are many years past their projected useful life.
- When one of the original projectors failed, a used one was found in Indiana.
- The audio-visual team (Matt Swinford, Kurt Schuette, and Mark Waltermire) got three quotes for new projectors. They rejected the lowest bid as they were not comfortable with that company.
- The recommended bid of \$22,684 from Schiller, a local business founded in 1892, includes installation, custom lenses, 3-year warranty, and additional features.

The motion was approved with 53 yes votes, including 2 on Zoom. There were no votes in opposition and no abstentions.

The Cemetery Board requested congregation approval of up to \$150,000 to replace a portion of the cemetery roads with concrete. (The congregation had previously approved up to \$125,000.) The motion was made by Clyde Donovan and seconded by Becky McNeil.

Matt Swinford explained that bids exceed \$125,000. The funds will come from the cemetery's Perpetual Care Fund, which has a balance of more than \$1.3 million. The remaining roads will also need to be upgraded but the Cemetery Board plans to wait until this project is complete.

The motion was approved with 56 votes. There were no votes in opposition and no abstentions.

The meeting was adjourned by President Schantz at 10:42 am.
