Pocono Township Board of Commissioners Regular Meeting Minutes March 25, 2025 | 6:00 p.m.

The regular meeting of the Pocono Township Board of Commissioners was held on March 25, 2025 and was opened by Chair Richard Wielebinski at 6:20 p.m. followed by the Pledge of Allegiance.
