RESOLUTION NO. 2022-18

A RESOLUTION GRANTING CONDITIONAL APPROVAL OF THE 3101 ROUTE 0611, JOE RONCO SITE PLAN

WHEREAS, the applicant, Joe Ronco, submitted a plan application for a site plan for the property located at 3101 Route 611 (the "Plan"). The Plan proposes to create three leasable office units in the existing building. The property is located in the C Commercial Zoning District. and is identified as Monroe County Tax Parcel I.D. 12.9.1.13, PIN Number 12-6372-00-61-5810; and

WHEREAS, the Township Engineer has reviewed the Plan and offered comments in his letters dated March 23, 2022 and April 7, 2022; and

WHEREAS, the Pocono Township Planning Commission recommended conditional site plan approval of the Plan at a meeting held on April 11, 2022; and

WHEREAS, the Pocono Township Board of Commissioners desires to take action on this Plan.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Commissioners of Pocono Township, County of Monroe, and Commonwealth of Pennsylvania:

That the Plan as prepared by Nik Nikolov, Architect dated March 1, 2022, as revised, be hereby approved with the following conditions and provided the plan is revised as follows, subject to the review and approval of the Township Engineer and/or Township Solicitor:

- 1. The applicant shall comply with all of the conditions and requirements identified in the Township Engineer's letter dated April 7, 2022.
- 2. The Applicant shall pay all necessary fees associated with the Plan, including any outstanding plan account charges and all professional services fees, prior to the recording of the Plan.
- 3. The applicant shall obtain all required permits and approvals from other governmental and regulatory agencies prior to presenting the Plan for signatures.
- 4. The applicant shall provide the requisite number of plans which are signed and notarized by the owner and sealed by the engineer.
- 5. The applicant shall meet all conditions of the site plan approval, and Plan shall be recorded within twelve (12) months of Conditional Plan approval, and agrees that if such conditions are not met, the Conditional Plan approval will be considered void.
- 6. The applicant shall accept these conditions in writing within five (5) days of receipt of the Board of Commissioners Resolution, otherwise the application is denied.

Pocono Township Board of Commissioners Regular Meeting Minutes April 4, 2022 | 6:29 p.m.

The regular meeting of the Pocono Township Board of Commissioners was held on April 4, 2022 and was opened by President Rich Wielebinski at 6:18 p.m. followed by the Pledge of Allegiance.

Roll Call: Jerrod Belvin, present; Ellen Gnandt, present; Jerry Lastowski, present; Keith Meeker, present; and Rich Wielebinski, present.

<u>In Attendance</u>: Leo DeVito, Township Solicitor; Jon Tresslar, Township Engineer; Taylor Muñoz, Township Manager; R. Sargent, Roadmaster; Shawn Goucher, Acting Chief of Police; and Krisann MacDougall, Assistant Secretary.

Public Comment

Janet Ferraro (3350 Mountain View Drive) – Cobble Creek East having issues with water runoff. Township did perform drainage work last year, but still significant runoff crossing road and impacting neighboring properties down toward Sullivan Trail. Asked whether the Township has any work planned to assist. R. Sargent will reach out to Ms. Ferraro.

Vincent Trapasso (3329 Mountain View Drive) – Attested to drainage issues that are happening within the development and stated it has been getting worse.

Announcements

- The Board of Commissioners held an executive session on Friday, March 25, 2022 at 4:00 p.m. for the purpose of discussing personnel matters.

L. DeVito stated the Township has been working on a revised Act 537 Plan and a public hearing is required as part of the plan adoption to receive any public comment if given. All in favor. Motion carried.

Vincent Trapasso (3329 Mountain View Drive) stated he owns 60 acres on Sullivan Trail across from The Loft. Offered any assistance available to help bring the lines up Sullivan Trail.

R. Wielebinski made a motion, seconded by J. Lastowski, to close the public hearing. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Lastowski, to adopt Resolution 2022-12 for the Adoption and Submission of a Revision to the Township's Official Sewage Facilities Plan to the Department of Environmental Protection for approval. All in favor. Motion carried.

Presentations

Presentation of Trauma Bags to the Pocono Township Police Department – James & Beth Moloughney (222 Owl Hollow Drive, Tannersville) shared that their State Farm agency is very supportive of the Police Department. They donated eleven trauma bags for each patrol car. Stated they hope is that the officers never have to use them, but that they want the bags to be available should there be a need.

R. Wielebinski made a motion, seconded by J. Lastowski, to pass Resolution 2022-14 Approving the Expenditure of \$62,236.00 for a 2022 Ford F-550 Utility Truck with Plow and Authorizing the Execution of a Lease Purchase Agreement with Bank Capital Services LLC, D/B/A F.N.B. Equipment Finance. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by K. Meeker, to pass Resolution 2022-15 Granting an Extension of Time to Satisfy Conditions of the Plan Approval of the Poconos Hospitality Land Development Plan. Dan Wise, the applicant's engineer, gave update on the project. E. Gnandt asked whether the extension request is affected by the new ownership entity that was established. J. Lastowski asked whether there are enough trees to buffer the adjoining residential properties. E. Gnandt asked whether a precedent is being set by approving a project that was allowed to lapse. J. Belvin asked if the current property is for sale. R. Wielebinski asked when construction was to start. Applicant stated work will begin this year. Roll call: J. Belvin, yes; E. Gnandt, no; J. Lastowski, yes; K. Meeker, yes; R. Wielebinski, yes. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to pass Resolution 2022-16 Granting Conditional Approval of the Steele's Warehouse Addition Preliminary/Final Land Development Plan. Lori Foglio, applicant's engineer, presented on the plan. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to pass Resolution 2022-17 Approving a Cooperative Memorandum of Agreement with Stroud Township Concerning SR 611 (Route 611) Multi-Jurisdictional Adaptive Signal System and Authorizing the Execution and Delivery Thereof. E. Gnandt asked if this is the grant that has been around since 2017. T. Muñoz and L. DeVito provided further information regarding the agreement. E. Gnandt asked for further clarification. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by K. Meeker, to purchase a new sliding board for Mountain View Park for an amount not to exceed \$25,000. E. Gnandt asked about installation, fees, safety and warranty. J. Lastowski asked about pricing and safety. All in favor. Motion carried.

Discussion with Jim & Margie Becker, Township residents, regarding use of Mountain View Park by the Porsche Club of America. Discussed a rally event competition being held around the Poconos and requested to have a location stop-off at Mountain View Park. The club would use a portion of the parking lots near Pavilions 2 and 3 on Thursday, June 16th from approximately 8:30 a.m. to 2 p.m. Stated there would only be a couple cars in the park at a time and they would abide by all speed limits and regulations. Under public comment, Charlie Trapasso reiterated the need for safety.

R. Wielebinski made a motion, seconded by J. Lastowski, to allow the Porsche Club of America to hold their "gimmick rally" at Mountain View Park Thursday, June 16, 2022 conditioned on a certificate of liability insurance being provided to the Township. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to approve a temporary sewage tank agreement between Pocono Township and Joe Ronco, owner of 3101 State Route 611, allowing for use of a sewage storage tank until such time as a sewer lateral is provided for connection to the public sewer system. R. Wielebinski stated this is the property along Route 611 that will be served by public sewer. E. Gnandt asked how the holding tank functions. R. Wielebinski gave description of the process of how the tank operates. E. Gnandt asked if the Township needs any protections to allow the tank to be used. All in favor. Motion carried.

 Discussion and possible action regarding the request of Shaare Torah School, located in Brooklyn, to allow three school buses of students at Mountain View Park on May 24th – No action or approval given.

As requested and as a follow up to our recent meeting, I am writing to document anticipated fees to address three stormwater project areas in the Township.

- 1. Laurel Lake Road Based on walking this site previously, we believe roadside swale and pipe improvements are needed all along Laurel Lake Road, beginning at the Lake and traversing northerly to a point past Marilou Lane. Also, there is a need for swale improvements between the dam embankment and Laurel Lake Road southerly to JoJo Road. The pipe transporting the discharge beneath Laurel Lake Road needs to be sized and replaced and improvements are required to prevent deposition of sediment where stormwater presently crosses Laurel Lake Road approximately 250 feet northerly of the dam discharge pipe. The design analysis for swale and pipe improvements under intersecting roads and driveways along Laurel Lake Road will require survey of road centerline and cross-sections at 50 foot intervals. Upon completion of the field survey and plotting of the information, roadside drainage swales can be sized along with the cross-pipes. A plan will be prepared for Bob Sargent to utilize in constructing roads and or placing/replacing pipes. We anticipate a fee of \$20,000 will be required to complete our work. If a permit is required for the pipe conveying the discharge from Laurel Lake Dam, and additional \$5,000 fee is anticipated.
- 2. Birchwood, Fernwood, Woodland Roads Bob Sargent believes he can solve the majority of the problems in this development by building enlarged rip-rap swales and upgrading cross pipes where necessary. It was decided B&J would develop an overall site plan utilizing LIDAR information for Bob to markup showing his proposed improvements. It is recommended that where Bob proposes to replace and/or install driveway pipes that B&J perform drainage calculations to insure that the pipes are adequately sized prior to construction. Once construction is complete, B&J will prepare a final plan documenting the proposed improvements for record keeping. The cost of the initial plan utilizing Lidar is estimated to be \$2,000. A budgetary fee for site visits and pipe sizing is estimated to be \$5,000. A final plan documenting improvements is estimated to be \$3,000.
- 3. Learn Road Drainage problems along Learn Road are attributed in part to the fact there are no clear drainage channels leading from stormwater infrastructure in Learn Road westerly to the Pocono Creek. While swales and drainage ditches exist, they are obstructed and in need of cleaning. Responsibilities for maintenance are unclear and the existence of easements is unclear. A first step to address these issues would be to prepare a topographic plan from LIDAR information and identify drainageways from facilities in Learn Road to the Pocono Creek. The next steps would involve determining if any easements exist along those areas by searching information of record, and determining recommended improvements to facilitate overall drainage patterns. A budgetary number to prepare the initial plan, field identify drainage swales and/or pipes and prepare a report recommending acquisition of easements and improvements to conveyance facilities is estimated to be in the order of \$15,000.
