POCONO TOWNSHIP MONROE COUNTY, PENNSYLVANIA

ORDINANCE NO. 2020- OL

AN ORDINANCE OF THE TOWNSHIP OF POCONO, MONROE COUNTY, COMMONWEALTH OF PENNSYLVANIA, PROVIDING FOR THE RENAMING OF STREETS KNOWN AS "TO FISH HILL ROAD" TO "ELENI'S WAY", "PIGEON WAY" TO "LEARN ROAD" AND A PORTION OF "LEARN ROAD" TO "FISH HILL ROAD" IN POCONO TOWNSHIP; PROVIDING FOR THE PLACEMENT OF STREET SIGNS; AND PROVIDING FOR THE AMENDMENT OF THE OFFICIAL TOWNSHIP STREET MAP.

WHEREAS, the Board of Commissioners of Pocono Township deems that the renaming of the streets known as "To Fish Hill Road" to "Eleni's Way", "Pigeon Way" to "Learn Road", and a portion of "Learn Road" to "Fish Hill Road" is in the best interests of Pocono Township, Monroe County, Pennsylvania.

NOW THEREFORE BE IT ENACTED AND ORDAINED, by the Board of Commissioners of Pocono Township, Monroe County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by virtue of the activity of the General Assembly of the Commonwealth of Pennsylvania known as the "First Class Township Code, as amended", as follows:

SECTION 1. PURPOSE

The purpose of this Ordinance is to rename certain streets in Pocono Township known as "To Fish Hill Road" to "Eleni's Way", "Pigeon Way" to "Learn Road" and a portion of "Learn Road", from its intersection with "Pigeon Way" west to its intersection with "To Fish Hill Road", to "Fish Hill Road".

SECTION 2. FINDINGS OF FACT

The Board of Commissioners of Pocono Township finds that the said street renaming will not be detrimental to or endanger the public health, safety, or welfare of the residents of Pocono Township.

SECTION 3. AMENDMENT OF OFFICIAL TOWNSHIP STREET MAP

The official Township Street Map and all other official Township maps shall hereby be amended to reflect the renaming of the streets known as "To Fish Hill Road (T-537)" to "Eleni's Way (T-537)", "Pigeon Way (T-624)" to "Learn Road (T-624)", and a portion of "Learn Road (T-624)", from its intersection with "Pigeon Way" west to its intersection with "To Fish Hill Road", to "Fish Hill Road (T-537)".

SECTION 4. ERECTION OF SIGNS

The Board of Commissioners of Pocono Township hereby authorizes the erection of street signs to reflect the change of the street names to "Eleni's Way", "Learn Road" and "Fish Hill Road".

SECTION 5. REPEALER

All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed upon the effective date of this Ordinance.

SECTION 6. SEVERABILITY

SECTION 7.

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance.

ORDINANCE NO. 2020-02

AN ORDINANCE OF THE TOWNSHIP OF POCONO, COUNTY OF MONROE, COMMONWEALTH OF PENNSYLVANIA AMENDING THE CODE OF ORDINANCES OF POCONO TOWNSHIP, CHAPTER 425, VEHICLES AND TRAFFIC, ARTICLE I, SPEED LIMITS, ESTABLISHING MAXIMUM SPEED LIMITS FOR MOTOR VEHICLES ON BOG ROAD AND BACK MOUNTAIN ROAD IN POCONO TOWNSHIP, AND FOR THE POSTING OF SPEED LIMIT SIGNS; ADDING A NEW ARTICLE IV, TRAFFIC REGULATIONS, RESTRICTING TRUCK TRAFFIC ON BOG ROAD AND LEARN ROAD, AND ADDING STOP INTERSECTIONS; AND PROVIDING FOR PENALTIES; AND REPEALING ALL ORDINANCES INCONSISTENT HEREWITH

WHEREAS, 75 Pa. C.S. §3362 and §3363 of the Pennsylvania Motor Vehicle Code authorizes Pennsylvania municipalities to set a maximum speed limit on certain locally-owned roads; and

WHEREAS, the Board of Commissioners of Pocono Township, after review of engineering and traffic studies, deems it to be in the best interests, and for the general welfare of the citizens of Pocono Township, to establish maximum speed limits for vehicles traveling on certain Township roads; and

WHEREAS, engineering and traffic studies have determined that truck restrictions are warranted on Bog Road and Learn Road; and

WHEREAS, the Board of Commissioners of Pocono Township desires to adopt traffic regulations to prohibit trucks on certain Township roads; and

WHEREAS, the Board of Commissioners of Pocono Township has determined that it would be in the best interest of the Township of Pocono to amend its Ordinance to include stop intersections.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Commissioners of Pocono Township, Monroe County, Pennsylvania and it is hereby **ENACTED AND ORDAINED** by virtue of the power vested in the Board of Commissioners by the First Class Township Code, as amended, and the Pennsylvania Motor Vehicle Code, as follows:

SECTION 1. Chapter 425, Vehicles and Traffic, Article I, Speed Limits, §425-1, Maximum Speed Limits, is hereby amended by the addition of Subsections (D) and (E), which shall read as follows:

"(D) Bog Road shall have a maximum speed limit of twenty-five (25) mph for its entire length.

- (E) Back Mountain Road shall have a maximum speed limit of thirty-five (35) mph for its entire length."
- **SECTION 2.** Chapter 425, Vehicles and Traffic, Article I, Speed Limits is hereby amended by the addition of §425-2.1, which shall read as follows:
- "§425-2.1. Posting of Speed Limit Signs. The Township shall post all roads identified in this Article I with official traffic control devices (speed limit signs) erected in accordance with the Pennsylvania Motor Vehicle Code, 75 Pa. C.S. §3362 and the regulations of the Pennsylvania Department of Transportation."
- SECTION 3. Chapter 425, Vehicles and Traffic, is hereby amended by the addition of Article IV, Traffic Regulations, §425-11, Truck Traffic Restricted on Certain Roads, which shall read as follows:

"ARTICLE IV. Traffic Regulations.

§425-11. Truck Traffic Restricted on Certain Roads.

- A. It shall be unlawful for any person to drive a vehicle other than a passenger vehicle, motorcycle, or other vehicle intended primarily for the transportation of passengers on any of the following roads, provided nothing in this section shall prohibit a person from driving an emergency vehicle on any of those roads or parts of roads, or from driving on any of those roads or parts of roads a truck or other commercial vehicle making deliveries to or pickups from premises located along that road or part of a road:
 - (1) Bog Road for its entire length;
 - (2) Learn Road for its entire length.
- B. The Board of Commissioners of Pocono Township shall cause official traffic signs to be erected along the roads identified in §425-11(A) of this Article in such locations and of such type, size and number as required by the Pennsylvania Department of Transportation, or as otherwise deemed necessary for the health, safety, and welfare of the traveling public.
- C. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25, plus costs of prosecution."
- **SECTION 4.** Chapter 425, Vehicles and Traffic, is hereby amended by the addition of Article IV, Traffic Regulations, §425-12, Stop Intersections, which shall read as follows:

"§425-12. Stop Intersections.

A. The following intersections are established as stop intersections and official stop signs shall be erected in such a position as to face traffic approaching the stop street in the direction

or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the stop street, in the directions indicated in each case, shall stop the vehicle as required by Section 3323(b) of the Pennsylvania Motor Vehicle Code, and shall not proceed into or across the intersecting or through street until they have followed all applicable requirements of that section of the law:

Stop Street Intersection or Through Street Stop Sign Location

Bartonsville Avenue Beehler Road Southbound

B. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25, plus costs of prosecution."

SECTION 5. REPEALER

All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed upon the effective date of this Ordinance.

SECTION 6. SEVERABILITY

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance.

SECTION 7. EFFECTIVE DATE

This Ordinance shall take effect five (5) days after the date of its enactment.

ORDINANCE NO. 2020 - <u>03</u>

AN ORDINANCE OF THE TOWNSHIP OF POCONO, MONROE COUNTY, COMMONWEALTH OF PENNSYLVANIA AMENDING THE CODE OF ORDINANCES OF POCONO TOWNSHIP, CHAPTER 37, PLANNING COMMISSION, TO REVISE THE NUMBER OF MEMBERS APPOINTED TO THE PLANNING COMMISSION AND REPEALING ALL ORDINANCES INCONSISTENT THEREWITH

WHEREAS, the Board of Commissioners of Pocono Township, Monroe County, Pennsylvania, under the powers vested in them by the "First Class Township Code" of Pennsylvania, as well as the laws of the Commonwealth of Pennsylvania, do enact and hereby ordain the following amendment to the Code of Ordinances of Pocono Township; and

WHEREAS, the Board of Commissioners has deemed it necessary to amend the Code of Ordinances of Pocono Township, Chapter 37, Planning Commission, to revise the number of members appointed to the Planning Commission.

NOW, THEREFORE, be it amended and ordained by the Board of Commissioners of Pocono Township, Monroe County, Pennsylvania and the same is hereby ordained and enacted, to wit:

SECTION 1. Sections 37-1, 37-2 and 37-3 of Chapter 37 of the Code of Ordinances of Pocono Township are hereby deleted and replaced as follows:

"§37-1. Title.

This Chapter shall be known as the "Township Planning Commission Ordinance."

§37-2. Establishment; membership; terms.

- A. A Township Planning Commission is hereby created and established for Pocono Township, Monroe County, Pennsylvania, pursuant to the provisions of 53 P.S. §10201 of the Municipalities Planning Code.
- B. The Planning Commission shall be comprised of seven members who shall be appointed for terms of office of four years, to be established on a series of overlapping terms with one or two terms expiring each year. The Planning Commission shall also include two alternate members that shall participate and vote in the absence of a quorum of the initial seven members. The two alternates shall be appointed to terms of office of four years, provided however that at the time of the initial appointment of the alternate members, one member shall be appointed for a term of two years in order to create overlapping terms.

§37-3. Intent.

The intent of the legislature in passing the Pennsylvania Municipalities Planning Code, Act 247 of 1968 (53 P.S. §10101 et seq.), as amended, is hereby adopted as the intent of the Commissioners. All the authority, powers, duties, rights, responsibility and liability authorized, reposed and vested in a planning commission by said Act are hereby authorized, reposed and vested in the Planning Commission of Pocono Township. All the authority, powers, duties and rights retained by the Board of Commissioners in said Act are hereby retained."

SECTION 2. REPEALER

All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed upon the effective date of this Ordinance.

SECTION 3. SEVERABILITY

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance.

SECTION 4. EFFECTIVE DATE

This Ordinance shall become effective five (5) days after enactment.

The regular meeting of the Pocono Township Commissioners was held remotely on Monday, May 4, 2020 via video and teleconference, and was opened by President Rich Wielebinski at 7:00 p.m. followed by the Pledge of Allegiance.

ROLL CALL: Jerrod Belvin, present; Ellen Gnandt, present; Jerry Lastowski, present; Keith Meeker, present; Rich Wielebinski, present.

IN ATTENDANCE

PUBLIC COMMENT

- Steve Leventhal (3245 Birch Hill Drive, Tannersville) Expressed concerns regarding short term rentals. Concerned with 3262 Birch Hill Dr. in Cobble Creek Estates and stated they exceed the single-family occupancy of 12 occupants.
- Wayne Mazur (3315 Birch Hill Drive, Tannersville) Thanked the Township Road crew for taking care of Cobble Creek Estates, including paving, fixing shoulders, installing drainage pipes and sweeping roads. He expressed appreciation for the Commissioners' work.
- Juliana Farrel (314 Bog Road) Asked the status of the ordinance for Bog Road. Stated traffic is an issue, including tractor trailers and speeding traffic. Chairman Wielebinski explained that, due to COVID-19, the Township has been hosting virtual meetings and had delayed the ordinance hearings.
- Chris Ortolan (16 Tara Dr., Stroudsburg) Inquired as to whether COVID-19 will impact the Spring Cleanup. R. Wielebinski stated this would be discussed by the Commissioners later during the meeting.

L. Devito stated the Township should post a summary of FFCRA benefits alongside the formal FFCRA notice. E. - Suggested that the Township should consider opening municipal parks, since the public can now golf and hike. L. Lastowski stated the Township should follow the Governor's orders. Board members

- Phone/written quotes were received to complete installation of well pump at Mountain View Park. Leon Clapper is the only contractor in the area with a crane capable of installing this style of well line. Provided estimate for approximately \$5,700 to do the work. R. Wielebinski clarified that all the other contractors stated they would either need to rent Clapper's equipment to do the work or have him do the work. Their bids would be more because they would have to rent the equipment from Clapper.

R. Wielebinski made a motion, seconded by K. Meeker, to approve L. Clapper to install new well pump, wiring and well line for a cost not to exceed \$6,000. At Mt View Park Roll Call Vote: Jerrod Belvin, yes; Ellen Gnandt, yes; Jerry Lastowski, yes; Keith Meeker, yes; Rich Wielebinski, yes. Motion carried.

- Further discussion regarding when contractors can begin work on Township projects. Consensus that if contractor is deemed an essential service by the state and practices safe social distancing, they should be able to move forward.
- Discussion regarding flooding issues on Archer Lane. J. Tresslar stated he, L. Devito and Shawn McGlynn, Township Zoning Officer, are working on addressing the issues. Township looking to bring action against property owner through the stormwater management ordinance and/or the newly adopted grading ordinance.

Administration - Manager's Report

No further updates.

Township Engineer Report

- Flashing light on Sullivan trail was put on hold. With Governor allowing construction projects to move forward as of May 1, J. Tresslar should be able to acquire needed information now that they are able to continue to operate.
- Meeting was held on location to address continued Alger Avenue flooding concerns. All agreed-to improvements have now been installed, including additional grading at the gate in the public works yard.
- White Oak Culvert replacement project proceeding as planned. Emergency access open, culvert removed, and anticipated delivery of box culvert this week.
- Information was requested from DEP regarding lower dam at TLC Park. No response yet.
- J. Tresslar and R. Sargent inspected drainage basin at St. Paul's Lutheran Church. Outlet structure is malfunctioning and needs to be replaced with different style system. Detention basin has adequate capacity but is not fully utilized. R. Wielebinski and J. Belvin were onsite during a severe rain event and observed detention basin was not working and water was running onto adjacent properties, ultimately flooding Learn Road.

R. Wielebinski made a motion, seconded by J. Lastowski, to contact St. Paul's Lutheran Church to correct the retention basin on Fish Hill Rd. Roll Call Vote: Jerrod Belvin, yes; Ellen Gnandt, yes; Jerry Lastowski, yes; Keith Meeker, yes; Rich Wielebinski, yes. Motion carried.

Homes below St. Paul's Lutheran Church off Fish Hill also experiencing flooding that's damaging sand mound and patio. Issues were identified with the nearby swale and stones potentially redirecting water onto property. However, L. Devito cautioned against doing any work in a private swale, as it would make the Township liable. J. Tresslar will investigate property records to identify how the swale is designated.

Township Solicitor Report

- The Township received a special exception request from Camp Lindenmere to be considered by the Zoning Hearing Board. Lindenmere exists as a nonconforming use and any expansion requires a special exception hearing before the Zoning Hearing Board. The camp can expand up to 50% of the existing nonconforming use once they demonstrate no major impacts. L. Devito stated he does not need to attend the hearing unless the Commissioners have specific concerns. J. Lastowski stated he would like to first understand whether there is any impact on surrounding neighborhoods before discussing whether L. Devito should attend the hearing.
- Stated the Johnson Appeal zoning hearing is still in the process of being rescheduled. Due to high level of public interest and many documents involved, this hearing cannot be held virtually.

DECLARATION OF DISASTER EMERGENCY

WHEREAS, on or about March 1, 2020 the COVID-19 (Coronavirus) outbreak began to spread through the Commonwealth of PA and in March 2020 the first confirmed case was announced in Monroe County. This pandemic outbreak threatens to cause injury – both physical & mental, damage – financial and societal, and long suffering to the persons and property of Pocono Township – Monroe County; and

WHEREAS, the COVID-19 (Coronavirus) outbreak has endangered the health, safety and welfare of some, if not all, persons residing in and visiting Pocono Township, and threatens to create problems greater in scope than Pocono Township may be able to resolve on its own; and

WHEREAS, emergency management measures are required to reduce the severity of this public health disaster and to protect the health, safety and welfare of all affected residents in Pocono Township;

NOW, THEREFORE, I, the undersigned President of the Board of Commissioners of Pocono Township pursuant to the provisions of Section 7501 of the Pennsylvania Emergency Management Services Code, (35 PA C.S., Section 7501), as amended, do hereby declare the existence of a disaster emergency in Pocono Township.

FURTHER, I direct the Pocono Township Emergency Management Coordinator to coordinate the activities of the emergency response, to take all appropriate action needed to alleviate the effects of this disaster, to aid in maintaining essential public services, and to take any other emergency response action deemed necessary to respond to this emergency.

STILL FURTHER, I authorize officials of Pocono Township to act as necessary to meet the current exigencies of this emergency, namely: by the employment of temporary workers, by the rental of equipment, by the purchase of supplies and materials, and by entering into such contracts and agreements for the performance of public works as may be required to meet the emergency, all without regard to those time-consuming procedures and formalities normally prescribed by law, mandatory constitutional requirements excepted.

Your concerns were forwarded to me from Commissioner Gerald Lastowski. We are aware of the issue with this property and have already started an enforcement action against the property owner for the non-permitted use as a short term rental. I will visit the property tomorrow to assess the issue with garbage. You may, if you'd like, email photos of the property for the file. I can then take further action on the issue of litter.

The Governor's order banning short term rentals is still in effect. It does not, however, fall under the township's jurisdiction for enforcement. If you see that the property is used again, please feel free to contact the State Police or submit your concerns to PA Department of Health here: https://expressforms.pa.gov/apps/pa/doh/COVID-19-Complaint
