A RESOLUTION GRANTING CONDITIONAL APPROVAL OF THE MINOR SUBDIVISION AND LOT CONSOLIDATION PLAN OF THE ESTATE OF CHARLES L. VASSALLO

WHEREAS, the applicant, the Estate of Charles L. Vassallo, submitted a minor subdivision and lot consolidation plan application titled "Minor Subdivision Plan for the Estate of Charles L. Vassallo" (the "Plan"); and

WHEREAS, the Township Engineer has reviewed the Plan and offered comments in his letters dated November 8, 2021, February 23, 2022 and March 23, 2022; and

WHEREAS, the Pocono Township Planning Commission recommended conditional approval of the Plan at a meeting held on April 11, 2022; and

WHEREAS, the Pocono Township Board of Commissioners desire to grant the conditional approval of the Plan, subject to the following.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Commissioners of Pocono Township, County of Monroe, and Commonwealth of Pennsylvania:

That the "Minor Subdivision Plan for the Estate of Charles L. Vassallo" as shown on the plan prepared by Brian D. Courtright, P.L.S., dated April 7, 2021, as revised, be hereby approved with the following conditions and provided the plan is revised as follows, subject to the review and approval of the Township Engineer and/or Township Solicitor:

- 1. The applicant shall comply with all of the conditions and requirements identified in the Township Engineer's letters dated November 8, 2021, February 23, 2022 and March 23, 2022.
- 2. The applicant shall provide the Township with a copy of the proposed deed of merger, which deed shall be recorded concurrently with the Plan.
- 3. The applicant shall pay all necessary fees associated with the Plan, including but not limited to any outstanding plan account charges and all professional services fees, prior to the recording of the Plan.
- 4. The applicant shall obtain all required permits and approvals from other governmental agencies prior to presenting the Plan for signatures.
- 5. The applicant shall provide the requisite number of plans which are signed and notarized by the owner and sealed by the engineer.
- 6. The applicant shall meet all conditions of the final plan approval, and Plan shall be recorded

- within twelve (12) months of Conditional final plan approval, and agrees that if such conditions are not met, the Conditional final plan approval will be considered void.
- 7. The applicant shall accept these conditions in writing within five (5) days of receipt of the Board of Commissioners Resolution, otherwise the application is denied.

RESOLUTION NO. 2022-21

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF POCONO, MONROE COUNTY, PENNSYLVANIA APPROVING THE EXPENDITURE OF \$109,721.90 FOR TWO (2) 2022 FORD EXPLORER POLICE INTERCEPTORS AND AUTHORIZING THE EXECUTION OF A CERTAIN LEASE PURCHASE AGREEMENT WITH BANK CAPITAL SERVICES LLC, D/B/A F.N.B. EQUIPMENT FINANCE

WHEREAS, Township of Pocono (the "Lessee") is a political subdivision of the Commonwealth of Pennsylvania (the "Commonwealth") and is duly organized and existing under the laws of the Commonwealth; and

WHEREAS, pursuant to applicable law, the governing body of the Lessee (the "Board of Commissioners") is authorized to acquire, dispose of and encumber real and personal property, including, without limitation, rights and interests in property, leases and easements necessary to the functions or operations of the Lessee; and

WHEREAS, the Board of Commissioners of the Lessee has determined that it is necessary and advisable to lease the following property: two (2) 2022 Ford Explorer Interceptors (the "Leased Property"); and

WHEREAS, the Board of Commissioners of the Lessee has determined that the costs of the Leased Property to be \$109,721.90; and

WHEREAS, the Lessee desires to enter into a tax- exempt Lease Purchase Agreement (the "Lease Agreement") with Bank Capital Services LLC, d/b/a F.N.B. Equipment Finance, as lessor (the "Lessor") to finance the costs of the Leased Property.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners as follows:

- 1. <u>The Leased Property</u>. The Lessee hereby authorizes and approves the acquisition of the Leased Property and does hereby ratify and confirm all action heretofore taken by officers and officials of the Lessee and others pursuant to direction of the Lessee in proceeding with the acquisition of the Leased Property. The Lessee shall proceed with the acquisition of the Leased Property and the necessary financing to fund the Leased Property and related costs and expenses.
- 2. <u>Authorization and Approval of the Lease Agreement</u>. The Lease Agreement, hereafter, including in such defined term all related documents therewith, each document substantially in the form presented at this meeting, are approved together with such changes as may be approved by the officers and officials of the Lessee executing the same, their execution to be deemed conclusive evidence of such approval.

Proper officers of the Lessee are authorized and directed, as applicable, to execute and acknowledge the Lease Agreement and to deliver the same to the Lessor for execution, in the form approved by this Section.

- 3. <u>Annual Appropriations</u>. The Lessee's payment obligations under the Lease Agreement shall constitute a current expense of Lessee subject to annual appropriation or renewal by the Board of Commissioners and shall not in any way be construed to be a debt of Lessee in contravention of any applicable constitutional, statutory or charter limitation or requirement concerning the creation of indebtedness by Lessee, nor shall anything contained herein constitute a pledge of the full faith and credit of Lessee.
- 4. <u>Designation as "Qualified Tax-Exempt Obligations"</u>. The Lessee hereby designates the principal component of its payment obligations under the Lease Agreement in the amount of \$109,721.90 as Qualified Tax-Exempt Obligations pursuant to Section 265(b)(3) of the Internal Revenue Code of 1986, as amended, and the applicable regulations and rulings thereunder. The Lessee represents and expects that the total amount of its obligations so designated and to be designated during the current calendar year does not and will not exceed \$10,000,000.
- 5. <u>General Authorization</u>. Proper officers and officials of the Lessee are authorized and directed to execute and deliver such documents (in addition to documents hereinbefore mentioned) and do such things as are required in connection with undertaking of the acquisition of the Leased Property, including payment of costs and expenses incurred in connection therewith, and as otherwise may be required to carry out the intent and purpose of this Resolution.
 - 6. <u>Effective Date</u>. This Resolution shall become effective immediately.
- 7. <u>Severability</u>. In the event any provisions, section, sentence, clause or part of this Resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Resolution, it being the intent of the Board of Commissioners that such remainder shall be and shall remain in force and effect.
- 8. <u>Repealer</u>. All resolutions or parts of resolutions inconsistent herewith are expressly repealed to the extent of such inconsistencies.

R. Wielebinski made a motion, seconded by K. Meeker, to approve Deferred Lateral Connections Contract Payment No. 2 to Kobalt Construction, Inc. in the amount of \$92,862.00. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by K. Meeker, to approve Pump Station 5 Part II Improvements Payment No. 3 to Hayden Power Group in the amount of \$2,880.00. All in favor. Motion carried.

 Motion to award Pocono Township 2022 Materials Bids - T. Muñoz indicated bids were submitted by Hanson Aggregates and Eureka Stone Quarry. Prices from Locust Ridge and 209 Enterprises were included for comparison, as they are COSTARS contractors and the Township can use them without a formal bid.

R. Wielebinski made a motion, seconded by K. Meeker, to award Pocono Township 2022 Materials Bids to Eureka Stone Quarry for delivery of 2A DGA Crushed Stone; delivery of #57 2B 3/4" Crushed Stone; pickup and delivery of SP Surge; delivery of #1 Ballast 2-4" Crushed Stone; delivery of 2RC Crushed Stone; delivery of #3 Crushed Stone; delivery of R3 Crushed Stone; Asphalt 9.5mm pg64s-22; Asphalt 19mm pg64s-22; Asphalt 25mm pg64s-22. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by K. Meeker, to award Pocono Township 2022 Materials Bids to Hanson Aggregates as the second lowest bidder of 2A DGA Crushed Stone. J. Lastowski inquired about the lowest bidder. All in favor. Motion carried.

Discussion regarding ESSA field improvements and a potential training facility for girls' softball and other youth leagues. Discussion regarding the improvements needed to construct a field complex and Township support. J. Lastowski asked whether the location of the complex would impact the field use and how the space would be used. Questions were asked regarding the maintenance of the facility, number of participants in programs; and parking needs. R. Sargent and T. Muñoz will continue exploration of the concept to see whether the facility could be located at TLC Park.

- Discussion regarding authorization to proceed with engineering study for identified stormwater projects – Laurel Lake Road, Oakwood Acres and Learn Road – J. Belvin and T. Muñoz discussed roads needing immediate attention. T. Muñoz provided engineering estimates and indicated ARPA funds can be used.
- <u>J. Belvin made a motion, seconded by J. Lastowski, to have J. Tresslar proceed with engineering studies of Laurel Lake Road and Oakwood Acres. All in favor. Motion carried.</u>
- J. Belvin made a motion, seconded by R. Wielebinski, to open agenda to discuss parks and dangerous structures. All in favor. Motion carried.
- On April 16, 2022, one of the basketball light poles collapsed at Mountain View Park. No one was injured. Rest of bases on other three poles are in poor condition. The lights currently use 440 service and are not energy efficient.

- <u>J. Belvin made a motion, seconded by K. Meeker, to have R. Sargent obtain quotes for the replacement of the four basketball court poles with energy-efficient lighting and explore lighting of lower baseball field.</u> All in favor. Motion carried.
- Discussion regarding New basketball court at TLC Park. Complaints received regarding fence around the TLC basketball court.
- J. Belvin made a motion, seconded by R. Wielebinski, to have T. Muñoz prepare quote to install four-foot-high netting extending off the top of the fence around the enclosure. Discussion regarding vandalism at the park. J. Belvin amended motion to include comparison with quote for fencing versus netting. Amendment accepted. All in favor. Motion carried.
- Discussion regarding Birchwood property and ongoing property maintenance and safety concerns.
- J. Belvin made a motion, seconded by R. Wielebinski, to have Pocono Township take owners to District Court. All in favor. Motion carried.

K. Meeker made a motion, seconded by R. Wielebinski, to have Zoning follow up regarding enforcement action against Pocono Manor for remaining debris from fire over two years ago. All in favor. Motion carried.

- There were 1,227 incidents in March, including traffic, with 3,619 total incidents year-to-date. This is up 32% from 2021. Provided update regarding current trainings taken by the officers. New patrol cars are getting painted. Corporals test is May 26, 2022. Looking to convert to different records management system for the Department, along with other County departments. JAG grant was completed and submitted for the Department. Currently looking to complete an application for a COPS grant to offset the cost of a new hire for up to three years.

A. SCOPE OF AGREEMENT

- 1. Pocono Township agrees that any sums received from the County shall be used in accordance with the provisions of the 2022: Monroe County Open Space Development Program to fund the development of the TLC Park Playground Equipment Enhancement Project. The terms of awarded grant and the program are incorporated herein.
- 2. Pocono Township agrees to adhere to all Federal, State and Municipal laws, codes and requirements. Pocono Township further agrees to indemnify, defend and save harmless from the County any and all claims arising out of the performance of this Agreement caused by an error, omission, intentional or negligent act for which Pocono Township is legally responsible.

B. MAXIMUM REIMBURSEMENT

- 1. It is understood that the total maximum reimbursable cost is up to 50% of the project total as awarded by the County, or Forty Thousand Dollars. (\$40,000).
- 2. The County agrees to reimburse Pocono Township for its expenditures made in accordance with the terms of the awarded grant and the Program.

C. EXTENT OF AGREEMENT

- 1. This Agreement shall expire December 31, 2023. Pocono Township agrees and understands that reimbursement will not be made by the County through this Grant program for costs incurred after the aforesaid termination date.
- 2. This Agreement may be amended only by written instrument signed by both County and Pocono Township.
