SEWER CONSULTANT

- Pump Station 5 Jockey Pump Project & Deferred Lateral Connections Project. Project is progressing, with tanks set and materials onsite to make connection to the force main. Contractor will dry-fit the pieces with a target date of next Wednesday. Preparing for physical connections on May 11. Township has requested that large industrial users reduce their flows during the connection time that Wednesday. For the Deferred Laterals Project, the Starner easement was finalized and recorded. Boring will occur concurrently.
- Discussion regarding finalization of two sewer reservation agreements. Springhill Suites Hotel planning new location between Frantz Road and Bartonsville Ave and has requested reservation of 30 EDUs as they go through the land development process. 330 Learn Road, known as "Westhill Villas," seeks reservation of 14 EDUs. Both applicants have submitted the appropriate paperwork and fees.

R. Wielebinski made a motion, seconded by J. Belvin, to open the agenda for action to approve reservation agreements. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Belvin, to approve reservation agreements for Springhill Suites Hotel in the amount of 30 EDUs and Westhill Villas/330 Learn Road in the amount of 14 EDUs. Discussion – E. Gnandt asked for confirmation that the EDUs requested are sufficient. J. Lastowski asked for clarification regarding the project's location. All in favor. Motion carried.

Discussion regarding construction process for the Tobyhanna equalization tank, specifically how payment applications will be made moving forward. Prior security for the pre-treatment facility was a bond and this is now being converted to a cash escrow. Township talked with Tobyhanna about the mechanics of how the payments and inspections will proceed and it was recommended that a professional services agreement be set up for specific engineering inspections and payment requests once permitting is complete. Discussion regarding establishing of a professional services agreement.

R. Wielebinski made a motion, seconded by J. Lastowski, to open the agenda for action regarding the establishment of an escrow with Tobyhanna Township. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Lastowski, to establish an escrow with Tobyhanna Township for the purposes of completing review of the equalization tank and its construction. No public comment. All in favor. Motion carried.
