POCONO TOWNSHIP MONROE COUNTY, PENNSYLVANIA

ORDINANCE NO. 2022-03

AN ORDINANCE OF THE TOWNSHIP OF POCONO, MONROE COUNTY, COMMONWEALTH OF PENNSYLVANIA, PROVIDING FOR THE RENAMING OF A STREET KNOWN AS "JOHN'S LANE" TO "KEVIN'S LANE" IN POCONO TOWNSHIP; PROVIDING FOR THE PLACEMENT OF STREET SIGNS; AND PROVIDING FOR THE AMENDMENT OF THE OFFICIAL TOWNSHIP STREET MAP.

WHEREAS, the Board of Commissioners of Pocono Township deems that the renaming of the street known as "John's Lane" to "Kevin's Lane" is in the best interests of Pocono Township, Monroe County, Pennsylvania.

NOW THEREFORE BE IT ENACTED AND ORDAINED, by the Board of Commissioners of Pocono Township, Monroe County, Pennsylvania, and it is hereby **ENACTED AND ORDAINED** by virtue of the activity of the General Assembly of the Commonwealth of Pennsylvania known as the "First Class Township Code, as amended", as follows:

SECTION 1. PURPOSE

The purpose of this Ordinance is to rename a certain street in Pocono Township known as "John's Lane" to "Kevin's Lane".

SECTION 2. FINDINGS OF FACT

The Board of Commissioners of Pocono Township finds that the said street renaming will not be detrimental to or endanger the public health, safety, or welfare of the residents of Pocono Township.

SECTION 3. AMENDMENT OF OFFICIAL TOWNSHIP STREET MAP

The official Township Street Map and all other official Township maps shall hereby be amended to reflect the renaming of the street known as "John's Lane" to "Kevin's Lane".

SECTION 4. ERECTION OF SIGNS

The Board of Commissioners of Pocono Township hereby authorizes the erection of street signs to reflect the change of the street name to "Kevin's Lane".

SECTION 5. REPEALER

All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed upon the effective date of this Ordinance.

SECTION 6. SEVERABILITY

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance.

SECTION 7. EFFECTIVE DATE

This Ordinance shall be effective five (5) days after the enactment hereof.

RESOLUTION NO. 2022-23

A RESOLUTION GRANTING CONDITIONAL APPROVAL OF THE RESUBDIVISION OF BROOKDALE ROAD PRELIMINARY/FINAL MINOR SUBDIVISION PLAN – LANDS OF STEVEN & MARY AGNES LARSON

WHEREAS, the applicants, Steven Larson and Mary Agnes Larson, submitted a minor subdivision plan application titled "The Re-Subdivision of Brookdale Road Preliminary/Final Minor Subdivision Plan – Lands of Steven & Mary Agnes Larson" (the "Plan"); and

WHEREAS, the Township Engineer has reviewed the Plan and offered comments in his letters dated March 23, 2022 and May 18, 2022; and

WHEREAS, the Pocono Township Planning Commission recommended conditional approval of the Plan at a meeting held on May 23, 2022; and

WHEREAS, the Pocono Township Board of Commissioners desire to grant the conditional approval of the Plan, subject to the following.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Commissioners of Pocono Township, County of Monroe, and Commonwealth of Pennsylvania:

That the following request for modification from the Subdivision and Land Development Ordinance are hereby granted:

1. SALDO Section 390-43.A.(6)(e)[2][a] – No more than 35% of the original ground cover within any designated steep slope area [areas having an original, unaltered slope of 20% or greater] on the property may be disturbed by grading, filling, or other means. At least 65% of the original ground cover must remain undisturbed during the establishment, alteration, or maintenance the property." *Applicant shall not be required to show, label, or dimension the steep slope easement.*

That the "The Re-Subdivision of Brookdale Road Preliminary/Final Minor Subdivision Plan – Lands of Steven & Mary Agnes Larson" as shown on the plan prepared by George Fetch, Jr., P.L.S., dated January 2022, as revised, be hereby approved with the following conditions and provided the plan is revised as follows, subject to the review and approval of the Township Engineer and/or Township Solicitor:

- 1. The applicant shall comply with all of the conditions and requirements identified in the Township Engineer's letters dated March 23, 2022 and May 18, 2022.
- 2. The applicant shall pay all necessary fees associated with the Plan, including but not limited to any outstanding plan account charges and all professional services fees, prior to the recording of the Plan.

- 3. The applicant shall obtain all required permits and approvals from other governmental agencies prior to presenting the Plan for signatures.
- 4. The applicant shall provide the requisite number of plans which are signed and notarized by the owner and sealed by the engineer.
- 5. The applicant shall meet all conditions of the preliminary/final plan approval, and Plan shall be recorded within twelve (12) months of Conditional preliminary/final plan approval, and agrees that if such conditions are not met, the Conditional preliminary/final plan approval will be considered void.
- 6. The applicant shall accept these conditions in writing within five (5) days of receipt of the Board of Commissioners Resolution, otherwise the application is denied.

RESOLUTION NO. 2022-24

A RESOLUTION GRANTING CONDITIONAL APPROVAL OF THE SWIFTWATER SOLAR PRELIMINARY/FINAL LAND DEVELOPMENT PLAN

WHEREAS, the Applicant, Swiftwater Solar LLC, submitted a plan application titled "Swiftwater Solar Project Preliminary/Final Land Development Plan" (the "Plan"). The Applicant proposes to construct solar panel fields, a substation, and various stormwater facilities. The property is located in the RD Recreation Zoning District and is known as portions of Monroe County Tax ID Nos. 12/16/1 and 12/111903; and

WHEREAS, the Township Engineer has reviewed the Plan and offered comments in his letters dated July 16, 2021, January 20, 2022 and April 20, 2022; and

WHEREAS, the Pocono Township Planning Commission recommended conditional preliminary/final plan approval at its meeting held on April 25, 2022; and

WHEREAS, the Pocono Township Board of Commissioners desires to take action on this Plan.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Commissioners of Pocono Township, County of Monroe, and Commonwealth of Pennsylvania:

The following requests for modification from the Subdivision and Land Development Ordinance are hereby granted:

- 1. SALDO Section 390-48.H.(1) "wherever there exists a dedicated or plotted portion of a road or alley along a boundary of the tract being subdivided or developed, the remainder of said road or alley shall be platted to the width required by this chapter, based on the classification of the road within the proposed development." *Applicant shall not be required to widen the cartway width along Sullivan Trail or Back Mountain Road*.
- 2. SALDO Section 390-48.K.(2) "Length and width. The private access road shall not exceed 750 feet in length as measured from the edge of the right-of-way of the abutting road, to the point of connection to the lot. The width of the private access road shall conform to Table 39048-1. Any proposed road exceeding the seven hundred fifty-foot length shall comply with all normal standards which apply to road construction." *Applicant is proposing a private access road that exceeds 750 feet in length*.
- 3. SALDO Section 390-50.D.(4) "Water depth. The maximum water depth, measured from the invert of the lowest outlet orifice to the peak one-hundred-year water surface elevation, shall not exceed five feet." Applicant is proposing thirteen (13) of the sixteen (16) infiltration basins to have a 100 Year water depth in excess of five (5) feet.

- 4. SALDO Section 390-50.D.(5) "The maximum slope of the earthen detention basin embankments shall be four horizontals to one vertical." *Applicant is proposing a slope of 3:1.*
- 5. SALDO Section 390-50.D.(7) "Top width. The minimum top width of the detention basin berm shall be 10 feet." *Applicant is proposing a berm width of eight (8) feet.*
- 6. SALDO Section 390-50.D.(8) "In order to ensure proper drainage on the basin bottom, a minimum grade of 2% shall be maintained for areas of sheet flow. For channel flow, a minimum grade of 1% shall be maintained." *Applicant is proposing 0% slope*.

That the following requests for modification of the Stormwater Management Ordinance are hereby granted:

- 1. SMO Section 365-11.A.(3) "The size of the recharge facility shall be based upon the following volume criteria: (a) NRCS Curve Number Equation." (as outlined in the Section); (b) Annual recharge. Water budget approach." (as outline in the Section)." Applicant is proposing that the PADEP spreadsheets, as required for the NPDES permit application, be utilized to calculate stormwater volume requirements.
- 2. SMO Section 365-13.B, 365-13.D., and Appendix A Design Criteria The Ordinance requires the use of certain rainfall depths and intensities for the various storm return periods, according to the region in which the project is located. *Applicant is proposing to utilize the NOAA Atlas 14 rainfall data as part of the stormwater management analysis to be consistent with the NPDES Application calculations.*

That the "Swiftwater Solar Project Preliminary/Final Land Development Plan" as shown on the preliminary/final land development plan prepared by Timmons Group, dated May 28, 2021, as revised, be hereby approved with the following conditions and provided the Plan is revised as follows, subject to the review and approval of the Township Engineer and/or Township Solicitor:

- 1. The Applicant shall comply with all of the conditions and requirements identified in the Township Engineer's letters.
- 2. The Applicant shall enter into an Improvements Agreement with the Township and provide appropriate security.
- 3. The Applicant shall enter into a Maintenance Agreement with the Township and provide appropriate security.
- 4. The Applicant shall enter into a Stormwater Management and Maintenance Agreement with the Township.
- 5. The Applicant shall pay all necessary fees associated with the Plan, including but not limited to a fee in lieu of dedicating open space in the amount of \$659,680.00, and any outstanding

plan account charges and all professional services fees, prior to the recording of the Plan.

- 6. The Applicant shall obtain all required permits and approvals from all other governmental and regulatory agencies, including but not limited to the Pennsylvania Department of Environmental Protection and the Pennsylvania Department of Transportation, prior to presenting the Plan for signatures.
- 7. The Applicant shall meet all conditions of the preliminary/final plan approval, and Plan shall be recorded within twelve (12) months of Conditional Plan approval, and agrees that if such conditions are not met, the Conditional Plan approval will be considered void.
- 8. The Applicant shall accept these conditions in writing within five (5) days of receipt of the Board of Commissioners Resolution, otherwise the Plan is denied.

The regular meeting of the Pocono Township Board of Commissioners was held on May 16, 2022 and was opened by President Rich Wielebinski at 6:05 p.m. followed by the Pledge of Allegiance.

<u>Roll Call</u>: Jerrod Belvin, present; Ellen Gnandt, present; Jerry Lastowski, present; Keith Meeker, absent; and Rich Wielebinski, present via Zoom.

<u>In Attendance</u>: Leo DeVito, Township Solicitor; Amy Montgomery, Township Engineer; Taylor Muñoz via Zoom, Township Manager; Shawn Goucher, Acting Chief of Police; Robert Sargent, Public Works Supervisor via Zoom; Frank Cefali, Township Treasurer; Paola Razzaq, Financial Administrator; and Jennifer Gambino. Administrative Assistant.

Announcements

The first annual Pocono Township Touch-a-Truck event will be held on Saturday, June 4th from 10:00 a.m. to 2:00 p.m. This free, family-friendly event will feature dozens of trucks, vehicles, and activities for children. Funds raised from food sales, donations and a raffle will benefit the Pocono Township Volunteer Fire Company.

Presentations

- Retirement Plaque Presentation Officer Rob Furino Plaque presentation and recognition of over 19 years of service to the Pocono Township Police Department.
- Q1 2022 Township Treasurer's Report Frank Cefali, CPA & Township Treasurer presented report (included as attachment with minutes). Presented highlights from each fund, revenues received, expenses and tax collection rates for Q1. Stated the expenditures look skewed because of a transfer out of the General Fund to the Capital Fund. Absent the transfer, the Township's expenses are in line as expected. Sewer tapping fees are up. E. Gnandt asked about Liquid Fuels disbursement and Amusement Tax. Clarification given regarding the increased Amusement Tax rate.
- MS-4 Presentation Melissa Prugar, P.E., LVL Engineering, provided a progress report for Pocono Township's Municipal Separate Stormwater System (MS-4) compliance. Township meets annual terms of the Township's MS-4 permit, which requires Township to meet six minimum control measures to protect area waterways and prevent illicit discharges. Control measures include public education, construction site stormwater runoff control, post-construction stormwater management, and pollution prevention. Any development over one acre requires notification of the Conservation District. T. Muñoz inquired about the current stormwater ordinance and the deadline for revisions. A draft will be presented to the Board for adoption in the future.
- Nick Wilson, Township Resident N. Wilson is a Township resident who lives on John's Lane, off Warner Road. In October of 2021, his brother-in-law was murdered in Florida. He was an integral part of their family. Two of his sisters live on John's Lane and he asked whether the Township would consider renaming their road to "Kevin's Lane." Signatures of support were collected from every resident on John's Lane.
- J. Belvin made a motion, seconded by J. Lastowski, to open the agenda for consideration of renaming John's Lane off Warner Road. All in favor. Motion carried.

J. Belvin made a motion, seconded by E. Gnandt, to advertise the renaming of John's Lane to Kevin's Lane, with the Township Resident, Nick Wilson, responsible for the cost of the change. No public comment. All in favor. Motion carried.

- J. Belvin made a motion, seconded by J. Lastowski, to approve the consent agenda. E. Gnandt asked that the motion for the slide be conditioned on the vendor being a COSTARS quote. Amendment to motion accepted. All in favor. Motion carried as amended.

NEW BUSINESS

Report of the President

Richard Wielebinski

Motion to award 2022 paving bid - Discussion regarding the bids received being above the 2022 budgeted amount. H&K bid \$1,874,247.03 and Hanson Aggregates bid \$1,879,310.20. L. DeVito indicated that the Township spoke with PennDOT and has the authority to remove portions of the project per the bid contract documents. L. DeVito suggested the Board of Commissioners take action at the next BOC meeting. J. Belvin suggested the Board discuss together what roads should be removed from the project.

R. Wielebinski made a motion, seconded by J. Belvin, to approve a COSTARS quote in the amount of \$165,674.00 provided by Recreation Resource USA for purchase and installation of two playground structures at TLC Park. These items will be purchased through grant funds, open space fees and ARPA funds. E. Gnandt asked that the invoice reflect COSTARS pricing. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Lastowski, to approve Payment No. 1 in the amount of \$27,000.00 to Blue World Construction, Inc. as part of the General/Building Contract for Pump Station 5 Part II improvements. All in favor. Motion carried.

R. Wielebinski made a motion, seconded by J. Lastowski, to approve Payment No. 1 in the amount of \$32,895.00 to Blue World Construction, Inc. under the Mechanical/Plumbing Contract for Pump Station 5 Part II improvements. J. Lastowski clarified that this bill is coming out of the sewer account. All in favor. Motion carried.

- Discussion and possible action regarding the re-naming of John's Way Action taken earlier in meeting.
- Discussion regarding possible youth softball and baseball training facility at TLC Park Pocono Pride was informed that they would be receiving another grant for the construction of a training facility and their representative asked whether Pocono would still be interested in the TLC Park location. E. Gnandt asked for clarification as to whether the Township would have to pay anything toward the building construction and whether the public would be able to use the facility. Any final document would be subject to legal review. J. Lastowski asked whether the parking at TLC will be sufficient to handle park amenities and a training facility. R. Wielebinski will ask representative to attend a future meeting.
- Update regarding quote for four (4) foot chain link fence extension for the TLC Park Basketball Court
 R. Sargent stated he placed two phone calls for quotes and a third one is in the works. Asking for quotes on backstop at MVP and fence around the upper field.

Commissioner Comments

Commended PW Crew for work on the TLC Park parking lot. Asked R. Sargent for updates on broken railing at Crossing Abilities playground, installation of plaques at TLC Park, T1-11 on dugouts, dog park update, and possible installation of cameras at TLC.

Ellen Gnandt – Commissioner

Update regarding T1-11 on Alger Avenue garage. Stated she observed activity at the property of the owner who will be before the Zoning Hearing Board at the end of this month, seeking approval for construction of a garage in the front yard setback. NEW TATTOO POLICY PROPOSAL

CURRENT POLICY

R6.22 Uniforms, Equipment and Appearance on Duty

Tattoos: Tattoos on the ears, head, nose, face, eyebrows, neck or tongue are prohibited. Tattoos on all other parts of the body shall be covered at all times by issued clothing or by utilizing commercially available cosmetics or fabric covers made for the purpose of covering tattoos. If commercial products are used, same must be of skin tone and neutral in color. This policy shall apply while all sworn members are on duty, including training or attendance at outside events (other than physical training or defensive tactics training) or whenever representing the Department in an official capacity regardless of whether the sworn member is in uniform or not, unless exempted under the provisions of this policy

PROPOSED NEW POLICY

Tattoo and Body Art

Purpose

This policy establishes guidelines for employees displaying tattoos and body art while on-duty, both in uniform or on-duty in civilian attire.

Policy

Tattoos or brands that are prejudicial are prohibited. Additionally, while on-duty in uniform or civilian attire, employees are not permitted to exhibit tattoos, body art, or brands that are offensive or demeaning to persons of ordinary sensibilities. This policy may be rescinded or modified at any time by the Chief of Police.

Definitions

Body Art – See definition of Tattoo.

Body marking – Pictures, designs, or other markings using means other than burning to permanently scar or mark the skin.

Body modification – A deliberate altering of the human anatomy or human physical appearance.

Brand – A picture, design, or other marking burned into the skin or other areas of the body.

Extremist – Extremist tattoos or brands are those affiliated with, depicting, or symbolizing extremist philosophies, organizations, or activities. Extremist philosophies, organizations, and activities are those which advocate hatred or intolerance based on race, ethnicity, national origin, gender, sexual orientation, gender identity, religion, economic status, age, or disability; advocate creating or engaging in illegal discrimination based on race, ethnicity, national origin, gender, sexual orientation, gender identity, religion, economic status, age or disability; or advocate violence or other unlawful means of depriving individual rights under the U.S. Constitution, and Federal or State law.

Indecent – Indecent tattoos or brands depict nudity or are offensive to modesty, decency, propriety, or professionalism.

Political – Relating to the symbols, causes, ideas, or strategies of a particular party or group in politics, including special interest groups

Racist – Racist tattoos or brands advocate a philosophy that degrades or demeans a person or group of people based on race, ethnicity, or national origin.

Sexist – Sexist tattoos or brands advocate a philosophy that degrades or demeans a person or group of people based on gender.

Tattoo – Defined as a picture, design, or mark made on the skin or other areas of the body by staining it with an indelible dye or by any other method, including pictures, designs, or markings only detectible or visible under certain conditions (as an ultraviolet light or invisible ink tattoo). The terms tattoo and body art are interchangeable.

Tattoos/Body Art/Brands and Body Modifications Prohibited or Required to be Concealed

The following tattoos, body art, and brands are prejudicial to good order and are prohibited for all employees, regardless of visibility:

- 1. Extremist;
- 2. Indecent;
- 3. Sexist;
- 4. Racist; and or
- 5. Violate the Township policies on Equal Employment Opportunity, Discrimination and Harassment.

Officers are prohibited from having tattoos on any part of the hands, neck, face, head, eyelids, mouth, and ears with the following exceptions:

- 1. Tattoo of one wedding band on a ring finger.
- 2. Conservative use of permanent facial make-up on the eyebrows, eyeliner, and/or lips.

Any tattoo/body art or brand that implies a negative bias toward any group will subject the employee to disciplinary action, up to and including termination.

The Department reserves the right to require employees to conceal their tattoos/body art or brands if deemed necessary to comport with evolving community standards, attitudes, or beliefs. This policy and its exceptions do not grant permanent approval to display any tattoos/body art or brands subsequently deemed unacceptable for display. Employees may be required to cover them at any time.

The following tattoos/body art and brands must be concealed in accordance with this policy while in uniform, on-duty, or on duty in civilian attire:

1. Symbols or markings likely to elicit a strong negative reaction in the workplace or public or that are inconsistent with the Department's values and community relations objectives, including but not limited to symbols or markings that promote or are associated with violence or weaponry.

- 2. Anything contrary to the purpose of law enforcement, including, but not limited to: depictions symbolizing or indicative of alcohol or narcotics, illegal or gang-related activity, or symbols suggestive of activity that undermines the purpose of law enforcement.
- 3. Illustrations, references, symbols, acronyms, or the like that denigrate the United States, State of Pennsylvania, or the Pocono Township Police Department.
- 4. Symbols or markings that represent political beliefs, political parties, political slogans, or that cast any political group in a negative light.

Authorization for Visible Tattoos/Body Art

Employment packages will include a copy of the Department's Tattoo/Body Art Policy to ensure the applicant does not have any tattoos/body art that are prohibited by this policy. The Chief of Police will determine whether an applicant's tattoos/body art complies with this policy.

Tattoos that must be concealed under this policy must be kept entirely from the authorized uniform or plainclothes when an employee represents the Department on duty.

If, when considering a new tattoo, an employee has doubts about the tattoo's compliance with this policy, the employee should submit the design to the Chief of Police for approval.

Any tattoo/body art that is believed to not conform to this policy should be brought to the attention of a supervisor. The supervisor will notify the Chief of Police.

The Chief of Police or designee shall make the final determination as to whether tattoos/body art conforms to this policy.
