Manager's Report for July 1, 2025 Regular Board Meeting

-Pool/Spa update: The pool has been consistently up and running and the temperature is staying around 82 degrees. We had to contact Watermark Spas a couple of times now because our chemical levels (PH, Chlorine, and Hardness) have been high, the water in the spa is consistently low, and the times they have shown up is not always on our Monday close time (10a to 2p). I talked with the front office and the tech that has been servicing our pool, so hopefully they will understand how important it is to maintain safe and ideal levels with the chemicals. I am meeting with another pool company that tests and maintains pools and spas in case Watermark doesn't work out. We are getting bids on the men's dry sauna with a timer and should have some pricing together within a week or so. Have a bid for a garage door (we'll take out two windows) from Overhead Door company and am meeting with Kooler Garage Door on Wednesday the 25th of June. I contacted a 3rd company (Monument Garage Door) and they are getting back to me with a time to meet later this week. The replacement window bid was over \$10,000 to replace all the windows, but now getting bids to adjust the window bid if we are putting a garage door in and maybe only replacing 2) windows for venting purposes. I asked Hanson Construction to breakdown his bid for the bathroom dividers and toilets, and another bid for replacing only the 2) windows and framing in the garage door. Another bid is coming for construction by Mike Vanian.

Eddy's Lawn Care has been contacted in regard to purchasing the Walker lawn mower and some of the other power tools we store over at the RV shop. I did some research on the mower and a used one can be purchased between \$4,000 to \$6,000 and the power tools (2-blowers, 2-trimmers, 2-hedging trimmers, and 1-chainsaw) are worth \$1,000 used. He made an offer to purchase the mower for \$5,000 cash or \$6,000 worth of labor, and the power tools for \$750 cash or \$1,000 labor. I told him I would be putting this in the managers' report, so the Board can make that decision. We aren't using any of the equipment (except 2-blowers and

and 1-trimmer that have been set aside already) and could benefit from him purchasing these items.

- -The new website is complete and now online. The developer is waiting for the information we need to get from Grand Valley Bank for ACH setup, but should have it all done by the first of July as long as I get the confirmation from GVB that we are all set up. I updated our information last week, so we should be all caught up and current. I'll be monitoring the website and will make any changes/updates we need to do with the developer.
- -Grounds update: Grounds have been looking good, and I sent in the Lakeside map to Sav-A-Tree so they can differentiate between the 4 Associations' common areas. Once we get the bid back from them, we will do another walk-around and then start adding homeowners' trees for additional bids for the homeowners. I'll reach out to the arborist and hopefully have LEVHA's bid out for the Tuesday meeting. Still have some sprinkler issues and dry spots that need to be addressed, but are staying on top of these with weekly emails to LiquiGreen on issues. We keep a few flags at the office, so if an owner or tenant knows where we are having problems, they can come by the office and get a flag and stick it in the problem area.
- -Contacted the GJ Police Department in regard to getting regular updates on Calls of Service (COS) in the Lakeside Community. They will be sending me weekly COS's and as we build a database with frequent offenders, this will be a more proactive approach to violations rather than a reactive one.

- -File storage device coming in from Networks Unlimited-\$1,133

- -We will start trimming to ensure we meet city code of elevating trees 8' over sidewalks and 14' over roadways. After that is accomplished we will clear buildings and structures by 6' and remove deadwood 1" diameter and greater that poses a significant hazard. After this trimming is done we will then move towards reducing and thinning heavy outreaching sections to lessen the likelihood of failure.
- -We will get as much if this done in a day as possible and will need multiple days per each HOA to get trees all trimmed up for safety to minimize maintenance needs afterwards.
