Important Questions	Answers	Why this Matters
What is the overall deductible?	For <u>network providers</u> \$1,500 person / \$3,000 family. For <u>non-network providers</u> \$3,000 person / \$6,000 family.	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes, the network benefits <u>deductible</u> doesn't apply to <u>preventive care</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without cost-sharing and before you meet your <u>deductible</u> . What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	For <u>network providers</u> \$4,000 person / \$8,000 family. For <u>non-network providers</u> \$8,000 person / \$16,000 family. Your plan also has a co-insurance maximum. For <u>network providers</u> \$2,500 person / \$5,000 family. For <u>non-network providers</u> \$5,000 person / \$10,000 family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Does this plan provide Minimum Essential Coverage? Yes.
