

General Price List

These prices are effective as of March 26, 2024, but are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff \$1,500.00

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to the initial request for service, 24 hours per day, 365 days per year; arrangement conference with the family or responsible party; coordination of the service; preparation and filing of necessary permits; recording of vital statistics; preparation and placement of obituary notices; and staff assistance prior to, during and following the funeral including coordination with those providing other portions of the funeral (i.e. cemetery, crematory and others). Also included in this charge are overhead expenses related to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains).

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
