Her Concert work includes: a *Rising Stars Concert* at Limerick University Concert Hall; Bach *Cantata BWV 191* (soprano solo) and Walton *Missa Brevis* (soprano solo) at the National Concert Hall, Dublin with the Goethe Institute Choir; a *Taste of Italian Opera* recital at the Italian Institute of Culture, Dublin; and a Summer Recital in Belfast.
