is a young, Norwegian lyric tenor who is currently studying at the Opera Academy in Copenhagen with Eva Hess Thaysen and Susanna Eken. Magnus is concurrently a member of the Royal Opera Copenhagen's Young Artist Programme.

He received both his BMus and MMus from the Norwegian Academy of Music, in Oslo, studying with Svein Bjørkøy, Magnus Staveland, Mona Julsrud and Ann-Helen Moen.

His performed repertoire includes: Don Ottavio; Ferrando; Tamino; Phoebus (*Fairy-Queen*), and Torquemada (*L'heure espagnole*); whilst repertoire in preparation includes: Fenton; Nemorino and Romeo (*Roméo et Juliette*).

Magnus made his debut at the Royal Opera Copenhagen as a Lehrbube (*Die Meistersinger von Nürnberg*), directed by Laurent Pelly, in 2024. This season, he sang Borsa in Sofia Jupiter's production of *Rigoletto*. In June 2025, Magnus received an artist grant from the his home municipality of Lillestrøm, Norway.

Active on the oratorio stage, Magnus has performed many times as the Evangelist and Tenor Soloist in Bach's *Christmas Oratorio*, *Johannes-Passion*, and *Matthews-Passion*. He has also performed several of Bach's cantatas.

Further concert engagements include: Handel's *Messiah* with the Uranienborg Vocal Ensemble, conducted by Elisabeth Holte; masses by Haydn and Schubert; Mozart's *Requiem*, and also his *Great Mass in C minor*, the latter with the Oslo Cathedral Choir, conducted by Vivianne Sydnes.
