

# Stafford Law

## Tuomas Miettola

is a young Finnish tenor whose bladed voice, fine musicianship and strong dramatic gifts have quickly established him as one of the most exciting young singers in Scandinavia. In 2024, he won the inaugural Jorma Hynnen Art Prize and in 2023 received 2nd Prize and the Audience Prize in the Havets Röst Singing Competition. In 2022, he was awarded scholarships by both the Finnish Wagner Association and the Friends of the Salzburg Music Festival.

His performed repertoire includes: Tamino; Fritz (*L'Amico Fritz*); Albert Herring; Ferrando; Male Chorus (*The Rape of Lucretia*); Jacquino (*Fidelio*); Gastone (*La Traviata*); 3rd Jew (*Salomé*), and Misail & Boyar (*Boris Godunov*).

For season 2025/2026 Miettola has been engaged for Young Singers' Programme at the Finnish National Opera, where his repertoire will include: tenor soloist (*CiruOpera 2.0*); Young Servant (*Elektra*); Gastone and Alméric (*Iolanta*).

Further 2025/2026 engagements include: Arturo & Normanno (*Lucia di Lammermoor*) at Jyväskylä Opera, and a return to the Savonlinna Opera Festival as Goro, under the baton of Piergiorgio Morandi.

Future concert engagements include: an Opera Gala, (with Silja Aalto and Ville Matvejeffwith) at the Oulu Symphony Orchestra; Future concert engagements include: Mozart's Requiem with Lappeenranta City Orchestra with Erkki Lasonpalo as a conductor and three solo lied recitals at prestigious music festivals such as Turku Music Festival.

Orchestras with which he has sung include: the Georg Enescu Festival Orchestra; the Tampere Philharmonic Orchestra; the Lahti Symphony Orchestra; the Tapiola Sinfonia; the Oulu Symphony Orchestra, the Jyväskylä Symphony and the Lapland Chamber Orchestra.

Conductors with whom he has worked include: Susanna Mälki, Lorenzo Passerini, Hannu Lintu, Giancarlo Andretta, John Storgårds, Alberto Hold-Garrido, Valentin Uruypin and Olari Elts.

### Hämeenkyrö Festival, Korpijaakko: People in the Summer Night
