has in recent years taken on more dramatic repertoire and has recently made her debuts at Theater Bremerhaven and the Semperoper Dresden. Future engagements include her debut at La Monnaie, Brussels. She is taught by Rosalind Plowright.

Eva Maria Summerer trained at the Hochschule für Musik und Theater in Hamburg. She won the 2015 German Forum New York Scholarship, was a 2016 recipient of the Richard Wagner Scholarship at the Bayreuth Festspiele, was a 2017 Finalist in the Richard Strauss Competition, and a Finalist in the 2018 Wagner Voices Competition.

As an ensemble member at Schleswig-Holstein Landestheater Flensburg from 2018 to 2020, she sang Amando (*Le grand macabre*), Erika (*Vanessa*) and Maddalena.

German engagements include: Mary (*Der Fliegende Holländer* - Children's Version) at the Bayreuther Festspiele; Gertrud (*Hänsel und Gretel*) and Annina (*Der Rosenkavalier*) at Theater Bremerhaven; Die Köchin (*Gespensersonate*) and cover Königin Eleonore (*Die Jüdin von Toledo*) at the Semperoper Dresden; Moldau (*Prinzessin Anna*) at the Opernfestspiele Heidenheim; Cornelia (*Giulio Cesare*) at the Cuvilliétheater München; Feueriger Mann (*inSOMNIA*) at the Opernfestival Oberpfalz; Alto Solo in a staged setting of Bach's *Bminor Mass* at the Theater Regensburg.

She has worked with conductors, including Ivor Bolton; Jonathan Darlington; Raphael Fusco; Thomas Hengelbrock; Corinna Niemeyer; Mark Niemann, Boris Schäfer; and Yura Yang, and directors, including: Robert Carsen; Eva Eiberger; Julia Hübner; Martin Philipp, and Julius Semmelmann.

Her concert engagements include: the Bach *Christmas Oratorio* at the Hauptkirche St. Petri Hamburg (KMD Thomas Dahl); the Beethoven *Major Mass* at the Philharmonie de Paris (Thomas Hengelbrock); the Mozart *Requiem* and the Rossini *Petite Messe Solennelle* at the Frauenkirche Dresden (Matthias Grünert); Soloist (*Christmas in Europe*) at the Château de Fontainebleau (Thomas Hengelbrock) and a solo recital of Brahms, Mozart and Strauss at the Lincoln Center, in New York.

Her new repertoire includes: Amneris; Azucena; Fricka; Jezibaba; Judith, and Waltraute.
