

MEETING NOTICE
HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 15

Notice is hereby given that **HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 15** will hold a meeting on **November 20, 2025**, at **7:30 P.M.**, at the following location in the District: **Tomball Fire Department Station 4, located at 10333 Mahaffey Road Tomball, Texas 77375.**

The District will consider and act upon the following matters:

1. Call meeting to order.
2. To receive public comment.
3. To approve minutes of prior meeting(s).
4. To review and take any necessary action on amendments to District 2025/2026 Budget.
5. To receive and approve the District's financial report and take any necessary action regarding the District's investments.
6. To pay the District's bills and debt obligations and to authorize the transfer of funds between District's accounts.
7. To review, discuss and take action regarding the replacement and purchase of new Poll Pads and warranties for District elections.
8. To review, discuss and take action regarding lease agreements for Station 4 and 5.
9. To review and act to approve the purchase, funding, financing and payment for capital assets, including vehicles, fire-fighting apparatus, apparatus repairs and equipment and for non-capital items and expenses.
10. To review and approve repair and maintenance expenses for Station 4 and Station 5.
11. To receive a report of fire suppression and related activity from the Tomball Fire Department.
12. To review and take action on the ratification of a continuing contract with a private law firm pursuant to §6.30 of the Tax Code for the collection of delinquent District ad valorem property taxes and, providing for the payment of up to 20% of the delinquent taxes, penalties, and interest which are collected by the attorney under said contract.
13. To discuss and take action on the imposition of additional penalty on delinquent taxes pursuant to §33.07 of the Tax Code and adoption of a Resolution regarding same for taxes.
14. To discuss and take action on the imposition of additional penalty on delinquent taxes to defray costs of collection by the District's delinquent tax attorney, pursuant to §33.08 of the Tax Code and adoption of a Resolution regarding same.
15. To discuss and take action on the imposition of early additional penalty for collection costs for taxes imposed on personal property on delinquent taxes pursuant to §33.11 of the Tax Code and adoption of a Resolution regarding same.
16. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.

17. To meet in Executive Session, pursuant to §551.071 Government Code, to conduct a private consultation with the District's legal counsel.
18. To recommend and discuss any new items which need to be on the agenda for the subsequent District meeting.
19. To schedule the December regular meeting.
20. Adjournment.
