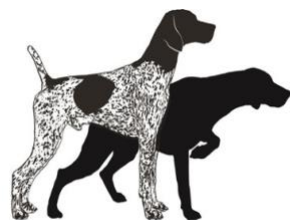

DIRECTIONS TO CASTLE BUTTE WELLS aka CAMP H:

FROM MOJAVE:

Go North on Highway 14 to California City Off Ramp. Turn Right and go 10.3 miles through California City and all the various stop signs and lights. Turn Left at the Light (Randsburg - Mojave Road) which turns into 20 Mule Team Parkway. Go 11.1 miles. Go past the Silver Saddle Ranch turnoff where the unpaved road starts. Continue for 3.4 miles to the next SCVC (Southern California Vizsla Club) sign and turn Right onto "Tulane Road." Continue approximately 2 miles to the Camp H Grounds. You will see the "Camps & Setups" on the left. Please be respectful while driving through camp and watch for people and dogs.
