The meeting was called to order at 8:52 p.m.


Laura Stoess read the Minutes from the November meeting into the record. The Minutes were approved as read.




Eddie Turner reported that the District has received a tax collection check from the Sheriff for February in the amount of \$42,916.80.



Laura Stoess read the Minutes from the March meeting into the record. The Minutes were approved as read.



Discussion was held. The motion passed unanimously.

Anyone else interested in running should notify Chairman Deibel in writing no later than May 14, 2025 to allow sufficient time to publish the Legal Notice. He inquired of Mr. Gardner if he was willing to be re-appointed and continue to serve on the District Board. Mr. Gardner advised that he was willing to continue to serve. Chairman Deibel instructed counsel to request that County Judge Executive Voegelé re-appoint Mr. Gardner.
