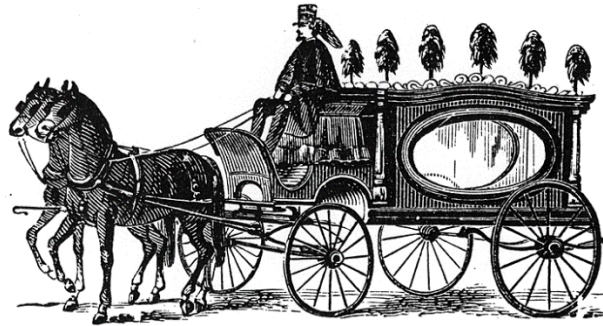

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide that describes the funeral goods and services you selected.

(1) Basic Services of the funeral director and staff **\$2145**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. {This fee is already included in our charges for direct cremations, immediate burials, & forwarding or receiving remains.} This fee includes, but is not limited to: Personnel available 24 hours a day, 365 days a year to respond to initial call, arrangement conferences, shelter of remains, coordinating service plans with cemetery, and/or other parties involved in the final disposition of the deceased. Also included in this charge are the overhead expenses relative to our facility such as insurance, maintenance, utility expenses, administrative costs, government compliance and equipment, and inventory expenses.

This portion of the fee is \$1150

This fee also includes clerical and staff assistance along with the necessary office equipment necessary in the completion of various forms and activities such as securing, filing, and recording the death certificate, Social Security forms, military forms, obituary notices, contacting newspapers & radio stations, and preparing and arranging for musicians and hair dressers.

This portion of the fee is \$995

(2) Embalming **\$1195**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

A Autopsy cases - \$95 additional charge
Refrigeration - \$50 per day, after the first 24 hours

(3) Other preparation of the body **\$195**

Includes bathing, shaving, restorative art, special cosmetology, dressing, and casketing.

(4) Services and facilities for a funeral service in our Chapel **\$550**

Includes services of the funeral director and staff in setting up and supervising the funeral ceremony, supervision of committal or other disposition service, and setup and use of equipment and facilities during the funeral ceremony.

(5) Services and facilities for a memorial service in our Chapel **\$550**

Includes services of the funeral director and staff in setting up and supervising the memorial ceremony, supervision of committal or other disposition service, and setup and use of equipment and facilities during the memorial ceremony.

(6) Services and facilities for a funeral service outside the funeral home (such as a church) **\$550**

Includes services of the funeral director and staff in setting up and supervising the funeral ceremony, supervision of committal or other disposition service, and setup and use of equipment and facilities during the funeral ceremony.

(7) Services and facilities for a funeral service held graveside **\$450**

Includes services of the funeral director and staff in setting up and supervising the funeral ceremony and the equipment necessary to conduct a funeral ceremony at the graveside.

(8) Services and facilities for a viewing **\$525**

Includes the services of the funeral director and staff in setting up and supervising the visitation, guest register, display of floral tributes, and private facilities for viewing and visitation.

(9) Staff, equipment, and transfer of remains to another facility for viewing, such as a home or church **\$525**

(10) Transfer of remains to the funeral home
\$300

Includes vehicle and services of the funeral director or staff in transporting the remains and securing transit permits, for the first 25 miles of transportation. After the initial 25 miles, the rate is \$4.00 per loaded mile.

(11) Hearse
\$350

Includes the first 25 miles of transportation between the funeral home and the cemetery. After the initial 25 miles, the rate will be \$4.00 per loaded mile.

(12) Other automotive equipment
\$250

Flower van & driver: includes the first 25 miles of transportation between the funeral home and the cemetery. After the initial 25 miles, the rate will be \$3.00 per loaded mile.

(13) Immediate burial: from \$2795 to \$3095

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff, a proportionate share of overhead costs, removal of remains, and local transportation to the cemetery.

A. Immediate burial with container provided by the customer **\$2795**

B. Immediate burial with cloth-covered wooden box from our funeral home **\$3095**

C. Immediate burial with casket selected from our funeral home (in addition to the cost of the casket). **\$2795**

(14) Direct cremation: from \$2345 to \$2895

Our charge for a direct cremation (without ceremony) includes: basic services of the funeral director & staff, necessary paperwork for authorization, and cremation of the remains. If you want to arrange a direct cremation, you can use an alternative container that encases the body and can be made of materials such as fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container.

A. Direct Cremation with container provided by purchaser **\$2345**

B. Direct Cremation with alternate container **\$2495**

C. Direct Cremation with cloth-covered wood casket from the funeral home **\$2895**

(15) Forwarding of remains to another funeral home

This charge includes the removal of remains, basic services of our staff, embalming, sheltering of remains, necessary authorizations, minimum shipping container, and local transportation to Birmingham airport. This charge does not include visitation, rites, or ceremonies prior to forwarding the body.

A. With minimum shipping container **\$4640**

B. With casket selected from our funeral home (in addition to the cost of the casket) **\$4440**

C. Air Tray (required by airlines) **\$500**

(16) Receiving remains from another funeral home
\$2995

Our charge includes: basic services of the funeral director and staff, a proportionate share of overhead costs, care of remains, transportation of remains from the Birmingham airport to the funeral home and to the cemetery.

*This charge DOES NOT INCLUDE visitation, rites, or ceremonies.

(20) Family Accommodation Service Package for Burial Insurance Policies \$995

This is a package of services that Turners Funeral Home, Inc. is authorized to perform in accordance with Burial Insurance Policies under Liberty National Life Insurance and/or Brown Service Insurance Companies. Where the Burial Policy provides benefits in funeral services and merchandise, in lieu of cash, Turners Funeral Home, Inc. will provide such services and merchandise as described in the policy/policies as ordered by the United States District Court in Edgar H. Battle vs. Liberty National Life Insurance Company as defined and ordered by United States District Judge, the Honorable Inge P. Johnson on March 8, 1999.

For services and/or merchandise that are not covered or provided under the policy, charges will be made in accordance with our published General Price List. Where the burial or funeral policy provides benefits payable in "cash only," you will be charged for all items of service and merchandise in accordance with our published General Price List, and credit will be issued equal to the amount payable under the policy.

(21) Traditional Funeral Service Package \$4650

This is a package of services, which is only available with the purchase of a casket from our funeral home. The price of the casket selected is not included in the price of this service package. This package includes the basic services for the funeral director and staff, picking up the remains within 25 miles of the funeral home, embalming (excluding special care for autopsied cases), other preparation of the body, professional services and use of our parlor and or chapel for viewing and visitation and/or a chapel, church, or graveside funeral service (within 35 miles), hearse service for up to 25 miles, flower van and driver to transport flowers, and arrangement of flowers at the visitation.

However, this package does not include any services not performed by Turner Funeral Home, Inc.

This package DOES NOT INCLUDE certain services commonly associated with a funeral such as cemetery fees, certified copies of the death certificate, outside hairdressing, excess mileage, organist, flowers, or gratuity to clergy.

(22) Graveside Service Package \$4350

This service package contains all services listed above in our Traditional Funeral Service Package EXCEPT for having a church or chapel funeral service.

However, this package does not include any services not performed by Turner Funeral Home.

(23) Sunday/Major Holiday Charge \$300

**This charge is in addition to the services listed in either the Traditional Funeral Service Package or the Graveside Service Package for funeral services requiring a funeral director on Sundays or major holidays.

(24) Second Visitation (After Hours) \$250

**In addition to the services listed in either the Traditional Funeral Service Package or the Graveside Service Package
