Beekman Charter School Notice of Investigation to Respondent

Beekman Charter School received a complaint alleging that you engaged in conduct that may constitute sexual misconduct under District Policy. If you have any concerns about the impartiality of the Investigator(s), please let me know immediately.

You are entitled to a presumption of innocence, which will be maintained throughout the process until a determination of responsibility is made. The Investigator(s) will be in contact with you to schedule a time to formally interview you for the investigation. You may be accompanied by a support person, advisor, or advocate of your choice to the investigation interview, including a lawyer, at your own expense. This person should not be someone who you will also identify as a witness.

As part of this process, you will have a right to provide evidence and witnesses for the Investigator's consideration, and to review and comment on evidence gathered by the Investigator(s) from the other party and witnesses. Beekman Charter School will objectively evaluate all relevant evidence, including inculpatory (proves a violation) and exculpatory (proves no violation) evidence to reach a determination of responsibility.

Consistent with the Policy, you are hereby directed not to delete any potentially relevant evidence, including electronic files, records, or data in your possession. You are further directed not to sell, give away, destroy, or otherwise surrender possession of any personal or Beekman Charter School-issued devices. Do not wipe or reformat any personal or Beekman Charter School-issued devices. Do not delete any social media or email accounts that you currently have or delete any content or data from the same.

Making false statements or knowingly submitting false information during the grievance process is prohibited by Beekman Charter School and may constitute an independent basis for disciplinary sanctions against any student or employee, up to and including suspension or expulsion of a student or termination of an employee's employment.
