WHAT: Prattville CityFest 2026

WHEN: Friday, May 1, 2026 - 6 P.M. to 10 P.M.; Saturday, May 2, 2026 - 9 A.M. to 4 P.M.

Friday and Saturday are SEPARATE this year. You can sign up for one night or both.

WHERE: Historic Downtown Prattville, Alabama. Friday, May 1, Spillway Park. Saturday, 124 West Main St.

SELECTION: All food vendors must submit an application along with a check in order to be considered by the selection committee. **Due to space constraints, a limited number of food vendors are allowed.** The food vendors are chosen by the selection committee. **The selection committee reserves the right to approve or deny certain food items to be served.**

ELIGIBILITY: Photographs of your product must accompany each application along with a sample menu. The selection committee will make decisions based on food represented in the photographs. All photos will be returned if accompanied by a self-addressed and adequately stamped envelope. **The selection committee does not assume any liability for loss or damage and recommends original photographs not be submitted. If chosen, you are responsible for keeping your booth area clean and ensuring that the area is left the same as it was when you arrive.**

DEADLINE: Entries must be received by April 3, 2026. No refunds will be granted for cancellation after April 3, 2026.

EXHIBITING INSTRUCTIONS: All means of display should be provided by the exhibitor. Tables and chairs will not be provided. **A COVER SHOULD BE BROUGHT IN CASE OF RAIN OR EXTREME HEAT.** Exhibit spaces will be approximately 15' x 20'. All materials/supplies/exhibits must be contained within the allotted 15' x 20' space. **Any display that exceeds 15' x 20' will require the purchase of two spaces.**

FEE SCHEDULE: **Friday, May 1: \$300; Saturday, May 2: \$300 OR both days: \$500 After April 4: \$400.00 per night.**
Upgrade of \$50 per day for power hook up (limited availability).

APPLICATION PROCEDURE: An entry fee and a signed registration form must accompany each application. Make checks payable to Prattville Chamber. Checks will be deposited upon receipt. **PLEASE DO NOT SEND CASH.**

REFUND POLICY: The space fee will be fully refunded to exhibitors who are not selected. Those applicants accepted by the selection committee will be sent space assignments, maps, and other pertinent information after April 17, 2026.

ENTERTAINMENT: Prattville CityFest has live, continuous stage entertainment. Continuous children's games and activities are conducted in a designated children's area.
