## Holiday Meals and Food Scraps

Installation of garbage disposals is not allowed at Watertree. When you prepare (or clean up) meals, take care to dispose of large food scraps properly: in the trash. Our pipes are sensitive and cannot handle much besides water. Vegetable peels, grease, or other non-water things often cause plumbing issues.

## Plowing Protocol

Winter is approaching, bringing snowplowing and sidewalk clearing. Please allow space for this work when snowfall is anticipated: Park cars in the middle or back row of the lot, leaving the front row by the sidewalk open for plowing. Once the lot is plowed, you are welcome to park as usual. If you do not go out first thing in the morning to move your car, then please don't park in the front row the night before when snow is falling or anticipated. Please be courteous when clearing off your car: brush off the snow so that it does not fall onto the sidewalks.




## Traveling Out of Town

If you plan on traveling for a few days, arrange to store your car where it will not block snowplowing or leave a car key with a trusted neighbor who will move your car. Also leave a house key with a trusted neighbor or the office. During cold seasons, leave your thermostat at 55° or higher, and leave cabinet doors open so warm air can circulate to the pipes under each sink.

## Winter Parking & Storage

Note that in addition to the protocols above, no parking area at Watertree can be used for storage of any vehicle in excess of 5 days. See House Rules Section 10 for more info.
