"Be still, and know that I am God."

- Psalm 46:10

A New Beginning: Carmen's Journey to Safety and Self-Reliance

Carmen Ortiz was born in Charco, Nariño, Colombia. At 11, her family relocated to Buenaventura, where she finished high school & watched her father build a small business. Violence in the region forced the family to move again—this time to Bogotá, in search of safety & stability.

In Bogotá, Carmen reconnected with a child-hood friend who became her life partner. Together, they launched Frutería, a fruit-selling business Carmen successfully operated for 17 years. During that time, she became a mother to her son, Adiel Jesús.

In 2023, violence again disrupted their lives. Fearing for their safety, Carmen & Adiel fled to Ecuador & applied for asylum through the International Organization for Migration (IOM). Life in Ecuador was hard.

"We were homeless. I had to sleep with my son under a bridge," she recalls. "He got sick & had to be hospitalized."

After more than a year, IOM helped process their immigration status and arranged travel to the U.S. In July 2024, they arrived in Houston-exhausted, hungry, & unsure of what came next. The guide assigned to help them was rarely available. Desperate for help & food, Carmen approached airline staff to ask about a delayed flight.

"We were so hungry. I just wanted to know when our flight would leave & instead, three employees brought us full meals. I started to cry. I had just arrived, & people were already helping me."

Their flight to Des Moines departed at midnight & landed at 2 a.m., where they were welcomed by Chuck, a caseworker from LSI. He brought them to a hotel, where Carmen remembers feeling overwhelmed.

"I was scared & confused. I remember thinking: Are we safe? Are we okay?"

Sixteen days later, LSI helped Carmen & Adiel move into their first apartment. From that point, life began to change. Carmen enrolled in English classes, received assist-ance with legal paperwork, healthcare, & food and soon found two jobs: at Sam's Club & Des Moines Public Schools.

"I'm incredibly grateful. LSI helped me with everything."

But life without a car in a Midwestern winter was difficult. Carmen walked long distances through the snow, waited for buses, or spent \$60 a week on rideshares, just to get to work & get her son to school. During a routine checkin, Carmen's caseworker Shaima heard about these challenges & referred her to Duaa, an IDA Specialist at LSI. Duaa introduced her to the matched savings program, which helps participants purchase essential assets—like a car—thru financial education & support.

"I'd wake up my son very early so we could catch the school bus from our old address. Then I'd rush to work & still be late."

Carmen had already saved \$2,000 on her own, knowing a car would be vital for her family's stability. Through LSI's Individual Development Accounts program, she opened an account at Veridian Credit Union, completed budgeting & asset-specific classes, & received one-on-one coaching from Juan Lourido, Business Development Specialist at LSI. Juan helped her understand financing, credit, & how to identify reliable used cars online. With his help, Carmen purchased a safe, fuel-efficient 2015 Toyota Prius that fits her family's needs & budget. "I never thought I could buy a car especially one that was safe & good quality. It means everything to me."

She also opened a secured \$500 credit card to begin building her credit history.

"These classes helped me prepare for when income slows down in the summer.



I feel independent now, especially with the car." Today, Carmen is preparing for her driving test, building a new life, & planning for the future.

"When we left Colombia, we were running from threats & violence. Now I'm getting used to a new life, looking for opportunities to grow, maybe buy a house, & support my son's education."

When asked to describe her journey in one word, she answers without hesitation:

"Apoyo" — Support.

Conclusions from the Survey for the Church Sign Replacement or Updating

- 1. A majority of the members responding wished to have the Church Sign in the same place as it is currently. Reusing the old sign foundation would save money.
- 2. The members that responded on moving the church sign suggested the sign be moved further south on the property, and possible set at an angle. Very small response.
- 3. A majority of the members responding wished to have the brick/mortar flower locations at the south end removed. This removal would be greatly appreciated by both the snow removal crew and the lawn mowing crew. Also, the members who water the flowers have a lot of work watering the flowers with the small amount of dirt in the planters.

Comments in point 4 and 5 are interrelated in regards to the type of sign desired as a replacement.

- 4. A smaller majority of the members responding wished to have a brick and mortar sign as we currently have with replaceable letters and in sign lighting.
- 5. A larger majority of the members responding wish to have an electronic sign that changes messages and can be updated by wifi from the office.
- 6. Most members responding were willing to participate in fundraising for a new church sign.
- 7. Most members agreed with the \$5,-10,000 electrical update to support the sign update.
- 8. Most members agreed with the \$25-35,000 sign update price estimates.
- 9. Most members agreed with the June 2026 project start date.

Meeting called to order at 10:22 a.m. Angie R-H offered Devotions.

Angie S. presented the April Minutes for approval. Ann made a motion to accept the minutes as presented; Travis seconded. No discussion. Motion passed.

Rick presented the Treasurer's Report. He presented the April checks written and the April journal entries. Ann made a motion to accept the April financial information as presented; Travis seconded. No discussion. Motion passed. Rick then presented the May checks written and the May journal entries. Ann made a motion to accept the May financial information as presented; Travis seconded. No discussion. Motion passed.

Rick noted that after doing a ten-year financial comparison that this is the first time the church has been in the black in May and that the church's income is at its highest. Ann requested that monies from the Lenten suppers be moved to the Dinner and Special Events fund. Angie S. made a motion to relocate the funds; Abby seconded No discussion. Motion passed.

Pastor made the Council aware of several issues at the Parsonage. The dishwasher and the clothes washer were recently replaced for a total around \$1,200. One dehumidifier in the house was replaced last year and the other one needs to be replaced. He also noted that the light/exhaust fan in the master bedroom needs to be replaced. There was discussion about using Renew and Restore funds for

these projects. There was also discussion about canceling the monthly maintenance/repair contract and putting that money into a fund to handle future repairs.

Pastor listed new members to be received June 29th. Ann will get baskets ready to give to new members June 29th. Ann made a motion to accept the new members to be received; Abby seconded. No discussion. Motion passed. Additional discussion included the Council being informed that Connie V. will have a knee replacement June 24th and will be off work six or seven weeks. Angie R-H will put out chore signup sheets for members to help out while Connie is away. Pastor Tim's review has been scheduled for Sunday, June 29 at 11 a.m.

No report from Pat or Ann.

No report from Kelsey though it was noted that, instead of Vacation Bible School, the church will sponsor two "Fun Nights" in July.

Abby reported outdoor worship services will be held the third Sunday of the month in June, July and August. She said hymns have been selected for June, July and August.

No New Business or review of church policies.

Another Community Meal is being planned for the next time St. Petri serves at Loaves and Fishes, Saturday, July 19.

Meeting adjourned at 11:45 am. and closed with the Lord's Prayer.
