We collect personal information through:

We do not sell, rent, or share your personal information with third parties for marketing or promotional purposes.

### Required A2P Compliance Language

No mobile information will be shared with third parties/affiliates for marketing/promotional purposes. Information sharing to subcontractors in support services, such as customer service, is permitted. All other use case categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

We may share personal information only in the following limited circumstances:

- **Service Providers:** Trusted vendors who assist in operating our business and services
- **Legal Requirements:** When required by law, subpoena, or legal process
- **Protection of Rights:** To protect our rights, users, systems, and services

Any service providers receiving information are contractually obligated to maintain confidentiality and use the data solely for authorized business purposes.
