

ORDINANCE NO. 2025-06

ORDINANCE LEVYING AND ASSESSING 2025 TAXES
PALOS FIRE PROTECTION DISTRICT

BE IT ORDAINED by the Board of Trustees of Palos Fire Protection District, Cook County, Illinois, in a public meeting on November 18, 2025, as follows:

Section One. The sum of Eight Million Eight Hundred and Ninety Eight Thousand Dollars (\$8,898,000) is assessed and levied from and against upon all of the taxable property within the limits of Palos Fire Protection District as the same is assessed and equalized for State and County purposes in the current year 2025, and which ordinance is in compliance with publication requirements as provided by law. The specific amount hereby levied is set forth under the column captioned "Amount To Be Raised by Levy," as follows:

Section Two. On October 21, 2025, there was a Resolution adopted by the Board of Trustees estimating and determining the amount to be levied. This was not less than 20 days prior to the adoption of this aggregate levy, for sums necessary to defray all necessary expenses and liabilities of the district as required by statute.

SECTION Three. That the Secretary of this District is hereby directed to file certified copies of Ordinance 2025-06 with the County Clerk of Cook County, Illinois, that sets forth the amount of taxes hereby levied.


