- One-person removal within 20 miles of the Solano office
- Refrigeration
- Basic Alternative Container - \$80.00 (plus tax)
- Simple Plastic Utility Urn - \$10.00 (plus tax)
- Cremation up to 300 lbs

If you want to arrange a direct cremation, you can use an alternative container.

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).
