

- WORDS FROM THE PRESIDENT -

Being about the Business of Serving Others

"O God...we thank Thee for Thy Church, founded upon Thy Word, that challenges us to do more than sing and pray, but go out and work as though the very answer to our prayers depended on us and not upon Thee."

Ten months ago, I was bestowed the honor of taking leadership of this great organization. Reluctant at first, my mind raced through all of the things that a position like this would entail - leading others, organizing people, facilitating activities, speaking up and advocating for social justice. You see, our organization prides itself on furthering the ideals of the late Dr. Martin Luther King, Jr. How exactly would I do that? Well I came to the conclusion that my focus would align with that of the original vision of our founder - to be about the business of serving others.



Here's the thing. I grew up inside of this organization as a little girl. I trampled up the steps of Ebenezer Baptist Church West with my mother and sat in the same room that doubled as my Sunday School classroom, and listened as the grown-ups planned events and trainings, discussed strategies, and shared their vision. Our founder, Rev. David H. Nunnally, Sr., was alive then, and he was a steadfast believer in being about the business of serving others. As I grew older, he became one of my mentors; and anyone who knew Rev. Nunnally knew that when you were under his tutelage, he was going to put you to work (but always in the service of others). And put me to work he did, along with friends that I drafted to help me. We cleaned yards of the elderly. We swept streets and parking lots. We packed goodie boxes for the poor. We hosted youth pow-wows and teen panels. One year we even went caroling through the neighborhood to lift people's spirits. Each summer, we would attend a week-long workshop at a different HBCU to discuss justice-related issues and visit Civil Rights sites. We worked hard and we had fun, but most of all we were about the business of serving others. Rev. Nunnally understood the mission, and I often think that it was his calling to teach it to us. Be about the business of serving others. To Rev. Nunnally, how many people were going to help was irrelevant. Having enough money on-hand was irrelevant. Even time itself was irrelevant. "Lawson," he once quipped to me, "When you have too much time to do something, that just gives you more time to mess it up." Like King, Rev. Nunnally was a man of action! We asked God for help. Then we rolled up our sleeves.

So what will be the focus of our organization during my tenure? We will follow the example that Rev. Nunnally set. We will be about the business of serving others. We will serve others through word and deed - forums and volunteer service. We will serve others through education and training. We will serve others through advocacy. As I traverse a new path, I hope that you will join us in our quest to Be about the Business of Serving Others.




“MISSION POSSIBLE II: BUILDING COMMUNITY,

Martin Luther King, Jr. was tenacious in his fight on poverty and injustice. According to author and scholar Jonathan Rieder, King came to Birmingham on Good Friday in 1963 believing that mass protests could overturn Jim Crow laws. That night, King was arrested. “Alone in his cell, reading a newspaper, he found a statement from eight "moderate" clergymen who branded the protests extremist and "untimely." King drafted a furious rebuttal that emerged as the "Letter from Birmingham Jail.”



“MY DEAR FELLOW CLERGYMEN: While confined here in the Birmingham city jail, I came across your recent statement calling my present activities "unwise and untimely." Seldom do I pause to answer criticism of my work and ideas. If I sought to answer all the criticisms that cross my desk, my secretaries would have little time for anything other than such correspondence in the course of the day, and I would have no time for constructive work. But since I feel that you are men of genuine good will and that your


criticisms are sincerely set forth, I want to try to answer your statements in what I hope will be patient and reasonable terms... I am in Birmingham because injustice is here... Just as the prophets of the eighth century B.C. left their villages and carried their "thus saith the Lord" far beyond the boundaries of their home towns...so am I. compelled to carry the gospel of freedom...I am cognizant of the interrelatedness of all communities and states. I cannot sit idly by in Atlanta and not be concerned about what happens in Birmingham. Injustice anywhere is a threat to justice everywhere. We are caught in an inescapable network of mutuality, tied in a single garment of destiny. Whatever affects one directly, affects all indirectly. Never again can we afford to live with the narrow, provincial "outside agitator" idea. Anyone who lives inside the United States can never be considered an outsider anywhere within its bounds...

We know through painful experience that freedom is never voluntarily given by the oppressor; it must be demanded by the oppressed. Frankly, I have yet to engage in a direct-action campaign that was "well timed" in the view of those who have not suffered unduly from the disease of segregation. For years now I have heard the word "Wait!" It rings in the ear of every Negro with piercing familiarity. This "Wait" has almost always meant "Never." We must come to see, with one of our distinguished jurists, that "justice too long delayed is justice denied." We have waited for more than 340 years for our constitutional and God-given rights...

UNITING A NATION THE NONVIOLENT WAY.”

You express a great deal of anxiety over our willingness to break laws. This is certainly a legitimate concern...One may won ask: "How can you advocate breaking some laws and obeying others?" The answer lies in the fact that there are two types of laws: There are just and there are unjust laws. I would be the first to advocate obeying just laws. One has not only a legal but a moral responsibility to obey just laws. Conversely, one has a moral responsibility to disobey unjust laws. I would agree with St. Augustine that "an unjust law is no law at all"... In no sense do I advocate evading or defying the law...That would lead to anarchy. One who breaks an unjust law must do so openly, lovingly...and with a willingness to accept the penalty. I submit that an individual who breaks a law that conscience tells him is unjust and who willingly accepts the penalty of imprisonment in order to arouse the conscience of the community over its injustice, is in reality expressing the highest respect for law... We should never forget that everything Adolf Hitler did in Germany was "legal" and everything the Hungarian freedom fighters did in Hungary was "illegal"...

I must confess that over the past few years I have been gravely disappointed with the white moderate. I have almost reached the regrettable conclusion that the Negro's great stumbling block in his stride toward freedom is not the White Citizen's Counciler or the Ku Klux Klanner, but the white moderate, who is more devoted to "order" than to justice; who prefers a negative peace which is the absence of tension to a positive peace which is the presence of justice; who constantly says: "I agree with you in the goal you seek, but I cannot agree with your methods of direct action"; who paternalistically believes he can set the timetable for another man's freedom; who lives by a mythical concept of time and who constantly advises the Negro to wait for a "more convenient season."



Shallow understanding from people of good will is more frustrating than absolute misunderstanding from people of ill will. Lukewarm acceptance is much more bewildering than outright rejection... Such an attitude stems from a tragic misconception of time, from the strangely rational notion that there is something in the very flow of time that will inevitably cure all ills. Actually, time itself is neutral; it can be used either destructively or constructively. More and more I feel that the people of ill will have used time much more effectively than have the people of good will. We will have to repent in this generation not merely for the hateful words and actions of the bad people but for the appalling silence of the good people. Human progress never rolls in on wheels of inevitability; it comes through the tireless efforts of men willing to be co-workers with God, and without this 'hard work, time itself becomes an ally of the forces of social stagnation. We must use time creatively, in the knowledge that the time is always ripe to do right. Now is the time to make real the promise of democracy and transform our pending national elegy into a creative psalm of brotherhood. Now is the time to lift our national policy from the quicksand of racial injustice to the solid rock of human dignity..."

**LISA LOTT****CHIEF JUDGE OF THE SUPERIOR COURT, WESTERN JUDICIAL CIRCUIT**

Lisa Lott is the Chief Judge of the Western Judicial Circuit, a circuit composed of Clarke and Oconee Counties. She was elected to the bench and sworn in as a Superior Court judge in 2018.

Judge Lott graduated from the Emory School of Law in 1994. She began her career as a prosecutor in the Gwinnett County District Attorney's Office. She has also served as the staff attorney for the Council of Juvenile Court Judges and as the lobbyist for the Georgia Indigent Defense Council. She served as an attorney in the Western Judicial Circuit Public Defender's Office from 2000-2018, where she specialized in juvenile court proceedings. She was the Chief Assistant Public Defender when she was elected judge in 2018.

Judge Lott is the proud mother of two Clarke Central High School graduates, and is married to former State Senator Doug Haines.







PAST PRESIDENTS OF THE ATHENS AREA

HISTORY OF THE HUMAN RELATIONS COUNCIL

The Athens Area Human Relations Council was founded by Rev. David H. Nunnally, Sr. in 1979. His idea was to implement a series of programs designed to keep the dream of Dr. Martin Luther King alive in the Athens, Georgia. He asked the members of his local chapter (Eta Iota Lambda) of the Alpha Phi Alpha Fraternity, Inc. to accept the idea as a service project in honor of their late brother, Dr. Martin Luther King. The members encouraged him to move forward with the programs and to serve as the chairman of the committee. The purpose was to organize activities, recognize the contributions of individuals from the Athens area who had done outstanding service for humanity and to implement a youth program, a scholarship program, an Ecumenical, and Leadership program. These programs would foster the philosophy and dreams held by the late Dr. Martin Luther King, Jr. during his lifetime - universal brotherhood, respect for all races of mankind, and the spread of love and non-violent social change as well as peaceful co-existence throughout the world.

Rev. Nunnally sought and found others who were dedicated to keeping these goals and dreams alive. During this time period, four annual events were sponsored: the Ecumenical Service to honor Dr. King, the Adult Leadership Conference, the Youth Rally, and the Martin Luther King, Jr. Youth Leadership Seminar. These activities were carefully designed to bridge the gap that existed between the races in the Classic City. The scholarships and the service awards were presented during the Ecumenical Service and were awarded to the most qualified candidate regardless of race, creed or color. Ebenezer Baptist Church West provided the meeting places for all events for the first three years. During the 1982-1983 years, two important additions were made which were destined to shape the future of the Human Relations Council - the establishment of a Human Relations Awards Banquet and the inclusion of members from ten different counties in Northeast Georgia. These two changes helped to create a broader range of candidates for the awards given by the Council. Later on, Rowena McCoy would go on to suggest that the Youth Rally be changed to the name Youth Pow-Wow.

HUMAN RELATIONS COUNCIL, INC.

The Original Founders of the Athens Area Human Relations Council were Jessie Barnett, Ileane Nunnally, Rosa Rittenberry, Lady Long, Melissa Tate, Henry Morse, Dr. Winfred M. Hope, Mayor Lauren Coile, and Dr. Ronald Schoeffler. Active Member of Eta Iota Lambda Chapter of Alpha Phi Alpha in 1979 were David H. Nunnally, Sr., Milton Hill, Walter V. Jackson, Hugh Goodrum, Wilber Jones, Lamar Kidd, James Holston, Sr., James Alford, Jr., James McCoy, John W. Townsend, Jr., Robert Harrison, Joseph Greene, Kenneth Dious, Willie E. Walker, Ambrose McDow, Marion Stroud, and Edward Shelton.

THE FIRST BANQUET

The first Human Relations Council Banquet was held in 1982 at fellowship hall of First A.M.E. Church where the Rev. Roosevelt Morris was pastor. Dr. John W. Townsend was the keynote speaker. The title of his speech, "What Color is a Dream?", was in line with the spirit and ideas of the Council. His speech was captivating and maintained that all people are brothers and sisters and only the weak are separated by color and race. The meal that evening was Fried Chicken, English Peas, Cream Potatoes, Rolls, Apple Pie, Punch and Coffee. The price per person was three dollars. Some people ate without paying. The cooks for the occasion were Ms. Sarah Jones and Mr. Willie Robinson who volunteered their services. The manager of Bell's Food Market helped to make it possible for Rev. Nunnally to purchase the food. He got the food supply on credit because the Council had no money to make the purchase. With the encouragement of Dr. Ronald Schoeffler, Rev. Nunnally moved forward in making the meal he had planned a reality. When asked about the first banquet Rev. Nunnally quickly points out, "There were doubters who feared that the banquet would be a failure, too big of a task to be successful. I knew with God's goodness and the many ambitious people behind the idea of unity and goodwill, this project would be a success. Dr. Ronald Schoeffler and I prayed about this many a night. We knew it could only be a success." The event was well attended and the crowd of over two hundred fifty inspired the leadership to dream even bigger.

ABOUT OUR FOUNDER

REV. DAVID H. NUNNALLY, SR. (1929 - 2015)

There are few people who have had as much drive, determination and dedication as the late Rev. David H. Nunnally, Sr. Rev. Nunnally's commitment to his community spanned over 60 years beginning with his entrance into Tuskegee University. While there, he served as Leader & President of the Tuskegee Institute Red Cross Chapter, providing student volunteer services weekly. Although he abhorred violence, he was drafted into the Korean War and agreed to serve upon consulting the guidance of his mentor, the education and civil rights giant Dr. Benjamin E. Mays. Upon returning to Athens he continued his involvement with the Red Cross, serving as secretary of the Athens Chapter under the guidance of Dean Tate. Afterwards he continued to work tirelessly, simultaneously volunteering in various capacities throughout Athens.



One of 14 children born to Henry & Ida Nunnally, Rev. Nunnally was especially dedicated to youth and to education. He taught at both the Rosenwald School and the E.D. Stroud School. He also served as the Athens representative for the NDEA Desegregation Institute in 1957 and served as camp coordinator of the Phyllis Wheatley Association. In his later years, Rev. Nunnally served as a member of the Clarke County Board of Education, serving 10 years before stepping down due to health concerns. He could be found encouraging youth in his work with the Boy Scouts of America (an organization with which he was affiliated from 1961 until his death in 2015). He was one of the founding members of Athens area alumni chapter of the Alpha Phi Alpha Fraternity and helped start a chapter on the UGA campus in 1969. Rev. Nunnally's volunteer efforts included the Butler Street YMCA, NE GA Advisory Committee, Athens Lions Club, Veterans of Foreign War, Georgia Human Relations Council, Southern Christian Leadership Conference, Clarke County Heart Fund, March of Dimes, Heritage Nursing Home and the Reach Out & Touch Club among others.

In 1979, Rev. Nunnally implemented a series of programs designed to keep the dream of Dr. Martin Luther King, Jr. alive. He sought out others who had a similar vision. It was then that he founded the organization known as the Athens Area Human Relations Council (AAHRC). Perhaps the truest testament to Rev. Nunnally's character and persistence is the story of the organization's first banquet. Because the Council was in its infancy, there was no money to purchase food or to rent a banquet hall. Never one to be deterred, Rev. Nunnally approached the manager of Bell's Food Market to explain the predicament and to see if he would allow him to get the food supply on credit. Knowing

Rev. Nunnally's previous good works in the community, the manager simply turned to the cashier and said, "Give him anything he needs." With the food in place, he went on to find a couple who volunteered to prepare the meal free of charge; and the pastor of First A.M.E. Church volunteered the church's fellowship hall as the banquet site. More than forty years later the AAHRC still hosts an annual banquet which is used to award scholarships to students and community service awards to volunteers.

This is a powerful statement on what one can accomplish when one applies action to a hope and a dream. Rev. Nunnally was once questioned on his belief that it was never too late to do anything. He simply replied, "When you have too much time to do something, that just gives you more time to mess it up." All told, Rev. Nunnally was the embodiment of all the attributes which one admires in a community leader. He constantly found new challenges and endlessly continued to give support to those in need.

KEY EVENTS IN AAHRC HISTORY

(1979 - 1987)

- The Athens Area Human Relations Council was founded in 1979
- 1st Ecumenical Service in honor of Martin Luther King held; the 1st scholarships would later be awarded at this service, with each scholarship being \$100
- A series of events are implemented including an Ecumenical Service, Adult Leadership Conference, and Youth Rally
- In 1982, the first awards banquet is held at First A.M.E.

(1987 - 1996)

- 1st fund-raising campaign is started to cover event expenses
- For the 1st time, scholarships are awarded at the banquet instead of the Ecumenical Service
- The Council incorporates and later receives recognition from govt. as being a non-profit 501(c)3 organization
- The banquet # exceeds capacity and is moved from the fellowship hall of First A.M.E. to the UGA Georgia Center
- The Council is successful in having Water St. and Hobson St. renamed MLK Parkway

(1996 - 2003)

- 1st proclamation is issued from mayor acknowledging Martin Luther King, Jr.'s contributions to society and proclaiming a MLK Jr. Day in Athens-Clarke County
- The banquet# again exceeds capacity and is moved from the Georgia Center to the Classic Center in Downtown Athens

(2003 - 2011)

- 1st female is elected as president
- A series of events are implemented including Community Clean-ups, Teen Summit, and Parent Forum
- Creation of the council website and e-mail is commissioned
- The council travels to Selma, Alabama where it is presented the key to the city by Mayor James Perkins
- 1st pledge campaign is initiated to secure long-term donors
- The Rev. David H. Nunnally, Sr. Founder's Award is implemented

- The Rev. David H. Nunnally, Sr. Scholarship is implemented

She is a Certified Peer Specialist in Mental Health and Addictive Diseases, a Medication Assisted Treatment Specialist, a Certified Addiction Recovery Empowerment Specialist, a Whole Health Wellness Coach, and a Forensic Pyramid.

In recognition of her significant contributions to the recovery community, Paula received the Champion of Hope award in 2023. As a passionate community leader, she chairs meetings to promote collaboration and awareness around recovery initiatives. Additionally, Paula has successfully coached over 20 residents, assisting them in obtaining their Certified Peer Specialist certification, thus fostering a new generation of recovery advocates.

Currently serving as a Certified Peer Coach at the DM & ADR Athens Clinic, Paula leads with her lived experience, offering invaluable support and guidance to individuals navigating their paths to recovery. Her dedication to resilience, empowerment, and community well-being continues to have a profound impact on those she serves and makes her a worthy recipient of the Rev. David H. Nunnally, Sr. Founder's Award.

Lamar Handy



Dennis Lamar Handy is the founder of The DL Handy Foundation, Inc., an organization which focuses on three pillars - Mental Health Awareness, Scholarships, and Community Empowerment. Under his leadership, the foundation began hosting community panel discussions educating the community on mental health resources and support, leading with the motto “*It’s Okay to Not Be Okay*”. The foundation has hosted panel discussion throughout Northeast Georgia, the metro Atlanta area, Augusta, and Charlotte, NC. In 2023, Lamar raised over \$8,000 for “Friends of Advantage” of Athens, GA a non-profit that provides services for those suffering with mental illness and other life crises.

Lamar prides himself in rendering service and giving back, especially to his hometown of Athens, GA, which he loves so dearly. When people ask, “Why give back to Athens Clarke-County?”, his response is “Athens Clarke-County is what helped shape and mold me into the man I am today. There’s so much greatness in Athens, yet there’s a need for extra care to pour back into the community.”

Lamar’s foundation work also focuses heavily on education, awarding two scholarships annually - The Ashantye Williams Scholarship, named in honor of his late cousin, and The DL Handy Foundation Scholarship. The organization has awarded over \$5,000 in scholarships over the last 3 years.

In July of 2023, The DL Handy Foundation, Inc. partnered with the 7th District Georgia Funeral Service Practitioners Association to host the first “*Rally of Hearse, Rally up, Guns Down*” Parade against gun violence. The parade featured hearses, motorcycle clubs, the Athens Clarke County Police Department, and the Athens Clarke County Sheriff Department. It was designed to build community awareness around gun violence. Mothers who experienced a loss were able to share stories of how they have survived after such a tragic loss. After the 2nd Annual Rally Up, Guns Down Parade, Athens-Clarke County Mayor Kelly Girtz named the 4th Sunday of July “Rally Up, Guns Down” Day in observance of Gun Violence Prevention Day.

Lamar is the proud son of Dennis A. Handy and Brenda Stewart (Howard). He’s the brother of Dr. DeAnn Walter and continues to be an example for his two nephews: Elijah Ace and Noah Alexander Walter. His integrity for being honest in all that he does was instilled by his grandmother, Julia M. Handy, whom he gives all the credit for instilling in him, his sister and cousin as children the importance of education. He is forever thankful for the love and encouragement of his grandfather James E. Jones.

For his dedication to community, Lamar is a fitting recipient of the Athens Area Human Relations Council Community Service Award.
