Contributions and Revenue

1. Contribution revenue for October was \$ 136,173. Slightly ahead of September, 2025.
2. The contribution budget for October was \$ 160,000.
3. The October contribution revenue showed a \$ 23,827 NEGATIVE VARIANCE.
4. October 2025 contributions were above September 2024.
5. Total revenue for October was \$ 193,692 which was also below budget largely to the lower contribution income but exceed the total revenue for September 2025.
6. Monthly giving for November was up by \$8,363 (as of 11-24-25) due to contributions exceeding the budgeted amount during the first and third weeks.

Expenses

1. Total October expenses were \$ 231,097.
2. The total October expenses were \$ 4,416 over budget or 0.2%
3. Expenses were well under control for October.

YTD Revenue

1. YTD revenue was \$ 2,145,266 against a budget of \$ 2,232,129.
2. YTD revenue budget NEGATIVE variance of \$ 86,863.
3. The largest contributor to the negative YTD revenue was a contribution YTD revenue shortfall of \$ 109,069.
4. The YTD revenue shortfall has been partially mitigated by increases in OTHER income.

Reserves

1. The financial reserves of the church remain strong at \$ 3.4 million.

6) Church Report from Rev. Dr. Neil Thomas

- a. Much was covered in the town hall but feeling confident that we are moving forward strongly in 2026
- b. 2026 theme is “Being Grounded”
- c. Will spend the first couple of months identifying a firm to guide us in strategic planning
- d. Last quarter of 2026 – is the target to have a plan for the next 5 years
- e. Digital footprint is growing (both worship and Believe out Loud).

- f. Newsletter open rate is around 40% - most nonprofits are around 10%
- g. Worship attendance has bounced back and is around 856.
- h. Spanish speaking congregation continues to remain unsteady
- i. COH is producing letters to confirm attendance
- j. Life Groups we well attended and a new Life Group was added
- k. Celebrate goals achieved for Thanksgiving Baskets (582 baskets were created and raised at least \$16,000 for baskets).
- l. We exceeded our largest Sunday ever (over \$4,600)
- m. This replenishes the Thanksgiving Basket fund that was depleted a couple of years ago
- n. Staff is evaluating not only what we do but why we do it and we are seeing the results of this.
- o. Impact story:
 - i. Rev. Jeremy invited a spouse to come to the TDOR service and came to the membership class saying “I never believed a church like this existed” speaking to the way we invite and make all feel welcome.
- p. Dallas Bears and Lonestar Court delivered 2 full tables of food and raised \$1600 and Hidden Door gave \$4,000. Dallas Voice delivers their food drive to us as well.
- q. Question: Congregants hearing about taking advantage of food programs. How is this going to work?
 - i. Announcement and flyer will be provided on Sunday including downloading the app to make it anonymous and discrete.
- r. As people are furloughed and accessing the outreach ministries, mental health is shifting downward with many affected people.

7) Continuing Business:

 - 1. January 5 is target date to start depending on equipment being delivered.
