

After a brief pause during the pandemic, the Forward with Faith campaign resumed in September to ensure our long-term investment in the spiritual and financial wellbeing of our parishes, schools and ministries. Sixteen parishes actively engaged in Block 2 of the campaign during this time, leveraging ZOOM meetings and social distancing to overcome the barriers we have faced due to COVID-19. Our supporters responded very generously with the average gift doubling throughout Block 2.



Parish Spotlight:

A Special Celebration for the Basilica of the Immaculate Conception in Waterbury started its campaign with big plans to increase church accessibility through the installation of an elevator and a vision to convert its lower church space into a new Parish Center. In addition to exceeding its fundraising goal, this parish celebrated the Beatification of Father Michael McGivney, founder of the Knights of Columbus. Father McGivney said his very first Mass at Immaculate Conception and his feast day will be observed August 13 in the Archdiocese of Hartford.

EMERGENCY RESPONSE FUND DISBURSEMENTS

More than 30 parishes and ministries have received \$500,000 in grants from The Hartford Bishops' Foundation for emergency and operational needs in response to COVID-19.

When sacramental life paused in March, HBF established an Emergency Response Fund to gather and distribute emergency funds to mitigate operating losses experienced by parishes and ministries.

Through these funds, the HBF directed emergency grants, providing vital services to individuals with the greatest need.

HBF also partnered with the Archdiocese of Hartford and quickly offered technical assistance to more than 100 parishes, helping to set up online giving, live streaming Masses, and parish social media channels.



Since its founding, The Hartford Bishops' Foundation has awarded more than \$5.7 million in grants to Catholic and community-based initiatives across the region. This year was the largest grantmaking year since HBF was founded in 2016. Thanks to supporters of the *Forward with Faith* Campaign, more than \$2.4 million was awarded in 2020 to support local community needs, innovative new Catholic education and evangelization programs, and COVID-19 emergency response services across Litchfield, New Haven and Hartford Counties.



INVESTMENTS IN VIBRANT PARISH COMMUNITIES

Over **\$1.2 million** was distributed in direct rebates to parish communities for their own local needs in 2020. These funds provided vital resources to parishes for faith formation and evangelization programs, technology, capital needs, social service outreach, and other important local initiatives. In addition to the parish rebates, the remaining grants distributed by The Hartford Bishops' Foundation throughout 2020 in support of innovation, Catholic education, social services, and emergency needs are flowing back into the parish communities to support their long-term vibrancy.



2020 CT GOLF CLASSIC

The 2020 Hartford Bishops' Foundation's Connecticut Golf Classic grossed \$236,350 to establish a stationary medical clinic for Malta House of Care, a nonprofit health organization. Malta provides free primary healthcare to uninsured adults on a clinic van that visits four Hartford-area neighborhoods per week. The new brick-and-mortar medical clinic will enable Malta to more than double the number of patients it serves.
