For more than 45 years, Theatre UP has been creating exceptional theatre experiences that enrich our community - a mission that goes far beyond entertainment. We produce award-winning performances, provide transformative educational opportunities, and serve as a gathering place for connection, self-expression, and belonging.

Rooted in Littleton and reaching across the North Country, Theatre UP is powered by local talent, regional partnerships, and a belief that creativity is at the heart of healthy communities. Every show, class, and collaboration reinforces our brand promise: To be a place where people come together to be seen, heard, and inspired.

### **About the Project**

We are renovating the historic Masonic Temple located at 137 Main Street in downtown Littleton into a vibrant location that will house:

- Dedicated classrooms and workshop space for our growing Theatre Education Academy
- Theatre UP's main offices
- A flexible performance space and rehearsal studios
- Production and administrative infrastructure to support year-round programming

Already more than 75% funded, this \$4.6 million project will deepen our impact and expand our reach — welcoming more than 3,200 annual audience members, 200 students, and dozens of artists, technicians, and volunteers from over 50 towns in seven NH counties.

We are now offering \$500,000 in New Hampshire CDFA tax credits over two years to complete Phase I and open the doors of the renovated building in time for the Littleton Arts Festival in September 2026.
