- C. If your entry is received after February 18th, you will need to become a parade sponsor to be included in the parade.
- D. Entry fee for Elmhurst residents and/or Elmhurst businesses is \$100 Entry fee for non-residents and/or non-Elmhurst businesses is \$295 The entry fee has nothing to do with parade sponsorship. Your overall assistance is needed & welcomed for a successful parade.
- E. The earlier you send back your forms the better chance your entry will have to be included in Pre-Parade Publicity, on our website & social media.
- F. If you have cars as part of your entry, we are limiting the number of vehicles to two (2).

--- Rules and Condition of Parade Participation ---

Please pay particular attention to the following guidelines. They are for everyone's benefit & safety.

- 1. Throwing candy from vehicles or floats along the parade route is prohibited. This creates a very dangerous situation for youngsters running into the middle of parade entries and vehicles. Walkers must distribute candy or novelty items/promotional materials curbside in a safe manner. Your participation in next year's parade will be denied if your group is identified as having ignored this request.
- 2. You will not be able to enter staging area from the north if you are driving a vehicle.
- 3. When you enter staging area, know your Parade line-up position. You will find your line-up position listed on the official parade website on March 1st, 2022. This will detail your assigned line-up spot. Parade marshals will be available to assist you on the day of the parade.
- 4. To avoid confusion, tell "everyone" in your group what the staging number is and the house address on Spring Road. (ie., 873 is 873 Spring Road)
- 5. Please keep your group at your assigned Parade line-up position.
- 6. If you are considering changing the makeup of your entry, please call & ask for permission. For example, if you are going to bring in a vehicle which was not included in your entry form, we need to know this in order to allocate enough space in the staging area.
- 7. Tell your marchers that they can park on any side street that runs north & south which is east or west of Spring Road & then walk to the staging area.
- 8. Please decorate your vehicle to match the day's event. This makes for a much more colorful parade.

The entry fee has nothing to do with parade sponsorship. Your overall assistance is needed & welcomed for a successful parade.

All Sign Bearers should keep about 25 feet away from preceding units. Other units should allow 20-30 feet between units to avoid delays.

Please note that on the day of the parade anyone arriving late will be placed at the end of the parade.

We hope your group has been planning a wonderful parade unit, and that your participation this year will be truly memorable.
