## Medical Complication and Travel Insurance for International Medical Travelers & Travel Companions

Specifically designed for international travelers who plan to have elective **Medical or Dental Procedures/Treatments**



### Global Protective Solutions programs are specifically

designed for international medical travelers and their travel companions. The travel benefit program includes coverage for normal travel related activities as well as wide-ranging benefits in the event an insured experiences a medical **complication** related to an elective procedure or treatment. International medical travel requires unique and specialized protection, which standard travel insurance policies usually exclude. Covered enrollees are eligible for reimbursement of certain expenses occurring as the result of a **complication** from an approved **medical procedure** or from travel related **accidents / illnesses**.

**Complication** means **bodily injury** as determined by a separate medical diagnosis and having occurred from an **approved procedure/treatment** which took place whilst an **insured** is outside their country of residence or citizenship. The occurrence of and diagnosis of the **complication** must occur within 180 days or as stated on the **insured's** schedule of benefits whichever is less.

A **complication** that causes **death** cannot be the result of a previously undiagnosed medical condition that first manifests itself during the Insured's period of travel or within 24 hours of return to the Insured's home country. A **complication** cannot result from the Insured's failure to follow all pre and post procedure medical instructions. A **complication** does not include **unfavourable or unsuccessful outcomes** especially as related to aesthetic outcomes or failure to correct the original diagnosis.

## Medical Complication and Travel Benefits for International Medical Travelers & Travel Companions

This is NOT A MAJOR MEDICAL POLICY. Eligible claim expenses would be submitted for approval and reimbursement to the claimant. Please refer to the "How to File a Claim" for details. Benefits are excess of any other valid and collectable coverage. Travel departure and return dates must commence and terminate within 60 days. The occurrence of and diagnosis of the **complication** must occur within 180 days from the originally approved date of the **medical or dental procedure/treatment** or as stated on the **insured's** schedule of benefits whichever is less. **Additional medical or surgical treatment** for a covered **complication** must occur within 270 days from the originally approved date of the **medical or dental procedure/treatment**.
