Strengthens the homeless response system by securing resources, building partnerships, and leveraging influence and expertise

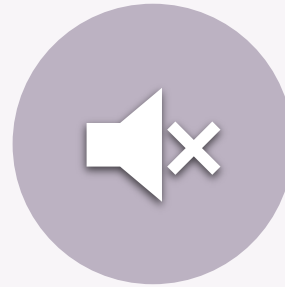
Made up of committed, community-focused leaders dedicated to improving outcomes for those experiencing homelessness

What is the Point-in-Time Count?



The annual Point-in-Time Count (“PIT Count”) is a survey of those experiencing homelessness within our CoC.



Our unsheltered homeless count takes place during the daytime over a three-day period at the end of January. (Note: Dates changed due to NOFO)



The PIT Count covers those living unsheltered (i.e., sleeping in places not meant for human habitation) and those experiencing homelessness but in sheltered conditions (e.g., emergency shelters, transitional housing, and safe havens).

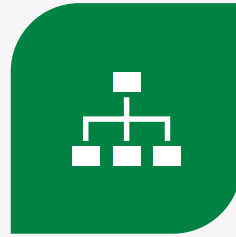
Decision-Making & Accountability

- Led by CFTH Staff with co-leads from the system representatives

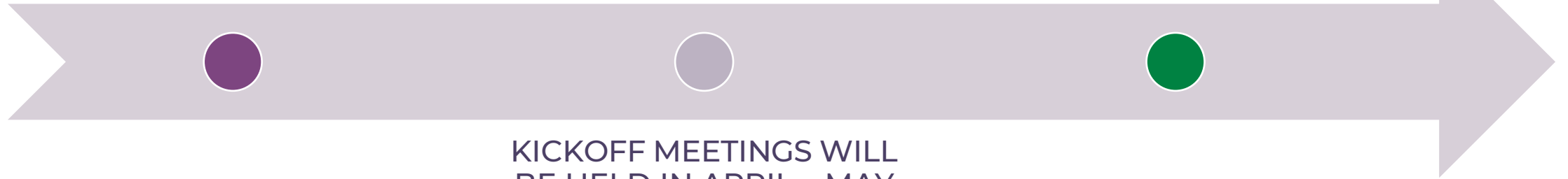
Key Responsibilities:
