Işlāḥī Committee (Reformative Committee)

- It was established by Ḥaḍrat Khalīfatul Masīḥ IV in May 1992 and he described the basic purpose of the Iṣlāḥī Committee in following words: "The "Iṣlāḥī Committee" should comprise of persons who possess deep insight. They should be able to sense evil and realize where its stench is coming from, and, even if an evil is invisible, their acute senses should warn them that danger is lurking and they should remove it before it actually becomes a disease."
- This committee shall consist of following six members at National level:
 - i. National Secretary Tarbiyat (Chairman)
 - ii. National Şadr Majlis Anşārullāh
 - iii. National Şadr Majlis Khuddāmul Ahmadiyya
 - iv. National Şadr Lajna Imāillāh
 - v. Missionary In charge
 - vi. One Member to be appointed at the discretion of Amīr
- This committee shall consist of following six members at Local level:
 - i. Secretary Tarbiyat (Chairman)
 - ii. Za'īm Majlis Ansārullāh
 - iii. Qā'id Majlis Khuddāmul Aḥmadiyya
 - iv. Şadr Lajna Imāillāh
 - v. Local Missionary
 - vi. One Member to be appointed at the discretion of the local President.
- It is advisable that meetings of this committee are held regularly. The agenda of these meetings shall comprise of all matters regarding Tarbiyat.
- The duties and functions of this committee shall be as follows:
 - i. To make assessment of the state of observance of daily prayers and recitation of the Holy Qur'ān by the members of the Jamā'at.
 - ii. To make assessment of the fact that members of the Jamā'at regularly watch and listen to the Friday Sermon delivered by Ḥaḍrat Khalīfatul Masīh and also watch other programmes on MTA.
 - iii. To personally contact the less active members of the Jamā'at and try to motivate them, with love and care, to observe daily prayers.

- iv. To see that members of the Jamā'at follow the decisions of the Majlis Shūrā that are related to the matters of Tarbiyat.
- v. It shall also strive to eradicate un-Islāmic practices, if any, from the members of the Jamā'at.
- vi. To create awareness among the members of the Jamā'at regarding uses and misuse of the internet and mobile devices and persuade them to protect themselves from their harmful effects.
- vii. It shall try to promote peace, harmony and brotherhood amongst members of the Jamā'at.
- viii. It shall try to promote an atmosphere of reconciliation between parties who have any misunderstanding or dispute and try to convince disputing parties to settle their disputes through mutually agreed arbitration.
 - ix. It shall also try to resolve and prevent matrimonial problems and disputes through counselling and mutually agreed arbitration.
