Reporting Abuse Handout: Grades 9-12

What to Do If You or Someone You Know Has Been Sexually Abused?

You are made in the image and likeness of God. Your body is a temple of the Holy Spirit. No one has a right to harm you. If you are currently experiencing abuse or have been abused in the past, it is important for your safety, your well-being, and your spiritual health that you tell a trusted adult who can help you, preferably a parent, teacher, counselor, or someone from your parish staff (pastor, youth minister, or faith formation leader). Normally that person will help you find the assistance you need, but If the person you tell does not help you get the abuse to stop or does not help you cope with the abuse, go to another adult you can trust and tell. Keep telling someone until you get the help you need. You are NOT made to be an object of abuse. You are made to love and be loved in the beautiful way that God has designed. This love will offer you beauty and goodness, NOT the fear, pain and suffering of abuse.

Likewise, it is important to report if someone you know has been or is currently being abused. Remember that we are all made in the image and likeness of God. For the good of every person, it is everyone's responsibility to report abuse, and to report it *now*. Note: If a friend tells you that they have been physically or sexually abused by an adult and asks you to promise not to tell, don't be sworn to secrecy. Don't promise not to tell anyone. Say, "I can't promise to keep a secret if your life is in danger or you are being hurt." Then, seek the help of a trusted adult or professional who can help you report the situation.

In addition to reporting to the State of Iowa, the Archdiocese of Dubuque has a system in place for, and encourages, reporting an incident of child sexual abuse by a priest, deacon, employee, or volunteer of the Archdiocese of Dubuque.

State of Iowa - Mandatory Reporting

Although anyone may (and should) report suspected abuse, the state of lowa has a mandatory reporting law. This means that people in certain professions must report child abuse. Mandatory reporters are:

- According to lowa law, six classes of professionals must report suspected abuse within 24 hours from the time
 they notice the suspected abuse. Those professions are: health, mental health, education, law enforcement, child
 care, and social work. These people are required by lowa law to complete a training course in mandatory
 reporting of abuse.
