- Update on Contract Negotiations
  - Tom Clark – We have two other contracts that are coming up. One is the security here in the development and the other is for the management of our pool. We had some interviews today with some companies about security. Hopefully we will make a decision on that by the end of this week. The pool sub committee is going to be meeting with possible new vendors, and a decision will hopefully follow. We are actively trying to make some improvements here.

At that time, we did a second walk through and review of our possible potential 2026 budget, We are still trying to work through all the numbers. **IX. Old Business**

Update on the Restaurant

- Tom Clark – As you all know, a few weeks back, a letter came from Matt Federricci with a formal notice of termination to the term of agreement. I've had many conversations with Mr. Federricci since I received this letter to try to encourage him to stay and try to work with him to change his business model so that he could be successful so he could make a profit and we could continue to use his restaurant. Unfortunately, Matt had a philosophy on how he wanted to operate the restaurant and he was sticking to that model that he came in here with. So, we were unable to make any changes that would be satisfactory. His biggest complaint to us was that there is approximately 2,500 people here in our community and all he sees is 400 people. You can't support a restaurant with 400 people. We as a community kind of let the restaurant down because there wasn't enough support to keep him profitable to make him stay here. Matt has been great. Nothing but praise for Matt. He has to make a profit so he decided he wanted to leave. This past Saturday, he had his last dinner. In conversations with him, I allowed him to continue to stay here until January because he's already booked a lot of parties and since the Board is unable to do anything with that space at this time, it only made sense to allow him to operate that part of his business here. What is going to happen come January? I had a conversation, just minutes before walking up here. I was introduced to a family member of Mr. Federricci, who has approached me and we will have to have further conversation. But he is interested in trying to continue the restaurant and we will have some conversations about that. He is interested in having a food credit applied in order to make the restaurant sustainable. That is definitely going to require a vote by the community. Since it is an assessment fee, we are required to put the vote out to the Homeowners. We are anxious to talk to the family member of Mr. Federricci.
