VII. New Business

- Open House Policy
 - Tom Clark We put together an Open House Policy. This is another tool to make the selling process easy for everyone.
- Policy for Paid Classes at the Towne Center Facilities
 - We have classes that are free at no charge. That will stay as it is. There are companies coming in who are charging for profit. They are putting a drain on the resources we have here. They are expensive. We are extending our facilities, we are paying the rent, we are paying the electricity and heating bills. In the indoor pool, which is very expensive and we have to have lifeguards in place which costs us at least \$30 an hour if not more. At the end of the season, that is a lot of money that adds up. So we are going to ask these full profit companies to begin paying us a fee for the right to be able to come in and do these services for people.
- Clubhouse Fire Doors Proposal from 5th Ave System Integration
 - Tom Clark There was a complaint that was filed from someone in the community to the police and fire department. They had to come down and we had to close the doors because they are in violarfion of a code. We need the magnetic doors which will release for the fire supression system. It is a very expensive proposition and is going to take some time.
- Installing Concrete Parking Stops and Bollards in the Nurse's Parking Area Johnson Baran Proposal
 - Tom Clark A number of weeks ago, there was an accident in the section of the building by the nurse's office. A resident lost control of the car and took out the light and flag pole. These bollards will stop this from cauing a tragedy.
- Irrigation Start Up Repairs Irrigation Specialties Proposal
 - Matt Lubas Every year when they guys come around, they fire up the system and find problems because it is an older system and we have thousands of sprinkler heads in the community over at Whittingham and around the Club House and everything else. We asked them for a very detailed list this year with locations which they provided to us. We cannot run that system until we fix everything. If the Boaed approves it next week, we will get it in the works

There are many expenses that have not been invoiced, there are scheduled projects to be completed in the next few months.
