	Payment is due when we e-file your returns. We will debit the bank account we use on your tax return for our fees. We will e-file your tax return with your written or verbal communication.
	If a tax agency (Federal or State) sends a notice for additional taxes due to a missing document you did not provide, the additional taxes and interest / penalties will be your liability. If the error is the fault of Sanskar Tax Advisors, Inc., we will only be liable for any interest and penalties incurred, not the additional tax liability.
