

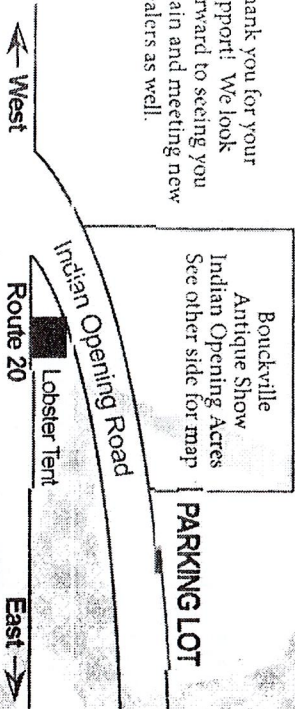

2. Please be prompt with your payments; deadline is May 1st for the August show & April 1st for June. Spaces will no longer be held after these dates.
3. Please give us a courtesy call ASAP if you know you will not be participating in our shows.
4. We are centrally located in the village of Bouckville.
5. Temporary toilet facilities, hand-washing stations, and ATM are available.
6. New York State requires vendors to have a NYS Tax ID Number.

7. Weekly parking pass will be available to our dealers. Please check in upon arrival if you will be using our parking field. Truck, Car, or Trailer-\$15/ea • Box Trucks- \$25/ea

CONTRACT RESERVATION FORM IS BELOW. PLEASE FILL IN, CUT OUT & RETURN WITH PAYMENT

DEALER AGREES TO ABIDE BY THE TERMS LISTED BELOW:

1. Dealer may display and sell antiques, collectibles, and related appropriate items. Distasteful or inappropriate merchandise is prohibited.
2. Dealer is solely responsible for any damages caused by themselves, their employees, assistants, or representatives.
3. Dealer agrees to release and hold harmless the show promoters and owners of the show grounds (Merkle's Antiques and Collectibles, LLC, and Coby and Shawn Merkle) from any loss, injury, or liability occurring during the duration of the show.
4. Dealer must supply their own tables, chairs, tents, and all necessary equipment unless otherwise arranged in advance with the show field owner.
5. Standard dealer spaces are approximately 20' x 20'. Larger or irregularly shaped spaces may be assigned when adjacent spaces are rented or when site conditions require such adjustments.
6. Dealer may park within their rented booth space, provided they do not exceed their marked boundaries. Additional dealer parking is available in the designated parking lot.
7. Dealers agree to be considerate of other dealers and buyers if you pack up prior to the end of the show.
8. Dealers cannot sublet spaces without show field owner permission.
9. All dealer tents, including stakes, poles, ropes, and merchandise, must remain entirely within the assigned space. No exceptions will be made.
10. Dealer may begin setup no earlier than the Friday before the show between 7:00 AM and 6:00 PM.
11. Dealer must comply with all applicable local, Madison County, and New York State health, safety, resale, and regulatory requirements.
12. Full payment for August show space must be received by May 1 of that show year in order to secure the reservation.
13. Dealer must remove all merchandise, equipment, and personal property no later than the Monday immediately following the conclusion of the show. Any items remaining beyond that time will incur a charge of \$25 per additional day.
14. Dealer is required to carry valid vendor insurance and must possess an active New York State Tax ID.
