SERVICES

Basic Professional Services of Funeral Director and Staff \$ 1650.00

This is the basic charge to each family we serve for our professional expertise in assisting them. It includes but is not limited to, a proportionate share of the taxes, licenses, utilities, and business expenses necessary to serve the public professionally. Also included in this charge is the consultation with the family, clerical and administrative services, preparation for filing necessary permits, consultation with the clergy, cemetery, crematory or common carrier, and funeral planning. There will be an additional charge for the direction and supervision of each service requested or required. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING \$ 490.00

Embalming is a chemical process that provides temporary body preservation and eliminates specific health hazards. A person licensed by this state must complete this procedure. Except in certain exceptional cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want to embalm, you usually have the right to choose an arrangement that does not require paying for it, such as direct cremation or immediate burial.
