CLUB REWARDS PROGRAM



Purpose and application

The NRL NT Club Rewards Program is designed to provide additional support and a financial reward for NRL NT affiliated clubs and associations for continued good corporate governance and support for Rugby League promotion and administration.

The rewards program is conducted in conjunction with other programs offered by the NRL NT including:

- NRL NT Expense Reimbursement Program
- NRL NT Marketing and Promotion Reimbursement Program

To be eligible, Clubs and Associations must be compliant to all relevant to laws, policies and guidelines of a number of governing entities including (but not limited to):

- The National Rugby League and the NRL Northern Territory.
- Various levels of government and their respective departments; Federal, Northern Territory and Local Councils.
- Their own constitution and members.

The NRL NT has also provided an NRL NT Club Committee Handbook, a practical tool to assist affiliated clubs and associations (especially those individuals joining a committee for the first time) in obtaining a greater understanding of their practical responsibilities and obligations when operating a club.

Key dates

NRL NT affiliated clubs and affiliations are able to apply from 1st April each year, all applications must be received by 31st August each year.

How can I apply?

Each affiliated NRL NT club and association is to complete the attached assessment and submit this to the NRL NT General Manager (or nominee). The NRL NT will review your assessment and confirm the amount payable to your club. When the amount is confirmed the club or association is required to then provide a tax invoice to the "ARLC NT Limited" detailing the clubs contact details, ABN, banking details and noting "Club Rewards Program.

CLUB REWARDS PROGRAM



Clubs are to complete the below Club Rewards assessment and provide this the NRL NT General Manager (or nominee). Clubs are to insert the assessment date or the date of the completion of the respective item. The club then assigns the relative point score into the Club Score column. A club then tally's the total Club Score. This amount is then multiplied by 10 to provide the amount to be paid to the club as the Club Reward.
