



How to Get Your Real Estate License in Nebraska

STEPS to Getting Your Real Estate License in Nebraska

STEP #1: Contact the Nebraska Real Estate Commission (NREC)

Contact the Nebraska Real Estate Commission to order a New Agent Packet. Call 402.471.2004 or Click <https://nrec.nebraska.gov/pdf/forms/packetrequest.pdf>

When you receive your packet... bring it to your first class or call (402) 676-0101. You do NOT need this Packet before registering for classes.

STEP #2: Meet the NREC Educational Requirements

Salesperson License Applicants are required to complete all three (3) 96-hours of Pre-License courses, plus the mandatory 6-hour ethics course.

Broker License Applicants are required to have two (2) years' experience and complete 120-hours of Pre-License Courses, including the mandatory 6-hour ethics course.

STEP #3: Background Check

You must register and complete a **Criminal Background Check**. Go to the Nebraska State Highway Patrol website and make an appointment at a location near you. Let them know this is for the Nebraska Real Estate Commission. **No previous background checks (Employment, CCW, etc.) can be used for your real estate application.**

- This will be a Fingerprint-based background check.
- In order to complete your real estate license application, you will be required to provide a written statement covering all legal actions or charges against you, no matter how long ago or whether dismissed or not, and any convictions for misdemeanors or felonies, including pending charges for any misdemeanors or felonies. Please note that even if any charges have been dismissed or a conviction has been expunged from your records, you must still disclose this information on your real estate license application.
- The Nebraska Real Estate Commission (NREC) may require a meeting with any applicant to review and discuss the applicant's background check before approving the application.
